

Upper age limit for Government Servants up to five years is relaxable in accordance with instructions or orders issued by the Central Government. 5. The crucial date for determining the age limit shall be closing date for receipt of applications. 6. The applications may be shortlisted according to the criteria as may be prescribed for the purpose. 7. The Candidates in service may send advance application on the condition that the requisite "NOC" will be submitted at the time of the interview. 8. 
