
The National Green Tribunal in association with United Nations Environment Programme (UNEP), the Asian Development Bank, the Ministry of Environment, Forest and Climate Change and the Ministry of Water Resources, River Development & Ganga Rejuvenation will be holding World Environment Conference at Mavlankar Auditorium & Manekshaw Center, New Delhi on 3rd - 4th November, 2017.
