Item 4 – bcd – Adv. for Resp. 2 & 4

Item 7 – abc – Adv for SPCB

Item 1 – bcd – DM for State of xyz

After joining, ensure that –

VIDEO is always 'OFF'

AND

MIC is always 'MUTE'

1. Video should be switched ON only by the parties to a case immediately when the concerned Item No. is called for hearing.
2. Mic should be UNMUTED only by the party speaking.
3. Generally attendance will be marked only when the video is visible.
4. Switching on the Video or UNMUTING the Mic otherwise will disturb the hearing of ongoing matters.
5. Parties to join the VC room at least ten minutes before the Hon'ble Bench Commences the session of the court. It shall be the responsibility of the parties to ensure that their devices have requisite compatibility and up-gradation to
