Dear Sir/Madam,

I am writing to bring to your attention the ongoing illegal crusher operations and mining activities in the RUPA area of West Kameng, Arunachal Pradesh. Despite my previous communications on this matter, no action has been taken by the administration.

I request the National Green Tribunal (NGT) to take suo moto cognizance of this issue and involve the relevant authorities as it represents a severe breach of duty and responsibility.

1. These crusher and mining activities have been operating for several years without the necessary licenses and tax payments.
2. The crusher is located adjacent to the main road, causing significant noise and air pollution, which disturbs the mental peace of local residents.
3. The mining in the GACCHAM area of Rupa, West Kameng, Arunachal Pradesh, exemplifies the collusion between the administration and the illegal mining mafia.
4. Rapid deforestation is occurring due to these mining activities, with the adverse effects likely to become evident during the upcoming monsoon season.

I have attached the exact location of the illegal crusher to facilitate onsite verification.

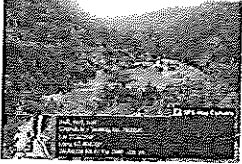

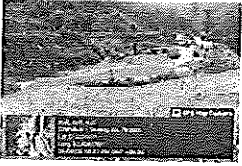
