2. We know Nabadwip Co-operative Bricks & Pottery Society Limited is a Defaulter Society as per The West Bengal Societies Registration Act. & Rules
3. No any Office or signboard of Nabadwip Co-operative Bricks & Pottery Society Limited. It's Our root concept, this society only a papers society. Because as are resident these not visible by us.
4. For your kind information for justice the Nabadwip Co-operative Bricks & Pottery Society Limited occupied 2.04- and 1.35-acre land respected Plot No. 790 and 789 as per JL No. 003 under Nabadwip Police Station.
5. 1.35-acre land under Plot No. 789 is average fall land (GARLAYAK PATIT). This land now a pond and it retain water six months and more.
6. This reservoir is Wandering field of Frog, rare verity of turtle and almost extinct fish and snake.
7. Illegal pond Filling and unauthorized Construction- Threat towards Environment. For aught we know The Indian Government has taken initiatives for conservation of both forest and water resources.
