1. The present Execution Application has been filed towards execution of Hon'ble National Green Tribunal, Eastern Bench, Kolkata order dated 22.2.2023.

2. That during last hearing dated 19.9.2024 Hon'ble Tribunal was pleased to pass the order of which the relevant portion is extracted below:

*"7. The State Respondents, Government of Bihar are directed to file affidavit within one month showing clearly that the road shown in the photographs has been cleared and all the slush and slime has been removed there from".*

That, it is humbly submitted that State Respondents have miserably failed to implement the aforesaid order of Hon'ble Tribunal and there is no perceptible improvement of the condition of various roads within Prabhunath Nagar housing colony. 4. That, from the Annexed photographs, it is evident that no worthwhile efforts have been initiated by State Respondents and the condition of water logging resulting in formation of slush and slime is still persisting.

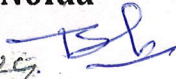
#### **PRAYER**
