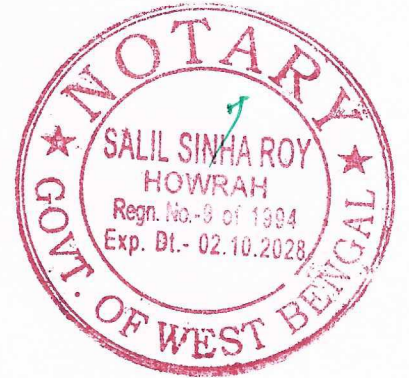

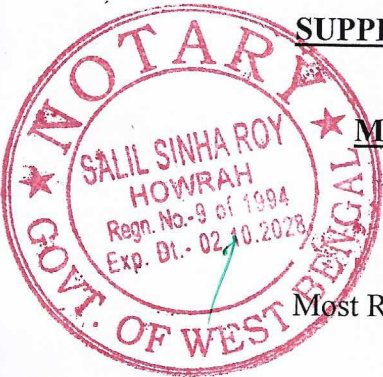

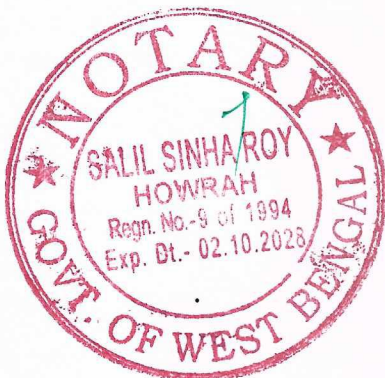
- 1) That I am the Applicant of the Original Application No 85 of 2024 which has been filed before the Hon'ble Tribunal in the matter of solid waste menace in the HMC area where solid wastes are dumped here and there, the photographs of which have been submitted before the court along with the OA as well as through the Supplementary Affidavit, dated 30th September 2024.

- 2) That there is traditional mishandling of the solid wastes in the city, which has earned the stigma for Howrah being the DIRTIST CITY OF THE COUNTRY. As a resident of Howrah the applicant faces the same experience every day. On 21st November 2024 the leading Bengali daily, Anandabazar Patrika has published a photograph in Calcutta page of the newspaper depicting solid wastes dumped on the road side near Howrah Bridge, Howrah, the photocopy of which is enclosed as Annexure S/A/1
- 3) That the applicant has been able to collect few photographs on this score, reportedly taken on 20th November 2024. These photographs will clearly show the dismal position of wastes mismanagement in Howrah. The said photographs are enclosed as Annexure S/A/2.
- 4) That the reported position in the newspaper has not been contradicted by the authority and the applicant, while commuting through Howrah Bridge has also witnessed the position but due to constant flow of traffic on the busiest thoroughfare of the city could not take the photograph of the same.
- 5) That in view the position as stated in the earlier paragraphs, the Hon'ble Tribunal may passed the necessary directions as deem fit and appropriate.

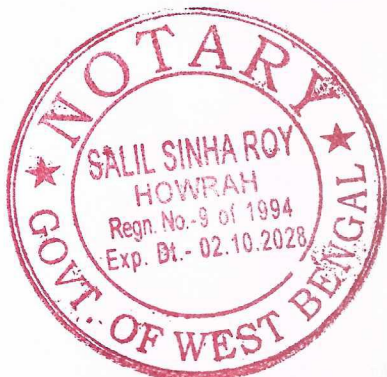
