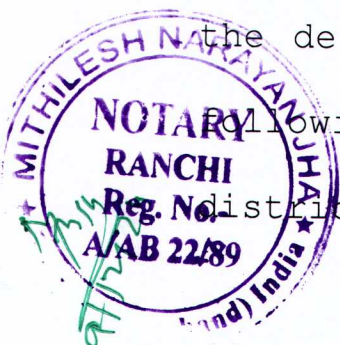

That, it is humbly stated and submitted that an Affidavit was earlier filed before this Hon'ble Tribunal on 11.03.2024 wherein a detailed information as contained in the Report of the Regional Officer-cum-Laboratory, Dumka (vide letter no.414 dated 02/03/2024) was brought on board. The said report inter alia provided a brief account of

- (c) Total number of Stone Mines **with** Crusher Units.

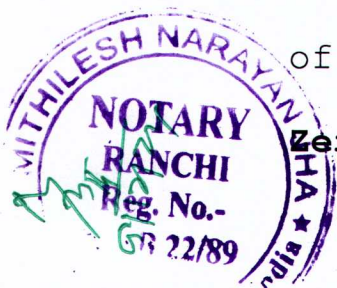
5. That it is humbly stated and submitted that the Hon'ble Tribunal during the hearing of the instant matter on 13.05.2024, was pleased to direct the Jharkhand state Pollution Control Board to file fresh Affidavit giving current status of matter in question. Further, vide Order dated 24/07/2024, the Hon'ble Tribunal directed that JSPCB while filing its affidavit shall also take into consideration the affidavit filed by the Enforcement Directorate.

6. That it is humbly stated and submitted that with regard to the current status of realization of the computed/revised Environmental Compensation against the erring Units in Sahebganj district, the Units have been categorized into the following List:-

(A) List of 07 (Seven) Units who deposited the total original amount of Environmental Compensation.

(B) List of 12 (Twelve) Units whose revised amount of Environmental Compensation was computed as

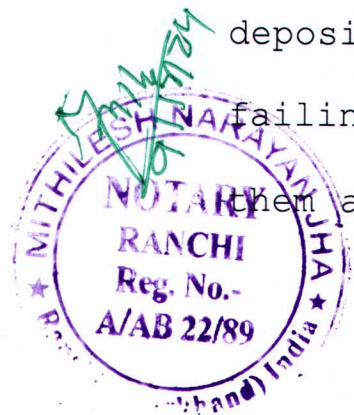

That, it is humbly stated and submitted that a last indulgence was given to the violating units via public Notice vide Notice No. B-2528 dated 03/12/2024, (published in local daily newspapers on 05/12/2024) wherein the 40 Units as enlisted under **category-D** above who have deposited only partial amount of imposed Environmental Compensation (EC) have been provided one(1) months timeline for depositing the rest outstanding amount of EC, failing which **closure order** shall be issued against them and appropriate legal action shall be initiated



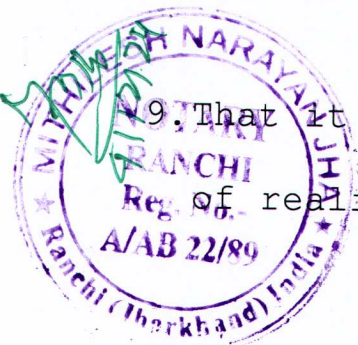
upon them for recovery of the imposed environmental compensation.

8. That it is further humbly stated and submitted that another public Notice vide Notice No. B-2527 dated 03/12/2024, (published in local daily newspapers on 06/12/2024), the 83 Units as enlisted under **category-E** above who have not at all deposited any amount of imposed Environmental Compensation (EC) have been provided seven (7) days timeline as a last indulgence from the date of issuance of the said Notice for depositing the imposed amount of EC, failing which **closure order** shall be issued against them and appropriate action shall be initiated upon them for recovery of the impact Environmental Compensation.

9. That it is stated and submitted that current status of realization of the computed/revised Environmental

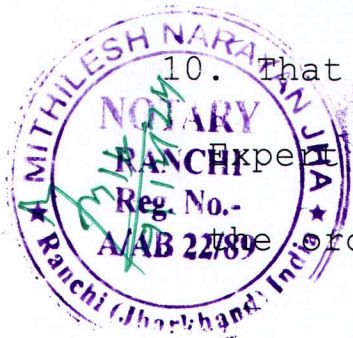

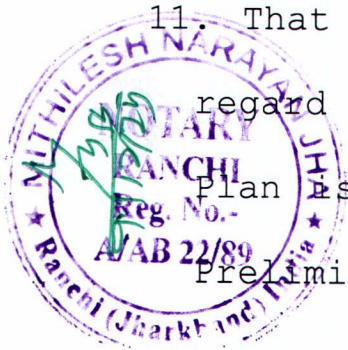
10. That it is humbly stated and submitted that the Expert Committee Report constituted in compliance to the order dated 22.12.2021 passed by Hon'ble NGT in



O.A. No. 23/2017 (EZ) with O.A. No 776/2018 (PB) with OA No. 373/2019 (PB); Syed Arshad Nasar Vs Union of India with Ramchandra Chaurasia Vs State of Jharkhand with Pradeep Kumar Singh Vs State of Jharkhand had reported about some illegal mining and crushing activities and suggested different corrective measures like Assessment of Carrying Capacity, Assessment for Environmental Compensation, measures to be taken for crushers/mines, Measures to be taken for management of railway siding etc. All the suggested measures are being ensured by JSPCB. Apart from the same, section 6.4 of Environmental Compensation & Damage Assessment and point no. XXIV of the section suggests as follows:-

"A Comprehensive Environment Management plan may be prepared, for the areas where the stone mines and crushers are located, through the expert institutes like Indian Institute of Technology - India School of Mines (IIT-ISM), Dhanbad or any other reputed agency."

11. That it is further stated and submitted in this regard that a Comprehensive Environment Management Plan is being prepared by BIT Sindri, Dhanbad. The Preliminary Report has already been submitted by the



institute and the same has also been placed before the Hon'ble Tribunal vide Action Taken Report (ATR) dated 10/08/2023 (Page 2156/2157 of the book) and the final report is expected to be finalized by March' 2025

12. That this Affidavit is filed bonafide and in the interest of justice.

13. That the statement made in forgoing paragraphs are true to my knowledge in annexure are true copy of its original.
