I, Ankur Sharma, the Applicant aged about 28 years by occupation Advocate residing at 13/3, Dr. P. K. Banerjee Road, Howrah - 711101 do hereby solemnly affirm and state as under :

1. I am the Applicant in the abovementioned Original Application. I downloaded a copy of the Affidavit filed on behalf of Urban Development & Municipal Affairs Department, Government of West Bengal affirmed on 24.07.2024. I have gone through the




contents and purports of the Affidavit (hereinafter for the sake of brevity referred to as the 'said Affidavit'), and I am making the present Affidavit in Rejoinder thereto.

2. As regard paragraph no. 1, 2 & 3 of the said Affidavit I say that the same does not require any specific reply.
3. As regard paragraph no. 4 & 5 of the said Affidavit I say that although a significant portion of the garbage located within the premises of Lichubagan Police Quarters has been removed yet, a considerable amount of garbage is still lying thereat particularly near/behind Police Barracks. Trunks/branches of trees which were felled without any permission are also lying within the Police Quarters.

The night soil pits and chambers of the said Police Quarters are damaged, resulting in the overflow of night soil into the drains. Staunch smell of night soil is released therefrom.

Some photographs are annexed herewith and collectively marked by the letter and figure 'A-1'.

4. That two issues as stated above needs to be addressed viz. (i) removal of remaining accumulated garbage and (ii) complete repair of all night soil pits/chambers.
5. As regard paragraph no. 6 of the said Affidavit I say that the same does not require any specific reply.



In view of what is stated herein above, I humbly pray before this Hon'ble Tribunal to pass necessary orders.
