Respected Sir,

I would like to bring to your kind attention that in Sirkabad Moza, JL No. 68 under Arsha Block, an area measuring 85 acres was notified as forest land vide Notification No. 6611-For dated 13.11.1966, corresponding to C.S. Plot No. 3752.

Subsequently, R.S. Plot No. 4709 was carved out of the above-mentioned C.S. Plot No. 3752, measuring 57.89 acres. However, the Record of Rights (ROR) for R.S. Plot No. 4709 reflects only 3.80 acres as recorded in the name of a private individual. Notably, the classification of the land remains as "Jungle" in the ROR, indicating its forest nature.

It is unfortunate to observe that non-forest activities, specifically the operation of a brick kiln, are being carried out on this land in violation of forest land use norms. Such activity is not only in contravention of the provisions of the Forest (Conservation) Act, 1980 but also detrimental to the ecological balance of the region.

I request your urgent intervention to investigate the matter and take appropriate steps to safeguard the forest land from further encroachment and misuse.
