


INTERLOCUTORY APPLICATION

(For urgent interim stay of operations)

(For immediate temporary stay of illegal brick-kilns operations)


MOST RESPECTFULLY SHOWETH:

1. That the Applicant has filed Original Application No. 168/2025/EZ titled "*Bittu Biswakarma vs CPCB & Ors.*" before this Hon'ble Tribunal, regarding the illegal and polluting operation of brick kilns in Barabani Block, Paschim Bardhaman District, West Bengal. The present Interlocutory Application is being filed for urgent **interim stay** as Respondent Nos. 5-7 are operating illegally and causing large-scale air pollution and environmental degradation.
2. That the said brick kilns — **GMB Brickfields, GRC Brickfields and Raja Brickfields** — are functioning **without** valid "Consent to Establish (CTE)" or "Consent to Operate (CTO)" under the Air (Prevention and Control of Pollution) Act, 1981 and the Environment (Protection) Act, 1986. Official data from the OCMMS (Online Consent Management & Monitoring System) portal, annexed as **Annexure A**, clearly shows rejection or non-availability of valid consents for these units.
3. That despite statutory prohibitions and pendency of the above OA, these kilns have resumed operations since early October 2025, emitting toxic pollutants and severely deteriorating air quality in the Barabani-Asansol region.
4. That the Applicant has gathered contemporaneous documentary evidence, including screenshots from the OCMMS portal and a consolidated list of applications reflecting their current status as *approved, pending, or rejected* (**Annexures- A- Colly**), thereby showing continuing violations and resultant environmental harm due to persistent non-compliance and lack of effective regulatory action
5. That the ongoing operations are causing grave and irreparable injury to public health and environment, amounting to violation of the citizens' **fundamental right** to clean air under **Article 21** of the Constitution of India.
6. That unless this Hon'ble Tribunal is pleased to grant an **immediate interim stay** on such **illegal operations** pending disposal of OA No. 168/2025/EZ, the object of the Original Application will be **frustrated and irreversible environmental damage will continue**.

1. Because the **impugned** brick kilns are operating **without** valid “Consent to Establish (CTE)” and “Consent to Operate (CTO)” under the **Air (Prevention and Control of Pollution) Act, 1981** and the **Water (Prevention and Control of Pollution) Act, 1974**, resulting in immediate and continuing **air, soil, and groundwater pollution**. **Urgent interim stay is required to prevent further and irreversible environmental damage**.
2. Because the **continued illegal operation** of such brick kilns violates the citizens’ fundamental rights guaranteed under **Article 21 of the Constitution of India**, namely the **right to life, clean air, safe soil, and uncontaminated water**. The **balance of convenience** and **irreparable injury** clearly lie in favour of granting an interim stay to safeguard public health and the environment.
3. Because the Applicant has submitted credible evidence (Annexures A & B) derived from the official OCMMS portal and recent field observations demonstrating that the Respondents’ brick kilns have resumed operations and that **Air Quality Index (AQI) levels have sharply increased**, confirming the immediate threat to the surrounding environment.
4. Because unless this Hon’ble Tribunal grants an interim stay at this stage, the purpose of the pending Original Application will be defeated, and irreversible degradation of air quality, topsoil fertility, and groundwater resources will continue unabated in the affected areas.



INTERIM RELIEF SOUGHT:-

Pending final disposal of **Original Application No. 168/2025/EZ**, the Applicant most respectfully prays that this Hon’ble Tribunal may be pleased to pass the following **interim orders forthwith**:

1. Direct **immediate temporary STAY** and **PROHIBITION** of operation (production/firing) of the brick kilns identified in the Original Application — including **GMB Brickfields, GRC Brickfields, Raja Brickfields**, and any other brick kilns operating within **Barabani Block** or adjoining areas found without valid **CTE/CTO** — until further orders of this Hon’ble Tribunal.
2. Direct the **Respondent No. 2 (District Magistrate, Paschim Bardhaman)** and **Respondent No. 3 (West Bengal Pollution Control Board)** to carry out

an on-site inspection within 48 hours, and to submit a compliance report within one week indicating:

- Whether the said kilns are operating with valid statutory Consents (CTE/CTO); and
- Whether adequate measures exist to prevent **air, soil, and groundwater pollution**.

3. Pass such ad-interim protection orders as may be necessary to prevent imminent environmental damage and public health risk arising from the ongoing illegal and polluting activities, during the pendency of the matter.

PAYER

In view of the facts and grounds stated above, the Applicant respectfully prays that this Hon'ble Tribunal may be pleased to:

1. Pass an ad-interim order granting immediate temporary STAY and PROHIBITION of operation of all illegal and non-compliant brick kilns in Barabani Block, including Respondent Nos. 5-7 (GMB Brickfields, GRC Brickfields, and Raja Brickfields) and any other brick kilns found operating without valid CTE/CTO, pending final disposal of OA No. 168/2025/EZ; and
2. Direct Respondent Nos. 2 and 3 to conduct a prompt on-site inspection and file a compliance report within one week, clearly indicating whether the said kilns are operating with valid statutory consents and adequate safeguards to prevent **air, soil, and groundwater pollution**; and

Pass such further or other orders as this Hon'ble Tribunal may deem fit and proper **in the interest of environmental protection, public health, and justice.**
