other revenue official, IDCO authorities and officials of M/s RAMCO Cement Limited was conducted on 30.01.2026 to ascertain the encroachment of Forest Land by M/s RAMCO Cement Limited upon the Plot No. 88, Mouza Cahakradharpur under Dharmasala Tahasil as alleged by the petitioner. Relevant land records, forest maps and site conditions were examined by the team. During the inspection it is found that Plot No. 88, Kissam-Gramya Jungle of Mouza- Chakradharpur under Dharmasala Tahasil falling outside the boundary wall of M/s RAMCO Cement Limited. The Forest Range Officer, Dalijora Range, Byree submitted the joint verification report to the Divisional Forest Officer, Cuttack Forest Division, Cuttack vide his Memo No. 433 dated 12.02.2026.

comprising of the Senior officers like Sub-Collector, Jajpur, Tahasildar, Dharmasala and the Assistant Conservator of Forest, Cuttack have made a fresh inquiry on 20.02.2016 in to the allegation levelled by the petitioner in the said original application particularly on Para 3 & 5. The committee reported that Plot No. 88, Kissam- Gramya Jungle of Mouza- Chakradharpur under Dharmasala Tahasil falling outside the boundary wall of M/s RAMCO Cement Limited.

Further, the existence of the Electric Sub-station was examined with respect to the ROR recorded in favour of OPTCL, Village Map (includes survey reference point) & the cadastral map provided by M/s RAMCO Cement Ltd. upon examination, it reveals that the Land Schedule as reported in the said report having an area of Ac. 1.95 is in possession of OPTCL. The present RoR and ^{field} filed enquiry report suggests that, the land in possession by the power company namely OPTCL is the self-acquired property of the company recorded under Stitiban Status as kissam Gharabari.

As directed, a joint inquiry was conducted on dt.30.01.2026 to carry out involving the concerned Forest Officials, representatives of the Tahasil Office, IDCO authorities and officials of M/s Ramco Cements Limited. Relevant land records, forest maps, and site conditions were examined during the inspection.

Upon verification, the following facts were observed:-

1. The boundary of the project area was physically inspected and verified with reference to available forest records and revenue maps.
2. The status of the land in question was cross-checked with the concerned Tahasil records.
3. The boundary wall of M/s Ramco Cement Ltd. has been verified and the Plot No. 88, Kissam-Gramya Jungle is failing outside the boundary wall of the said company.
