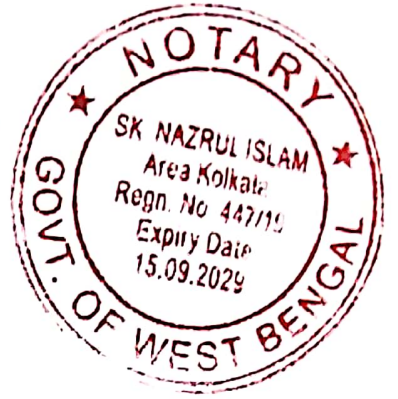

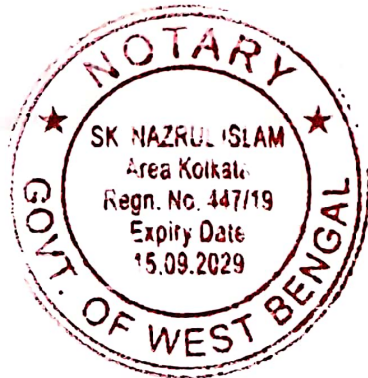

COMPLIANCE REPORT ON BEHALF OF RESPONDENT NO. 2  
(DISTRICT MAGISTRATE, MUZAFFARPUR)

I, Saurav Raj, son of Shri Dilip Kumar Sinha, aged about 36 years, by faith - Hindu, by designation the Senior Deputy Collector, Muzaffarpur, having its address at Collectorate Muzaffarpur, Pin - 842 001, Bihar do hereby solemnly affirm and state on oath as follows:

1. That I am the Senior Deputy Collector, District Legal Section, Muzaffarpur and as such I am conversant with the facts and circumstances of the present case and am duly authorized to swear this Compliance Report on behalf of Respondent No. 2.

2. That this Compliance Report in both the original applications is being filed in compliance with the order dated 09.01.2026 passed by this Hon'ble Tribunal.

3. That vide the said order dated 09.01.2026, this Hon'ble Tribunal was pleased to direct the respondents to take requisite remedial measures to remove geo-bags filled with sand or soil, island-like formations covered with vegetation, and plastic bags lying in the Budhi Gandak riverbed and stream around the pillars of the Athar Ghat bridge within a period of two months.

4. That following the directions of this Hon'ble Tribunal, the executing agency, Bihar Rajya Pul Nirman Nigam Limited (BRPNNL), Muzaffarpur, and the contractor, M/s Ganesha Ram Dokaniya (Respondent No. 5), were instructed to carry out the required cleanup activities.

5. That it has been brought to the notice of the answering respondent by the Senior Project Engineer, BRPNNL, Muzaffarpur, vide Letter No. BRPNNL/MZF/C027/329 dated 30.03.2026, that the contractor has partially complied with the order by removing some of

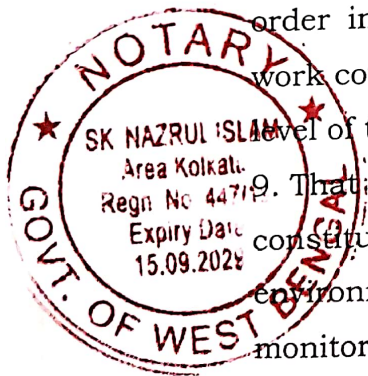
the bags from the river using boats. A true copy of the said letter is annexed herewith and marked as Annexure ~~Reb. B~~

6. That, however, complete removal of the debris and remaining bags could not be executed within the stipulated time frame due to an unexpected rise in the water level of the Budhi Gandak River. Due to the elevated water levels, it has not been feasible to deploy heavy machinery into the river to clear the remaining mid-stream obstructions and island-like formations. The contractor has submitted in writing on 19.03.2026 that the remaining clearance work will be completed with promptness as soon as the water level recedes and becomes suitable for heavy machinery operations.

7. That the District Administration has taken strict note of this partial and incomplete compliance. The Office of the District Magistrate, Muzaffarpur, has issued a strict directive vide Letter No. 550, dated 30.03.2026, to the Senior Project Engineer, BRPNNL, Muzaffarpur. A true copy of the said letter is annexed herewith and marked as Annexure ~~Reb C~~

8. That in the aforementioned letter dated 30.03.2026, the answering respondent has explicitly observed that the Hon'ble Tribunal's order dated 09.01.2026 has not been fully complied with. Consequently, the District Administration has strictly directed BRPNNL to ensure 100% compliance with the Hon'ble Tribunal's order immediately and submit a complete compliance report. The work could not be completed due to sudden unexpected rise of water level of the River.

9. That the answering respondent is committed to fulfilling the constitutional obligations to protect and improve the natural environment. The District Administration will continue to closely monitor the site and shall take all necessary steps to get the executing agencies to complete the remedial measures at the earliest



possible opportunity once the river's water level permits safe operational access.

10. That, in view of the genuine physical constraints arising from the rising river water, it is most respectfully prayed that this Hon'ble Tribunal may graciously be pleased to take on record the partial compliance already effected and the actions initiated by the District Magistrate, and further be pleased to grant a reasonable extension of time to enable the concerned agencies to safely achieve complete removal of the obstructions, as previously directed, once the water level recedes and conditions become suitable for heavy machinery operations.

11. That the statements made in paragraphs 1 to 9 of the foregoing application are true to my knowledge and are matters of record and information derived from record, which are believed to be true and correct and the rest thereof including the prayer portion are my respectful submissions before this Learned Court.

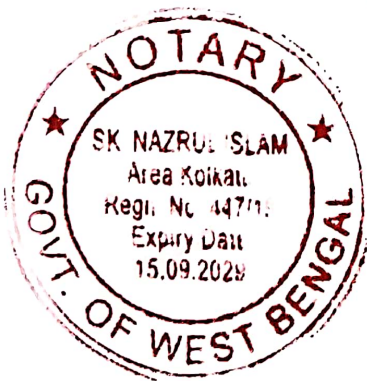

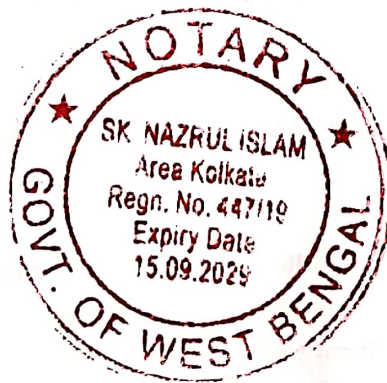


**Facts Finding about the Athar Ghat, Muzaffarpur, Bihar on the Bank of River Budhi Gandak:**


1. The Committee had fixed the date of inspection on 02.06.2025.
2. The Committee had visited the site in question and as per the direction of Hon'ble NGT examined the factual status of the river in light of the allegation made in the O.A. 56/2025/EZ.
3. The river named as Budhi Gandak. The Budhi Gandak is a perennial river that flows through the northern part of Bihar. It is a tributary of the Ganga River and originates from the Someshwar Hills Near Bisambharpur in West Champaran district, near the Indo-Nepal border. Its approximate length is 320 kilometers. It flows through the West Champaran, East Champaran, Muzaffarpur, Samastipur, Begusarai and Khagaria districts of Bihar. It merges with the Ganga River near Khagaria district.
4. There is a bridge near Athar Ghat, Musahari, Muzaffarpur, Bihar. Its length is approximately 300 meters.
5. Flow of River is from west to east.
6. During the construction of the bridge pillars, the agency built a wall of geo-bags filled with sand or soil around each pillar to prevent water from entering the base. At present an island-like formation has developed on either side of the bridge

around the pillars. Most of these areas are now covered with grasses and wild vegetations, including herbs and shrubs. At some spots, plastic bags were also observed (Photographs attached).

7. Since the river is perennial, water continues to flow through the gaps between the island-like structures.
8. These formations have not altered the course of the river.
9. The flow of water on both sides of the bridge appears to be normal.
