STATUS REPORT AND ACTION TAKEN REPORT FILED BY THE 8TH
RESPONDENT - EXECUTIVE OFFICER OF THE THIRUNEERMALAI
TOWN PANCHAYAT

I, N.Latha, Wife of Mr. K.S.Krishnamoorthy, aged 55 years, serving as the Executive Officer i/c, Thiruneermalai Town Panchayat, having address at S4, Tajeswer Homes, Dilli babu Nagar, 2nd Street, Pallikaranai, Chennai-100, do hereby solemnly affirm and sincerely state as follows:-

1. I humbly submit that this Hon'ble Tribunal has taken suo moto cognizance based on the News item in The New Indian Express, Chennai edition Dated 23.01.2021, "Biomedical waste dumped near Chennai's Thiruneermalai Lake not removed even after a week" and in its order dated 05.02.2021 has directed the Joint Committee which was constituted in OA No. 50 of 2019, to visit the area in question and submit its factual and action taken report and also directed the Respondents to file its response as to the allegations made in the paper report.

2. I humbly submit that pursuant to the direction of this Hon'ble Tribunal, this Respondent is filing the status report as follows:-

Thiruneermalai is a Special Grade Town Panchayat in Chengalpattu District with a population of 30,702 as per 2011 Census and the present population is estimated about 40,000. The extent of the Town is 4.80 sq.km and is administratively delimited into 18 wards. There are 10308 House Holds and 254 commercial establishments, 1 urban health centre, 1 Primary Health centre, 1 private hospital and 9 small health clinics situated within the Town. The Town Panchayat owns 39.538 km length of Roads besides 4.00 km of roads belong to State Highways Department. There is 32.860 km length of storm water drains maintained by the Town Panchayat. It is the duty and responsibility of the Town Panchayat for the better maintenance of Sanitation, Solid waste Management, Water Supply, Street lights and other basic services to the people of the Thiruneermalai.

I. SOLID WASTE MANAGEMENT – QUANTITY OF MUNICIPAL SOLID WASTE GENERATED

The Town Panchayat generates 9 Metric Tonnes of Solid waste every day as mentioned below:

Bio – Degradable Waste - 5 MT
Non Bio degradable waste - 4 MT

The Non bio degradable waste daily generated consists of the following categories of wastes.

1	Plastics	1.700 MT
2	Glass, Rubber and Tyres etc	0.450 MT

Apart from the above, C & D waste about 0.3 M.T is collected separately and 0.3 M.T silt from Road sweeping and storm water drain cleaning are collected and stored separately at Resource Recovery Park.

II. RESOURCE RECOVERY PARK

The Resource Recovery park located in Town Survey No: 147/1G/2 in an extent of 1.18 acres. The same is established in the land, classified as Government Land, which has been in possession and maintenance of the Town Panchayat for more than 30 years. The Solid waste generated at source of 10308 households and 254 commercial establishments at 216 streets/roads of the Town Panchayat has been collected by Sanitary Workers at the Doorsteps and segregated, processed to the maximum extent at the Resource

Recovery Park. The route chart for primary collection of solid waste from households to RRP is in place for strict monitoring of movement of solid waste.

The primary collection at source by using Tri cycle/Battery Operated Vehicles/Push Cart is immediately transported by the secondary vehicles from strategic points to the Resource Recovery Park mentioned above for final disposal. The entire process is handled by 110 Sanitary Workers of Town Panchayat and 47 vehicles in different configurations, presently fit to run on road. An average of 5 metric Tons of Bio Degradable are processed through windrow method and 4 Metric Tons of Non Bio Degradable solid wastes are collected in a day from all the above 216 Streets/Roads. Bio degradable wastes are processed at the Resource Recovery Park (RRP) and sold as Bio Compost and Vermi Compost to the farmers and other urban families for roof top garden. An average 2.0 Tones of Plastic wastes are segregated at RRP and supplied to the privates. Thermocol and other re-processable non bio degradable items are handed over to scrap collectors.

III. PRESENT SYSTEM OF WASTE PROCESSING & DISPOSAL.

The Town Panchayat has set target of 100% achievement in Door to Door Collection before 30/9/2021. Similarly the target for segregation at source is set for 100% achievement before 30/9/2021 by engaging required manpower.

IV. LEGACY WASTE

The Town Panchayat has been maintaining 216 No. of streets/roads and 32.860 running kms of storm water drain. As presented above, an average 9.000 Mt of solid waste generated in a day is processed through Windrows method. The solid waste collected for more than two decades were deposited at the western side of

Adayar river bank in the en route of Thirumudivakkam-Thiruneermalai main road. The National Green Tribunal directed the Town Panchayats to reclaim the land and develop the processing facilities as stipulated under the Solid Waste Management Rules 2016. The estimated quantity of historical waste at the old site is about 8100 cum.

The Government originally accorded administrative sanction to remove the legacy waste dumped on the Adayar river bank at an estimate cost of Rs.90.00 lakhs under CRRT Scheme vide GO (Ms) No.72 MAWS Department dated 12.07.2017. Subsequent study conducted by engineering team at Anna university has revised the estimate to Rs.60 Lakhs. The Bio mining of historical waste at the adyar river bund was already started and so far 3750 Cum has been completed out of estimated 8100 cum. The firm assigned for bio mining of historical wastes is advised to complete the rest of process at the earliest. An extent of 70 Cents of land will be reclaimed after completion of the Bio mining process.

V. ACTION TAKEN ON SOLID WASTE MANAGEMENT

The Town Panchayat is peripheral local body and the number of permanent/sanctioned posts is inadequate, considering its development. As of now, the sanctioned post of Sanitary Worker is 22, out of which 3 is vacant. The process of filling vacancies requires considerable time and compliances, in accordance with Rules. As the existing staff in sanction posts are insufficient to meet the requirement of rapid growth in households and population, the services of SHG and NGO were roped in to supply required personnel for solid waste management.

1. Since the State formulated Solid Waste Management Rules 2016 (Management and Handling), the Town Panchayats were authorized to engage self help groups and Non Government Organisations to handle Solid Waste Management Activities as per Na.Ka.No:5030/08/B4 dt 24/6/2008, issued by the Director of Town Panchayats, Chennai.

2. Accordingly, the service of an NGO named "Ramanujam Social Service society" was engaged to supplement the existing sanitation team and to ensure proper implementation of Solid Waste Management activities as per Solid Waste Management Rules 2016.

3. The process of Solid Waste Management from Door to Door collection to final process at RRP has been monitored by the Executive Officer Town Panchayat, as mentioned supra.

4. All solid waste management activities in this Town Panchayat went on well, till the general lockdown declared from 23rd March 2020 on account of Covid 19 pandemic. However, the effective implementation was affected due to COVID19 pandemic and general lock down. Since the entire sanitation team was busy in containment of COVID-19 and the SHG could not provide additional personnel required at the lockdown period, the Town Panchayat had to place some more temporary arrangements on contractual basis, with little orientation to those personnel. Due to the above reasons, the Door to Door collection and waste segregation at source activities were naturally disturbed. Nevertheless, the Door to Door collection and segregation at source are being addressed, restored and improved now. Inspire of consistent efforts of Town Panchayat, the response and cooperation of public still need to be improved, for which awareness is continuously created.

- a. Present Door to Door collection - 75%
- b. Segregation at source - 75%

The Town Panchayat has set target of 100% achievement before 30/9/2021 by engaging required manpower, strengthening system and roll out the action plan

VI. Water bodies within Town Panchayat:

The following 6 major water bodies are situated within Thiruneermalai. Except Periya Eari, all are maintained by the Town Panchayat.

The subject area mentioned in the daily newspaper is the service road situated in the banks of chitteri lake. The area on both the sides belongs to Tambaram and Pammal municipalities. Since lot of vehicles pass by in the above mentioned service road, the passengers throw lot of garbage in this area. In this Town Panchayat around 110 employees are working in solid waste management system. The Route Map for primary collection of solid waste from door steps to end processing yard, has been in place. The movement of solid waste is tracked accordingly. The wastes collected from the households are transported by the secondary vehicle to the Resource Recovery Park for disposal of waste. Non bio degradable waste and recyclable waste are segregated and stored in this place. 34 tonnes of plastic waste collected during the last six months has been handed over to Ms. Bala Trading Co for a syn amount of Rs.3400/- and about 170 Kg thermocol collected in this area are handed over to M/s. Westwin Private Company.

The Town Panchayat involving 110 Sanitary Workers, manage the Solid waste collections at source to the end process at RRP, as detailed above. Since, there are four secondary collection points as transit center to transport the solid waste from primary collection to RRP, there is no necessity for the Town Panchayat to dump its waste at any water bodies and service road.

Curbing the stray incidents of dumping solid waste at road side and water bodies is now strengthened, by proper orientation to the Sanitary Workers. It is also proposed to install CCTV cameras at strategic points in collaboration with local Police for strict surveillance including the service road and Chiteri Lake. Already there is provision for penal action in the by-law for Solid Waste Management and imposing fine published under District Gazette No: 19 dt. 20/7/2017.

VII. BIO MEDICAL WASTE

As per the Solid Waste Management Rules 2016 and Bio Medical Rules 2016, collection and disposal of Bio Medical Waste are the responsibility of State Pollution Control Board. There are 1 urban health centre, 1 Primary Health centre, 1 private hospital and 9 small health clinics within the Thiruneermalai Town Panchayat limits. No Major private Hospitals/Multi Speciality Hospitals are situated in the limits of Thiruneermalai Town Panchayat. The Bio Medical Waste generated from the above Hospitals is collected by the private vendors namely M/s.GJ Multi Clave India Pvt. Ltd., who is authorised by the Tamilnadu Pollution Control Board and thd said agency disposed off the same in facility at Thenmelpakkam Village, Chengalpattu Taluk and District as per Bio Medical Waste Management Rules 2016. Hence the role of Town Panchayat in disposal of Bio Medical waste limited to collection of syringes, used cottons, tablet covers and bottles etc from households and handed over to said agency.

VIII. Hospitals and Health Centers:

As mentioned earlier, there is no major Hospital within the Town Panchayat and only mini hospitals and clinics, as listed below are located:

M/s. GJ Multiclave (India) Pvt Ltd, having address at Old No.20, New No.37, Teachers Colony, Kamaraj Avenue, Adyar, Chennai – 600 020, an accredited agency by Tamil Nadu Pollution Control Board is vested with collection and handling of bio medical waste from the above health centers. The Thiruneermalai Town Panchayat would keep in touch with the above agency to clear bio medical waste in accordance with the rules and address any untoward incidents.

The Town Panchayat is periodically contacting the above urban health centres, Primary Health centre, private hospitals and small health clinics to ensure the Bio Medical Wastes are not disposed off within Town Panchayat and creating health hazards.

A mechanism is devised to report any incident of dumping of bio medical waste contrary to the rules, to the competent authority such as regular surveillance of sanitation team, installation of CCTV, periodical interaction with domiciles/associations, inviting complaints through Watts App, regular awareness through Green Ambassadors.

There are 7 Pharmacies situated within Thiruneermalai Town Panchayat. It is proposed to conduct awareness program within week on safe disposal of medical waste like like expired tablets, syringe and used cotton and statutory compliances .

IX. Nevertheless, the potential threats and challenge to the Thiruneermalai Town Panchayat in maintaining its sanitation and solid waste management, is throwing or dumping of solid wastes on

roadside at odd hours by unknown elements, unnoticeable by authorities, due to the factors like, the intersection of Thiruneermalai by the Outer Ring Road from Tambaram to Maduravayil, nearby Tanneries at Pammal/ Pallavaram, the small and medium units catering the industrial needs of factories of Thirumudivakkam Industrial Estate and vast tracts of vacant lands lying undeveloped. The Town Panchayat has taken into account of these factors and work toward addressing the issues effectively.

X. Action Plan for Implementation Solid Waste Management Rules 2016

- a) The Town Panchayat has been taking steps along with the local Police Station, to install cameras on main points to monitor the violations and untoward incidents.
- b) The members of Sanitation team of Town Panchayat have been oriented to intensify their vigil on water bodies, roads and streets to curb those kinds of illegal dumping of solid wastes.
- c) The Waats App Number for registering complaint from public is advertised in prominent places and notice board of Town Panchayat.
- d) The staff are sensitized to receive the complaints on time and adder them at the earliest
- e) It is planned to have interactive sessions with public, local associations and women groups for creating awareness on sanitation, citizens responsibilities, mutual sharing of activities and grievances.
- f) It is planned to have periodical interaction with nodal persons of Health centers, Pharmacies and traders association, to minimize the complaints and maximize their cooperation.
- g) Frequent awareness campaigns on waste disposal and solid waste management are being conducted.
