**ADDITIONAL REPLY STATEMENT ON BEHALF OF THE
RESPONDENT No. 1 and 3**

I, Niligonda Venkateswarlu, S/o. Narsaiah, aged about 56 years, working as Commissioner, Nereducharla Municipality do hereby solemnly affirm and sincerely state as follows.

1.I submit that I am the 3rd respondent herein and I am filing this Additional reply statement on behalf of the 1st respondent and 3rd respondent also. I am well acquainted with the facts of the case from the records and as such I am competent to file this reply statement before this Hon'ble National Green Tribunal.

2.It is further submitted that in paragraphs 2& 4 of the Hon'ble NGT Order date 10.08.22in OA No.51 of 22, that the Applicant has raised few issues as follows for which this respondent clarifies as follows:-

i. Dumpsite is a closed stone quarry which has 7 to 8 feet deep pits	At present Dumpsite is a not a stone quarry. There is no deep pits at the dumpsite. Some of the portions are 2 to 3 feet in depth, pits which has been filled with debris material
ii. Dumpsite is situated 70 to 80 meters away from habitations	Dumpsite is situated 110 meters away from Battuvanikunta.
iii. Dumping is going on adjacent to fertile paddy fields	This is the only available Government land in Srvy.No.453, we have temporarily provided fencing to prevent the dump from falling in the fertile paddy fields
iv. Dogs and pigs menace has increased at dump site and causing bad odour.	Wandering of pigs and dogs are completely prohibited by municipal council, Nereducharla. On several occasion notices have been issued to pig herders and lot of pigs and dogs have been caught and transported out of town. Therefore, there is no possibility for any nuisance at dumpsite by pigs and dogs.
v. Due to non-segregation of garbage and plastic, plastic waste and plastic covers are borne by wind into paddy fields	The segregation of garbage and plastic happens at house hold level and we collect garbage, plastic from separate bins. To prevent spreading of covers into the paddy fields, compound wall has been proposed at a cost of Rs. 65 Lakhs. Proposals have been sent to Higher authorities for their approval.

vi. Breeding of mosquitoes and spreading of diseases	Nereducharla municipality is taking up several activities like fogging, spraying and bleaching to prevent breeding of mosquitoes & seasonal diseases.
vii. Municipal authorities are not segregating biodegradable material	The Hon'ble C&DMA has also issued proceeding vide Roc.No.180320/ 245849/ 2022 and also has issued the circular to the remediation and reclamation of legacy waste in dumpsite at Nereducharla municipality.
viii. Polluted water from dump site is flowing into the agriculture fields, nearby stream and finally polluted water from dump site to chillepalli lake	All precautions has been already taken to prevent polluted water flowing from dumpsite to chillepalli lake.

4. It is submitted that the Nereducharla Municipality was newly formed on 02-08-2018. As per the Telangana State Municipal Act 2019, in this act, section 127 (1), (2), (3) it is the responsibility of the Municipality to process the entire municipal solid waste collected duly, segregating and using scientific management including Bio-mining, Bio-processing or any other technology as prescribed by the Government or any of its agency. The Municipality may identify the lands which are at reasonable distance from densely populated areas, for setting up of future dump sites. If such lands for the purpose of this dump site is not available with the Municipal Authorities, as per

Section 127 sub section (3) it shall be the duty of the District Collector to provide the Municipal authorities with appropriate land from amongst land under his control. Accordingly, the District Collector, Suryapet was requested for allotment of Government land for the above purpose of dump yard in Nereducherla Municipality surroundings.

5. As stated earlier the work of remediation and reclamation in 11 No's of urban local bodies Nalgonda and suryapet district including Nereducherla Municipality has been awarded to one M/s. Harshita Infra Engineering Private Limited and the concession agreement was executed on 13.07.2022.

6. It is therefore prayed that the Hon'ble Tribunal may be pleased to pass appropriate order or orders as this Hon'ble Tribunal may deem fit and proper in the circumstances of the case.

The attention of all the AC,LBs, and MC's noted in the address entry is invited to the refs., cited. It is to inform that tenders were called for Biomining of legacy waste in 123 ULBs in the State. Technical & Financial evaluation of the bids were done by the Committees constituted by the Government vide ref 2nd cited.

2. It is to inform that vide ref 3rd cited, as per SBM Urban 2.O guidelines, Govt of India have agreed for funding under Biomining @ Rs.550/- per metric ton.

3. Tender were evaluated and submitted to the Government for approval. Further, vide ref, 7th cited, Gol have approved the proposal of remediation of legacy waste dumpsites. Govt vide G.O.8th cited, have issued orders for taking up bio-mining of legacy waste @ Rs.550/- per Metric Ton for (09) clusters covering 123 ULBs and awarded the work to the following agencies:

4. In this regard, it is to inform that successful bidders were given letter of Intent on 23.02.2022 and a meeting was convened on 15.03.2022 with all the above Bidders and they were instructed to start the work immediately.

5. Keeping in view of the above, the following Roles & Responsibilities of the AC LBs, Municipal Commissioners and the Agencies for the execution of the project are as follows:

Role of AC, LBs:

- 5.1 To conduct, initial meeting with the contractor and Municipal Commissioner, ME, SI to review the time bound action plan as submitted by the Contractor and direct to complete the activities as per submitted schedule. It may be noted that a compliance report has to be submitted to Hon'ble NGT periodically.
- 5.2 To conduct fortnightly meeting, if required on earlier periodically, with the Municipal Commissioner and others on the progress made and if needed conduct the review meeting with all relevant stake holders to sort any issues and periodical update may be submitted to the Dist Collector
- 5.3 Inspect the bio mining activities and validate the progress made in view of the NGT and SPCB compliances.
- 5.4 Monitor the performance of agencies for successful completion of the bio mining activity and utilization of the recovered land for useful purpose.
- 5.5 Recommend payments based on quantity of work done on submission of weekly report by the Municipal Commissioner.
- 5.6 Since the rate and project is already approved by the Government (GoT & GoI), no further approvals are required for the project. The subject may be placed before council for information only.
- 5.7 The AC, (LB) shall be single Nodal officer at District Level for implementation of the project. Hence, all further decisions for successful timely completion of project in terms of finances or administration shall be taken by the him/her under intimation to this office. They shall also ensure that the fund flow for the project is not affected. In case of any financial crunch in respect of any ULB, the same may be brought to the notice of this office. The SBM-U funds and Pattana Pragathi (50% State Matching & 50% CFC) can be utilized for the project.

Role of ULB/Commissioner:

- 5.a To handover the contractor the exact site to be recovered and provide possession of Dumpsite for Remediation & Reclamation through Bio-mining as per Concession Agreement. As the work is for limited time period, the MC may directly issue the letter.

- 5.b Ascertain the Implementation Plan submitted from the Agency immediately.
- 5.c Pl ensure before and after photos are taken from same angle at every stage/activity and both hard & soft copies are maintained for the purpose of records, and for reports as well as audit.
- 5.d To designate himself as nodal officer at ULB level so as to be in contact with the contractor or a person appointed by the contractor to carry out the bio remediation operations.
- 5.e ULB shall assist in documentation and approvals, whenever necessary, for the Water and Power connection.
- 5.f Monitor the process of ascertaining the quantity of legacy waste using the topo survey and drone survey and intimate the same (Qty.) to the CDMA office.
- 5.g To conduct periodical inspection on weekly basis and appraise the progress supported with pictures to the O/o CDMA and also validate the data provided by the Agency in monthly progress reports after seeking comments of the IE.
- 5.h Monitor the provisions of dust barriers around the legacy waste to avoid any immediate air pollution to the nearby residents provided by the agency.
- 5.j Direct the contractor to collect any leachate in a temporary pond created using plastic sheets and utilize the leachate for spraying on the existing legacy waste for treatment.
- 5.k Have right over assets and technology in case of Termination or expiration of Concession Period, whichever is earlier.
- 5.l Take guidance of the AC(LB) relating to furtherance of project and follow the directions.
- 5.m Ensure weekly / fortnightly payments to the agencies after approval of the AC (LB)
- 5.n Ensure that the conditions of contract are fulfilled in true spirit.
- 5.o Any deviations/lapses in the matter the Municipal Commissioner and the concerned Engineer shall be held responsible.
- 5.p As it is a time bound project utmost care shall be taken for adhering to the timelines.


