STATUS REPORT BY GREATER CHENNAI CORPORATION

IN O.A. No. 95 OF 2020.

I, D.Rajasekar, S/o. Dr.K. Dharmalingam , Hindu, aged about 56 years, Zonal Officer, Zone - XI, Greater Chennai Corporation, having office at No.33, Arcot road, Valasaravakkam, Chennai 600 087, do hereby solemnly affirm and sincerely state as follows:

1. I submit that I am working as the Zonal Officer in Zone - XI, Greater Chennai Corporation and filing this report on behalf of the Commissioner, Greater Chennai Corporation and hence I am well acquainted with the facts and circumstances of the case.



2. I respectfully submit that this Hon'ble Tribunal has taken a Suo Moto case on the paper publication in O.A. No. 95 of 2020 (SZ) and has passed an order to file a further action report by the Respondents.

3. I respectfully submit that due to the outbreak of the Corona virus disease (Covid-19), the Government of India declared it as a pandemic, and provisions of the Epidemic Diseases Act, 1897 had been invoked. Educational institutions and many commercial establishments had been shut down. India had suspended all tourist visas, as a majority of the confirmed cases were linked to other countries. Above all, the entire country was under lock down from 24th March 2020 onwards for months together. Further the officials of Greater Chennai Corporation were engaged in COVID-19 relief work. I further submit that the Election Commission of India declared Elections in Tamil Nadu for Legislative Assembly in the month of March, and the election results were declared in May 2021. Also, the State Election Commission declared urban local body election on 28.01.2022 and the election result was announced on 04.03.2022, during which time model code of conduct was in place.

4. I further submit the details of the action that has already been initiated against encroachers. As stated earlier, notices dated 09.03.2022 under Section 220 read with Section 222 of Chennai City Municipal Corporation Act, 1919 have been issued to the 21 building owners who are running small commercial shops. I further submit that, subsequently on 14.03.2022 and 15.03.2022, this Respondent's officials of Zone XI, tried to serve notices under Section

220 read with Section 222 of Chennai City Municipal Corporation Act, 1919, to the remaining encroachers, however the encroachers/local people stiffly opposed the same and did not allow the officials to enter the said area.

5. I further submit that a letter dated 15.03.2022 was addressed to Commissioner of Police, Vepery, Chennai, by this Respondent to provide necessary Police bandobast, and another letter was addressed by this Respondent to Chennai District Collector to provide necessary support to Greater Chennai Corporation officials for issuing encroachment notices. I further submit that a letter was addressed to Tahsildar, Maduravoyal Taluk, by Zonal Officer, Zone-11, for demarcating the boundaries of Ramapuram lake and to coordinate with Greater Chennai Corporation officials for issuing notices to the encroachers.

6. I further submit that a joint meeting was conducted by Regional Deputy Commissioner - South, Greater Chennai Corporation, along with Deputy Commissioner of Police, T. Nagar on 16.03.2022, where it was decided to form eight teams headed by Assistant Engineers of Zone 11, Greater Chennai Corporation, along with Revenue and Police officials. After this meeting, Police protection was organized, and it was decided to issue notices under Section 220 read with Section 222 of Chennai City Municipal Corporation Act, 1919 to the encroachers.

7. Each of the eight teams formed for issuing the notices was headed by an Assistant Engineer of Greater Chennai Corporation. The other officers included 1 Sanitary Inspector of

GCC, 1 Conservancy Inspector of GCC, 5 laborers, 1 VAO, 1 Surveyor, 1 Inspector of Police, 3 Sub -Inspectors, 22 constables. This team was supported by 1 inspector, 2 Sub-Inspectors, 20 of other ranks in police, to prevent law and order situations. Along with them, 1 police constable and 1 arrest vehicle was deployed. In addition to this, 2 mufti policemen accompanied the teams.

8. Following this, notices under Section 220 read with Section 222 of Chennai City Municipal Corporation Act, 1919, dated 17.03.2022 were issued to 389 house owners. The details of the same are enclosed in separate annexures along with this status report.

9. I respectfully submit that for the removal of encroachment in the Ramapuram lake area, action has been initiated against all the encroachers as per the provisions of the Chennai City Municipal Corporation Act, 1919. Further action will be taken with sufficient support from the relevant authorities, by following the due process of encroachment eviction.

10. I respectfully submit that a Writ Petition in W.P. No. 22958 of 2019 is pending before the Hon'ble Division Bench, Madras High Court and the case is posted on 22.03.2022 for filing of further action report.

When the staff of Greater Chennai Corporation tried to serve the notices. People in that area do not allow the staff to enter the area.

Hence, it is requested to provide necessary police bandobast during the issuing of encroachment notices from 16.03.2022 to 19.03.2022 in order to comply with Hon'ble High Court direction.






