

**Factual and action taken report in the matter of Amit Kumar & Anr, V/s Union of India & Ors. Original Application No.90/2024 (CZ), Hon'ble NGT, Central Zone Bench, Bhopal**

**Background**

The original application has been filed by the applicants Sh. Amit Kumar and Sh. Kailash Meena against the various Departments, as mentioned in the writ, alleging that the illegal mining and stone crushers are operating and and unlawful encroachments have been done in the riverbed of Sota River (A tributary of Sahibi River) which is covering the parts/areas of Tehsils Kotputli and Behror.

**Order**

Hon'ble NGT, Central Zonal Bench in its order dated 24/04/2024 had directed *inter alia* as follows: -

*"...8. We deem it just and proper to call a report on the matter in issue in present Original Application, from a Joint Committee consisting of:-*

- i. One representative from the Water Resources Department, Government of Rajasthan, Jaipur (Rajasthan).*
  - ii. One representative from the Principal Secretary, Ground Water Department Government of Rajasthan, (Rajasthan).*
  - iii. One representative from the CPCB.*
  - iv. One representative of Rajasthan State Pollution Control Board, Rajasthan.*
- 9. The committee is directed to visit the place and submit the factual and action taken report within six weeks...."*

Accordingly, Superintending Engineer, Water Resource Circle, Jaipur was nominated, vide letter no. 920 dated 30/04/2024 and subsequently, vide letter no. 255 dated 13/05/2024, Executive Engineer, Water Resource Circle, Jaipur, was nominated as representative of Water Resource Department, Rajasthan. Copies of letters has been enclosed collectively as **Annexure-1**.

And where as, Superintending Engineer, Ground Water Department, Jaipur was nominated, vide letter dated 20/05/2024 and subsequently, vide letter dated 05/06/2024, Senior Hydrogeologist, Ground Water Department, Alwar, was nominated as representative on behalf of Principal Secretary, Ground Water Department Government of Rajasthan. Copies of letters has been enclosed collectively

as **Annexure-2**.

And whereas, Scientist-C was nominated as a representative of Central Pollution Control Board (CPCB) vide letter no. 216 dated 03/05/2024. Copy of the letter has been enclosed as **Annexure-3**.

And whereas, Regional Officer, RSPCB, Alwar, vide letter no. 157-158 dated 26/04/2024 was appointed as Officer In-charge on behalf of Rajasthan State Pollution Control Board. Copy of the letter has been enclosed as **Annexure-4**.

### **Joint Committee Visit**

In accordance with the aforementioned Hon'ble NGT order and letters, a video conferencing was conducted on 06/06/2024 to prepare an action plan and to decide further course of action needed to be taken in order to comply with the directions issued by Hon'ble NGT with the aforementioned representatives of the departments, wherein it was decided that since the applicant has alleged about the illegal operation of mining activities, crusher activities and establishments in the riverbed of Sota River, therefore, a letter may also be written to District Collector, District - Kotputli-Behror, with the request to direct the concerning Sub-Divisional Magistrates (i.e. Paota, Kotputli and Behror) to assist the joint committee in their site visit and to provide the requisite data/information for preparation of joint committee report and to carry out first joint committee visit, of the site, on 14/06/2024. Minutes of video conferencing are attached as **Annexure-5**.

Accordingly, the joint committee members/representatives visited, the site in concern, on dated 14/06/2024. Following officials were present during the joint committee visit:-

- i. Sh. Deependra Jharwal, Senior Environment Engineer and Regional Officer, Regional Office, RSPCB, Alwar,
- ii. Sh. Milind Nimje, Scientist-C, CPCB, Bhopal,
- iii. Sh. Praveen Kumar, Tehsildar, Paota,
- iv. Sh. Kailash Chand Sharma, Junior Hydrogeologist, Ground Water Department, Alwar and
- v. Sh. Shailendra Garhwal, Assistant Engineer, Water Resource Department, Kotputli.

Thereafter, 2<sup>nd</sup> Joint Committee Visit was proposed on dated 01/07/2024 (vide RSPCB letter dated 25/06/2024) and subsequently on dated 02/07/2024 (vide RSPCB letter dated 26/06/2024). Copies of both the letters are enclosed as **Annexure-6**.

Accordingly, the joint committee members/representatives, assisted by concerned SDMs of the area, again visited the site in concern, on dated 02/07/2024. Following officials were present during the joint committee visit (Copy of attendance sheet enclosed as **Annexure-7**):-

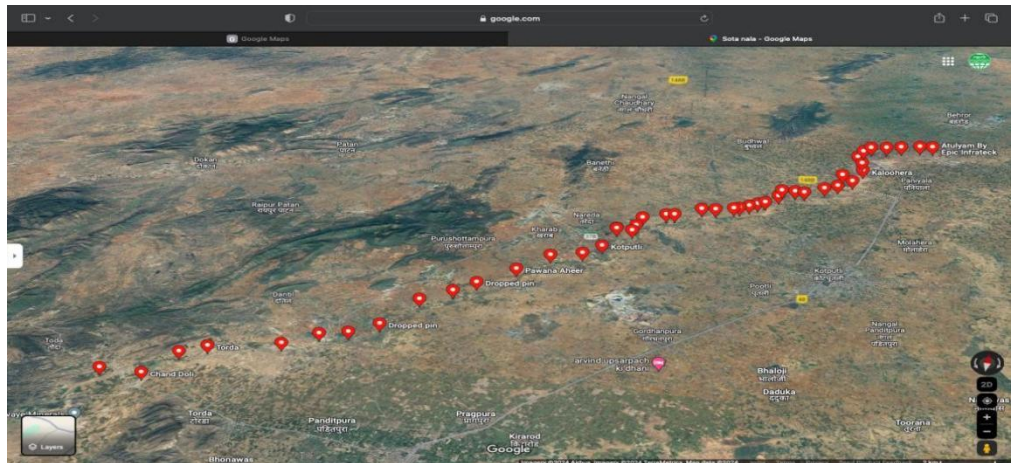

### Observations

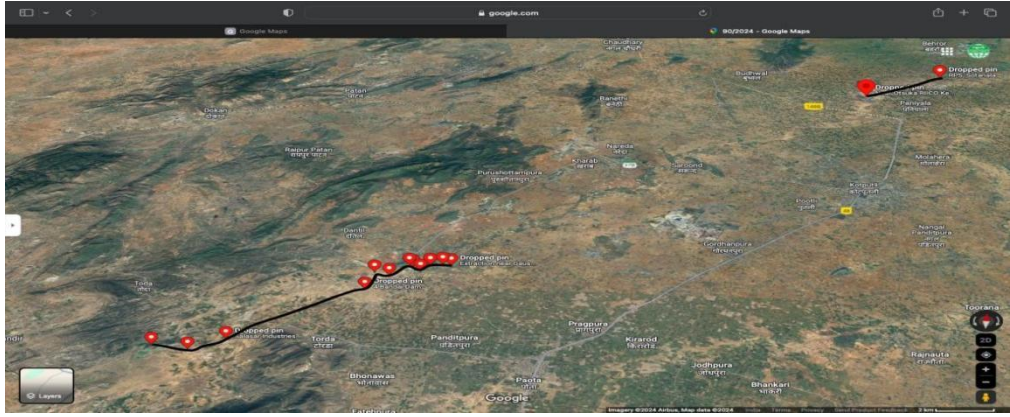
During aforementioned field visits (i.e. 14/06/2024 and 02/07/2024) and on the perusal of records, following observations were made:-

- i. The area of river-flow of Sota River starts from Paota to Kotputli and ends in Behror. There are two notable dams/reservoirs in this stretch namely Buchara Dam and Banedi Bandh. The River-Flow co-ordinates pointed on Google Maps, as provided by the WRD is shown below:-

- ii. The members inspected the area starting from Buchara Dam and its nearby areas, Banedi Bandh and its nearby areas, Bhuri Badhaj area, RIICO Keshwana area and Sotanala area including RPS International School (as mentioned in the original application filed by the applicant).

- iii. During the course of inspection, traces of mining activities were observed near the Buchara Dam area (Co-ordinates 27.586251 N, 75.977471 E) and River Sand mining were also observed in the Banedi Bandh (Co-ordinates 27.617548 N, 76.027188 E) and its nearby catchment area. Also, some of the stone crushers were found operative in the places visited by the Joint Committee Members.
- iv. Details of the aforementioned stone crushers, with reference to the Consent to Operate (CTO) and their validity, issued by RSPCB are as follows:-

The pollution control measures were found adopted by these aforementioned stone crushers. During the visit, Sh. Praveen Kumar, Tehsildar, Paota informed that the details of illegal stone crushers and its encroachment will be provided after verifying the records but till date no information provided.

- v. In view of the observations made during site visit dated 14/06/2024 and 02/07/2024, since the mining activities in the area pertain to Mining Department/Forest Department/Land Revenue Department,

the establishment of structures in and around the probable river-flow area of the Sota River pertain to Land Revenue Department and encroachment in the collection/storage area of dams/reservoirs pertain to Water Resource Department, therefore, Regional Office, RSPCB Alwar (being the nodal agency) issued letters to the concerned departments, as above, for submission of factual status and action taken report, if any, for their jurisdiction. Copies of the letters dated 05/07/2024 and reminder letters dated 19/07/2024 are collectively enclosed as **Annexure-8**.

- vi. However, the requisite information/data has not been received from all the departments except Mining Department and RIICO Keshwana.
- vii. Assistant Mining Engineer, Kotputli, vide its letter dated 15/07/2024, informed that several cases of illegal mining has been observed in the past as well in Buchara Dam, Banedi Bandh area, Bhuri Badhaj area and Mining Department is regularly taking action against the illegal mining. From financial year 2010-11 to financial year 2024-25 (up to 30/06/2024), the department has taken action against 2113 number of cases for illegal mining/illegal transportation/illegal storage and also imposed and collected penalty of Rs. 836.24 Lakhs. Assistant Mining Engineer, Kotputli letter dated 15/07/2024 is enclosed as **Annexure-9**.
- viii. As far as the establishment of RIICO Industrial Area, Keshwana is concerned, the Unit Head, RIICO Neemrana, vide its report enclosed with the letter no. 868 dated 12/07/2024, stated that land measuring area 178.42 hectares, of village Keshwana Gurjar and Keshwana Rajput of Tehsil Kotputli in District Kotputli-Behror, was set apart by District Collector, Jaipur, vide its order no. 15381 dated 26/11/1992, for the industrial purpose. Thereafter, land of area measuring 33.53 hectares and further 11.32 hectares were also allotted/acquired in favor of RIICO. Later on, RIICO surrendered land measuring area 20.84 hectares. As per the report, there is no encroachment made by RIICO Keshwana on the riverbed of the Sota River. The report of Unit Head, RIICO Neemrana is enclosed as **Annexure-10**.
- ix. Photographs, with GPS co-ordinates, taken during site visits dated 14/06/2024 and 02/07/2024 are enclosed as **Annexure-11**.

**Recommendation of the Joint Committee:-**


Since the applicant has alleged regarding the illegal mining activities, establishment of stone crushers, illegal encroachment, etc. in the river-flow of Sota River, which is related with the jurisdiction of various departments as already mentioned above (point no. "v" of observations), therefore, this committee is of the view that separate action taken reports shall be submitted by the concerned departments before Hon'ble National Green Tribunal.

## Factual Status on Industrial area Keshwana

Sub :- Regarding Hon'ble NGT, Central Zone Bench, Bhopal order dated 24.04.2024 in the matter of Amit Kumar & Ant. V/s Union of India & Ors. Original Application No. 90/2024 (CZ).

The District Collector Jaipur set apart land measuring 178.42 hect. of village Keshwana Gurjar & Keshwana Rajput, Tehsil Kotputli, Distt. Kotputli-Behror under section 92 of land revenue act 1956, vide office order no. R-18B(9)1992/I/15381 dated 26.11.1992. Further, Government of Rajasthan had ordered that the land specified in the schedule which had earlier been set-apart by the District Collector, Jaipur by the order no. R-18B(9)1992/I/15381 dated 26.11.1992 under section 92 of the land Revenue Act, 1956 for industrial purposes is allotted to Rajasthan State Industrial Development and Investment Corporation, Jaipur. Thereafter, land measuring 35.53 Hect. was also allotted to the corporation. The Corporation had also acquired private khatedari land measuring 11.32 hect. of village Keshwan Gurjar for the industrial area for industrial purpose vide award dated 15.12.2001. As per decision of Government of Rajasthan, RIICO land measuring 20.84 Hect. was surrendered by the corporation.

After taking possession of the land RIICO had developed aforesaid industrial area wherein 38 nos. Industrial plots were planned. The corporation has allotted all 38 nos. Industrial plots to industrialist for establishing industrial unit in the industrial area.

As per revenue record/map and also on inspection of site it was observed that no encroachment is made by RIICO on the riverbed of the Sota River.
