In the above noted case Hon'ble Tribunal has passed an order dated- 26-11-2019. The relevant portion of the order is as below-

1. Accordingly, report has been filed by the joint committee on 19-11-2019 that 43 brick kilns were inspected. 482 more brick kilns were in existence. The siting criteria was laid down under the Uttar Pradesh Brick Kilns (Siting Criteria for establishment) Rules, 2012. Though it is stated that siting norms will apply to kilns established after 2012, the report does not show how many brick kilns existed prior to 2012. Compliance of air quality norms is also not mentioned. It is undisputed that unit set up after 2012, in violation of laid down siting criteria, cannot be allowed to continue. With regard to others, this Tribunal has already held vide order dated 10.07.2019, in Review Application No. 34/2019, Bhag Singh Vs Union of India and Ors, that the siting criteria can be invoked for future while renewing the Consent to Operate. No vested right is created by mere establishment. If such establishment affects public health and environment, consent to operate may not be renewed, having regard to environmental status. The SPCB has also to have regard to the carrying capacity of the area to sustain activity of brick kilns while renewing consent to operate in the light of 'Precautionary' and 'Sustainable Development' principles of the environment act. All that is required for assessing the carrying capacity is the existing air quality and the anticipated impact of the permitted activity, which can be done by the SPCB itself from time to time.
2. In view of above, let further action be taken and compliance report filed within two months by e-mail at judicial-ngt@gov.in.

ACTION TAKEN REPORT IN COMPLIANCE OF ORDER DATE 26-11-2019 PASSED IN OA NO 550/2019 TITLED RAJBEER SINGH VERSUS STATE OF UTTAR PRADESH

In the above noted case Hon'ble Tribunal has passed an order dated- 26-11-2019. The relevant portion of the order is as below-

1. Accordingly, report has been filed by the joint committee on 19-11-2019 that 43 brick kilns were inspected. 482 more brick kilns were in existence. The siting criteria was laid down under the Uttar Pradesh Brick Kilns (Siting Criteria for establishment) Rules,2012.

Though it is stated that siting norms will apply to kilns established after 2012, the report does not show how many brick kilns existed prior to 2012. Compliance of air quality norms is also not mentioned. It is undisputed that unit set up after 2012, in violation of laid down siting criteria, cannot be allowed to continue. With regard to others, this Tribunal has already held vide order dated 10.07.2019, in Review Application No. 34/2019, Bhag Singh Vs Union of India and Ors, that the siting criteria can be invoked for future while renewing the Consent to Operate. No vested right is created by mere establishment. If such establishment affects public health and environment, consent to operate may not be renewed, having regard to environmental status. The SPCB has also to have regard to the carrying capacity of the area to sustain activity of brick kilns while renewing consent to operate in the light of 'Precautionary' and 'Sustainable Development' principles of the environment act. All that is required for assessing the carrying capacity is the existing air quality and the anticipated impact of the permitted activity, which can be done by the SPCB itself from time to time.

2. In view of above, let further action be taken and compliance report filed within two months by e-mail at judicial-ngt@gov.in.

Pursuant to the above directions the Status of 525 brick kilns is prepared along with the date of establishment of the brick kilns (before or after 27-06-2012 from which the guidelines is applicable) annexed as Annexure-I. From the status, it is revealed that 476 brick kilns were established prior 27.06.2012 and 49 brick kilns are established after 27.06.2012 this is the date from which guidelines of Uttar Pradesh Brick Kilns (Siting Criteria for establishment) Rules,2012 is applicable. Out of 525 brick kilns 328 having valid consent. Consent is granted to those brick kilns only which have been converted into High-Draft Zigzag technology and no complaint against such brick kilns are pending. The consent is not granted to the brick kiln against which complaint is received and compliant found genuine.

It is also to bring to kind notice to the Hon'ble Tribunal that all brick kilns are lying closed presently due to order passed by Hon'ble National Green Tribunal in OA No. 1016/2019 (Utkarsh Panwar Versus Central Pollution Control Board and Others) dated 30.01.2020.

An ambient Air Quality Monitoring was done at different Places in district Baghpat at the following locations :-

Serial No.	Location
1.	Krisht Jyoti Senior Secondary School, Baghpat
2.	Vikram Ent Udyog, Chhaprauli road, Baraut , Baghpat
3.	Katha, Khekra, Baghpat

These locations are situated at cluster of brick kilns. The Ambient Air Quality Monitoring Reports are Annexed as Annexure-II. The reports are higher than norms. When the brick kilns will operate, the actual values of the parameters may be more higher. The actual assessment of the impact on air quality can be assessed when the brick kilns will be operational. But it is evident that the number of brick kilns are very high in district Baghpat and there is a need to prevent any further increase in brick kilns. Therefore it is prayed before Hon'ble Tribunal that the District Administration Baghpat may please be directed, not to allow new brick kilns in the district Baghpat and no license to be given by Zila Panchayat, district Mining Officer and the revenue department. So, that air quality may not deteriorate further.

It is also submitted that the Hon'ble Tribunal has passed an order dated 30.01.2020 in OA No. 1016/2019 (Utkarsh Panwar Versus Central Pollution Control Board and Others). In this order direction has been given to CPCB for ascertaining carrying capacity of NCR Region and district Baghpat is also in NCR Region. The relevant content of the order is as below :-








ORDER

1. Question for consideration is permissibility of brick kilns in NCR till end of February 2020 or till level of air pollution becomes normal. A report was sought from CPCB about the impact of running of brick kilns in NCR, including those run by Zig-zag technology. The report filed on 13.12.2019 furnished by CPCB was considered by this Tribunal on 18.12.2019 to the effect that even brick kilns operated by

the Zig-zag technology had adverse impact on air quality in view of overall fugitive dust emissions. The Tribunal accordingly directed as follows:

"4. In view of the above, while CPCB may conduct further study for assessment of different types of brick kilns with reference to source emissions from different types of fuels, having regard to the conclusion that average fugitive SPM values are almost same in FCBTK and Zig-Zag brick kilns, the interim order directing closure of brick kilns in NCR will continue till the next date. Thereafter, brick kilns in NCR may be allowed only consistent with the carrying capacity and siting criteria, subject to GRAP, consent conditions and background concentration of ambient air quality."

2. In view of above, report dated 28.01.2020 has been filed by CPCB which covers not only the present matter but also O.A. No. 1088/2018, Dinesh Chahal Vs. UOI. The said matter is being dealt with by a separate order passed today on the question whether without carrying capacity, it was permissible to permit FCBTK technology kilns in non-NCR region. In the said order, it has been observed:

"6. It is acknowledged in the report of joint Committee that stack emissions are less in case of kilns operating on Zigzag technology, compared to the kilns operating on FCBTK technology on the same fuels. The report further mentions that introduction of FCBTK technology using agro-residue may be done only after carrying capacity assessment of specific area, covering estimation of total existing PM load, assimilative capacity with regard to PM and supportive capacity with regard to PM. Further, in view of large number of brick kilns operating in the area, besides carrying capacity issue with regard to ambient air, there are issues with regard to environmental degradation on account of operation of such large number brick kilns having potential for loss of productive top soil which takes thousand of years to form and is a prime factor which determines agricultural productivity.


7. For the above reasons, while the life of impugned order dated 07.12.2018 passed by the Director, Food, Civil supplies and Consumers Affairs, Government of Haryana has expired, question whether FCBTK technology can be allowed in non-NCR region of Haryana by using agri-residue will be determined in the light of further report as to the carrying capacity of the area in the light of potential for impact on the air quality of the area and

on NCT Delhi specially during the winter months and degradation of top soil.

8. Accordingly, let the carrying capacity study which has adequate samples in terms of number of brick kilns and days for which the emissions monitored be conducted covering the impact on ambient air and the loss of top soil. Such study may particularly assess the permissible number of brick kilns and technology to be used for the same in the non-NCR region. Let further report in the matter be furnished by the Member Secretary, CPCB by 31.03.2020 by e-mail at judicial-ngt@gov.in."

3. Since brick kilns can be permitted only after ascertaining the carrying capacity as above, let a report about carrying capacity of the NCR region in above terms be furnished by CPCB before the next date by e-mail at judicial-ngt@gov.in.
