1. That it is humbly submitted that as per the Action Plan of Central Pollution Control Board (CPCB), the CPCB had recommended that the drains falling into the River Hindon shall be cleared and immediate actions to do so shall be carried out.
2. That with regards to the above, it is submitted that taking the recommendation provided by the CPCB under consideration, the Urban

Local Bodies are carrying out the exercise of cleaning the drains periodically. The solid waste collected during the cleaning/desiltation is lifted and transferred to the Solid Waste Processing Plants for scientific processing.

The photographs of the cleaning/desiltation of drains being carried out is annexed herewith and marked as **ANEXURE-1**.

3. Hence, the present photographs of desiltation are being filed for the kind consideration and perusal of this Hon'ble Tribunal.





