

UTTARAKHAND**

I Santosh Badoni aged about 56 years S/o Late Shri Sachchidanand Badoni, currently posed as Additional Secretary of Urban Development Department, Government of Uttarakhand have been authorized to swear this compliance affidavit on behalf of State of Uttarakhand and Secretary, Urban Development Department, Government of Uttarakhand. That I does hereby solemnly affirm and state on oath as under.

1. I in aforementioned capacity is well acquainted with facts and circumstances of the case and is duly authorized by the competent authority to sign and swear the instant affidavit.
2. This affidavit is being filed in compliance of the directions of the Hon'ble Green Tribunal, New Delhi dated 18.09.2025 passed by this Hon'ble Tribunal particularly in terms of paras 11-12 of the said order.
3. It is submitted that in compliance with the Hon'ble National Tribunal order dated 18.09.2025 , National Mission for Clean Ganga (NMCG) held a hybrid review meeting under the chairmanship of ED (T), NMCG on 12.11.2025 to review the implementation status of the task assigned to NMCG under section

6(3) of the NMCG Notification, 2016 which was attended by several officers of various departments. That detailed directions were given to compile requisite data. That the copy of the minutes of the meeting dated 12.11.2025 is Annexed herewith as Annexure A.

4. It is most humbly submitted that the concerned State Departments in pursuant to the directions given in the meeting dated 12.11.2025 have provided the requisite data as sought by NMCG, *inter alia* vide the following correspondence:

- a. The Irrigation Department has provided identified and documented data pertaining to structures situated within the designated flood plain zone. That this data includes KML of the structures that fall within 5 year flooding area frequency of river Rispana. That this data includes GPS coordinates (latitudes and Longitudes) for each identified "pakka" structures.. Copy of the of the letter of Executive Engineer to Secretary, Uttarakhand bearing no 7364/Pra.A./SI.Vi./NI.Anu./NGT-417/2022, dated 28.11.2025 along with annexures is annexed herewith Annexure B.
- b. The Mussoorie Dehradun Development Authority (MDDA) and Nagar Nigam Dehradun have identified encroachments on the Rispana riverbed, as detailed in letter no. 1636/Bhumi/2025 dated December 5, 2025. This joint effort involved compiling a comprehensive database—specifically in areas such as Kathbangla-Dhakpatti—classifying structures as either "Temporary" or "Permanent" and documenting resident details alongside GPS coordinates. That this data has been provided to Program Director, State Clean Ganga Mission, Namami Gange for further action with the final verification. Copy of the letter

bearing no 1636/Bhumi/2025 dated 05.12.2025 is Annexed herewith as Annexure C.

5. Accordingly, the aforesaid information was duly compiled and consolidated by State Mission for Clean Ganga (SMCG), Uttarakhand and forwarded to the Director General , National Mission for Clean Ganga (NMCG) vide letter bearing no 733/SMCG/Namami Gange/NGT dated 09.12.2025 for review and action as per Rule 6(3) of the River Ganga (Rejuvenation, Protection and Management) Authorities Order 2016. The copy of the letter is Annexed herewith as Annexure D.
6. That Vide e-mail dated 16.12.2025 by office of NMCG sent to Program Director Namami Gange, it was conveyed that a committee under Director General, NMCG, will be conducting the site visit from 17.12.2025 till 20.12.2025 to enable them to proceed further as per Rule 6 (3) of River Ganga (Rejuvenation, Protection and Management) Authorities Order 2016. This exercise is likely to complete in four days and the concerned officers of the SMCG along with District magistrate, District Ganga Samiti, Dehradun, Vice-president, MDDA, Director, Urban Development Department, Municipal Commissioner, Nagar Nigam Dehradun, Executive Engineer, Irrigation Department will be part of the exercise. That the copy of the Email dated 16.12.2025 along with the schedule is Annexed herewith as Annexure E.
7. It is most humbly submitted that the State of Uttarakhand is in the process of complying with the orders and directions of this Hon'ble Tribunal in letter and spirit. The delay in execution on ground is neither intentional nor deliberate and due to practical exigencies while carrying out the works involving several agencies of the State.
8. The present affidavit is being filed by the Deponent as nodal officer to submit compliance and action taken on behalf of Respondent Nos. 1, 2, 5 and 7. The

A meeting in hybrid mode was held at NMCG on 12.11.2025 under the Chairmanship of ED(T), NMCG to review the implementation status of the task assigned to NMCG under section 6(3) of the NMCG Notification, 2016 in compliance with Hon'ble Tribunal Order dated 18.08.2025 in the matter of OA No. 417/2022, filed before the Hon'ble NGT, Principal Bench, New Delhi.

The of the Officers who participated in the meeting is enclosed as **Annexure-1**.

After detailed deliberation, following decisions were taken for compliance by concerned official (s).

1. As per the directions of Hon'ble NGT dated 18.08.2025, the tribunal has directed the State of Uttarakhand to provide the requisite information to NMCG within three months and accordingly NMCG can take actions as per the provision of the section 6(3) of NMCG Authority Order, 2026. In View of the approaching timeline i.e. 18.11.2025 for submission by Govt. of Uttarakhand; ED(T), NMCG requested to ensure expeditious compilation and submission of the required information in entirety to NMCG.
2. ED(T), NMCG reiterated that only after the submission of the requisite information site visit by NMCG will be meaningful.
3. He further raised queries regarding input data and approach used, to which it was submitted that it is the same set of data that was used for FPZ of 25 year and 100 year flood recurrence period and hydro-metrological approach was used. Rainfall data was taken from PMC atlas data of CWC.
4. He further inquired the source of parameters used for synthetic unit hydrograph, to that it was told that relevant hydro metrological subzones reports published from CWC was considered.
5. Since, 1-in-5 year return is considered as active flood plain zone and accordingly, the State has to delineate and share flood plain zoning lines on both sides of the River Rispana along its entire stretch, corresponding to a 1 in 5-year return period in .KMZ and .KML file formats.
6. Director (Urban), NMCG added that the format (**Annexure-2**) shared in MOM dated 14.08.2025 for providing details of the structures in the Active Flood Plain zone should duly be filled and submitted to NMCG along with the requisite information.

The meeting ended with vote of thanks to the Chair.




