Respectfully sheweth

The Applicants humbly submit as under:

**GROUND:**

1. That the Joint Committee (with the District Magistrate as Nodal Officer) has given the false and incorrect report in order to save its own skin as well as other concerned officials as it is responsibility of the District Magistrate to Rejuvenation the impugned Village Pond of Ludhiana as **the garbage is still being dumped in Village Pond as on date too and impugned village pond is in pathetic condition.** Further, the MCL has submitted in the report that illegal dumps have been closed whereas the fact is, garbage is still being dumped on such places and forcing the Public at large to live in miserable conditions. There are large number of locations at

which Solid Waste is being dumped in unscientific manner as MCL as well as GLADA, both have failed in door to door collection of garbage in Ludhiana. Thus the Municipal Commissioner as well as GLADA Chief Administrator, both are too indulged in Environment pollution as well as defying directions of this Hon'ble Tribunal as well as various Environment laws and rules, thus liable to prosecuted under section 26 of NGT Act, 2010 as well as other Environment provisions.

2. It is further pertinent to submit here that the Garbage is dumped in unsegregated manner at various illegal Points and shifted to Main Primary Tajpur Dump i.e. Garbage is not being disposed-off scientifically resulting into increase in legacy waste at Primary Dump by going against the directions of this Hon'ble Tribunal. It is humbly submitted that the Applicants waited for clearance of various illegal dump sites as well as cleaning of Village Pond till date but the replies submitted by the DC, MCL, GLADA & DDPO of village Gill & Churpur Road were mere an eyewash.

3. Thus, the Joint Committee has just tried to save the skin of all the department i.e. DC Office, MCL, GLADA, DDPO and LIT whereas the conditions at almost all location except very few location where the garbaged is being handled in un-scientific way and transported to primary dump at Tajpur Road resulting into increase in legacy waste.

**PRAYER:**

Keeping in view of the facts submitted above, the report prepared by the Joint committee is WRONG and FALSE and far away from actual and factual conditions of Solid Waste Management at above shared locations, resulting into Environment loss including

contamination of ground as well as surface water in Ludhiana and the report has been in order to save the skin of concerned officials of Respondents responsible, thus liable to be rejected by this Hon'ble Tribunal. The Applicants humbly prays this Hon'ble Tribunal to impose Environment compensation on the responsible departments and issue directions as prayed in the Original Application and as deemed to be fit by this Hon'ble Tribunal.

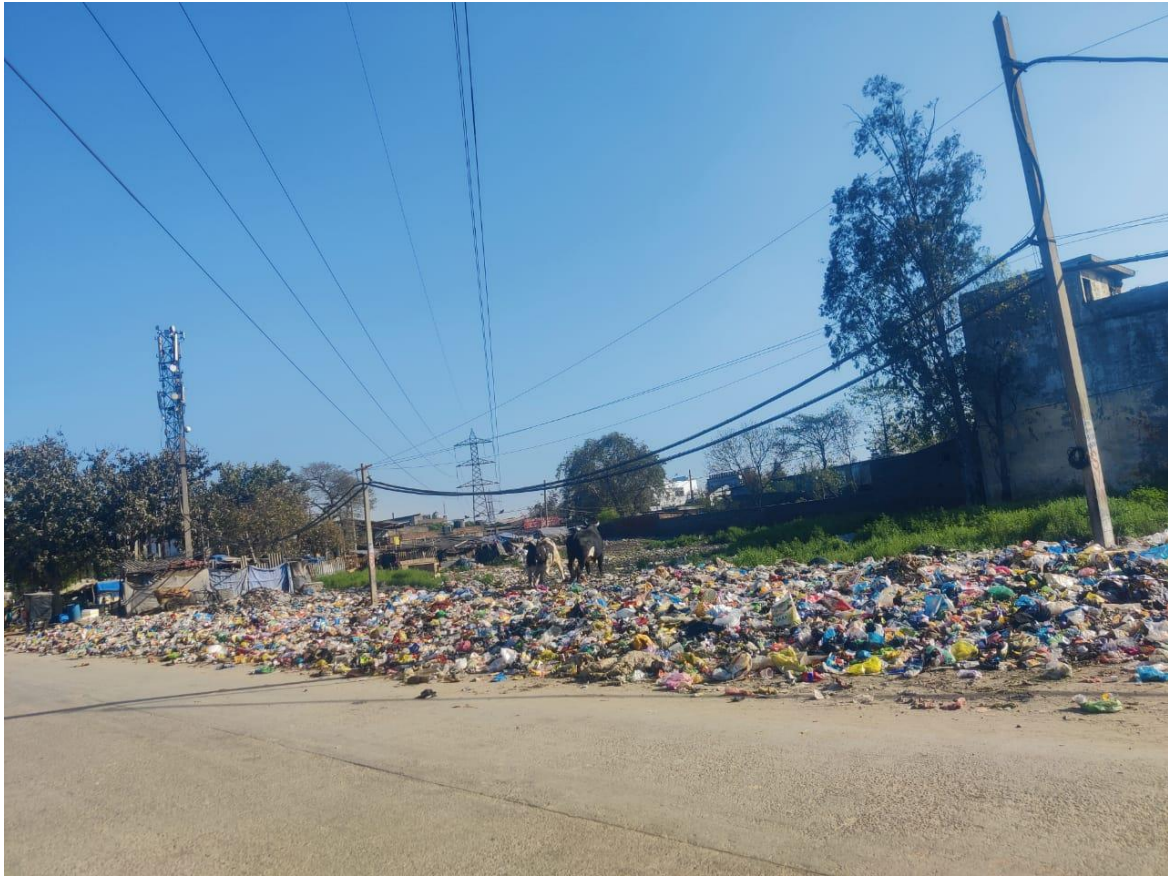

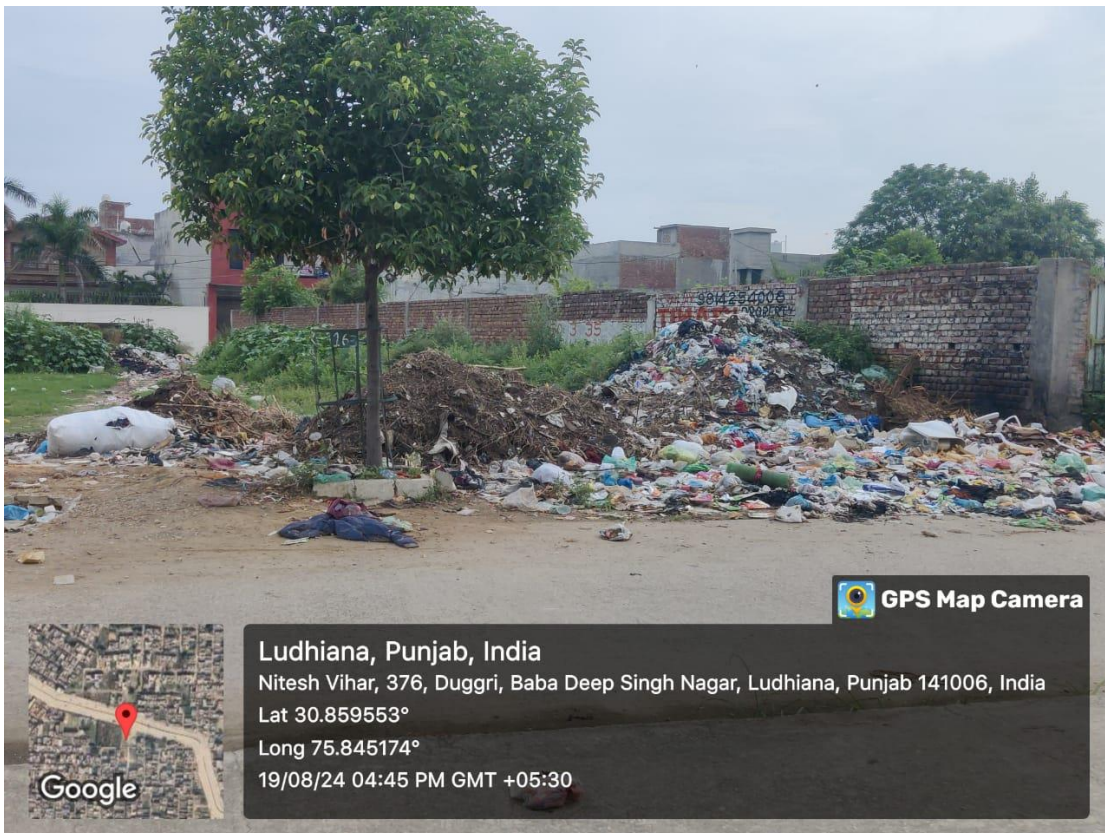
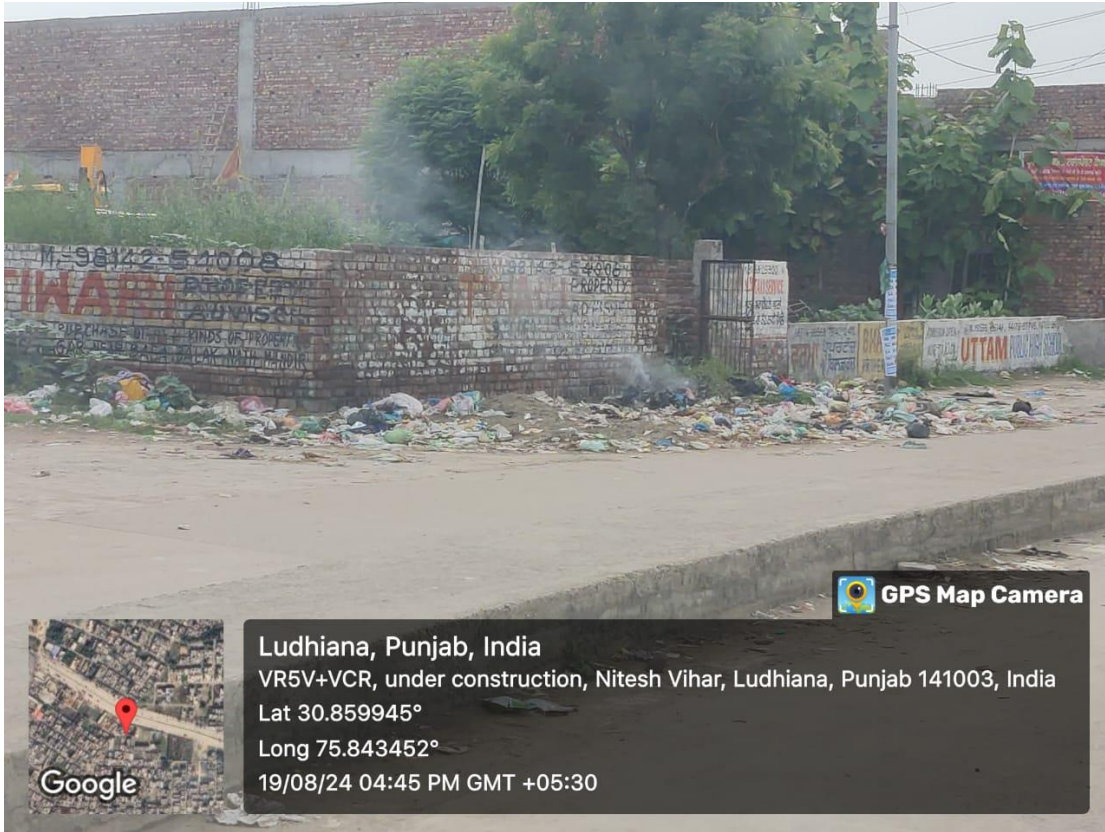
