

**ACTION TAKEN REPORT ON BEHALF OF DELHI POLLUTION CONTROL COMMITTEE WITH RESPECT TO ORDER DATED 07.01.2021.**

IT IS MOST RESPECTFULLY SHOWETH:

1. That, the Hon'ble NGT on 07/01/2021 was pleased to pass an order which pertains to unscientific dumping of sewage by tractors/vehicles of septic tank cleaners in Sangam Vihar Deoli Constituency. In the above order the Hon'ble Tribunal had composed a joint committee and had passed the following directions:

*"...In view of the above averments, a joint committee of DPCC, DJB and SDM, Saket may look into the grievance and take appropriate action in accordance with law. The DPCC will be the nodal agency for compliance and coordination ....."*

2. That in compliance to the above-mentioned orders, co-ordination has been done with Member (Drain), DJB and SDM, Saket to take action against unscientific dumping of sewage by tractors/vehicles of the septic tank cleaners at Sangam Vihar, and to submit action taken report to DPCC.

3. That the Office of the District Magistrate (South) vide its letter dated 17.02.2021 had sought action against un-authorized vendors

for illegal collection, transportation and disposal of septage at non designated locations from Delhi Police. Letter dated 17.02.2021 issued by the office of the Ld. District Magistrate South is annexed herewith and marked as **ANNEXURE -1**.

4. That, the Delhi Jal Board informed that the officials Delhi Jal Board, visited the location on 18.03.2021 & no disposal of the septic tank waste were found/noticed on the ground at mentioned location i.e., K-II, Harijan Basti, Jile Singh Farm, Sangam Vihar, New Delhi-80. The same was telephonically discussed by DJB with the petitioner wherein petitioner confirmed that presently no disposal of septage waste is being done at site.

5. That, the SDM (Saket) has informed that he asked the information from Local Police about the action taken to collect information of illegal collection, transportation and disposal of septage at various non-designated locations by unauthorised vendors. The local Police has not provided any action taken report till 08.04.2021. Copy of the letter dated 08.04.2021 of the SDM (Saket) is annexed herewith and marked as **ANNEXURE-2**.

6. That DJB has also informed that under Delhi Water Board Septage Management regulation 2018, it has permitted/ issued license to 208 Numbers individuals/ Agencies/ Firms/ Companies for the collection, Transportation and disposal of Septic Tank waste at DJB designated point. Further There are 06 DJB designated disposal location nearby Sangam Vihar area where septic tank waste may be disposed: (i) SPS EPR colony (ii) SPS Pul Pahladpur (iii) SPS East of Kailash (iv) STP/SPS Mehrauli, (v) SPS Arjun Nagar (vii) SPS Dakshinpuri. Copy of the letter dated 30.04.2021 issued by the Delhi Jal Board, is annexed herewith and marked as **ANNEXURE-3**.

7. That, in light of the correspondences annexed herein above, as of today no disposal of septage waste is being done at site. It is therefore requested to this Hon'ble Tribunal that the present status report may kindly be taken on record.

**Sub: Action against un-authorized vendors for illegal collection, transportation and disposal of septage at the non-designated locations including dumping in the storm water drain in the South Revenue District.**

Sir,

As you are all aware that to regulate the collection, transportation and disposal of waste of septic tanks and for matters connected therewith and incidental or ancillary thereto, Septage Management Regulations 2018 have been notified by the Government. Apart from District Administration, officers of different enforcement/ drain owing agencies like SDMC, PWD, Police etc., have been entrusted with crucial role to ensure the enforcement, and compliance of the aforementioned notified regulations:

Under these regulations, specific provisions for the issuance of License for collection and transportation of septage to notified Locations have been given and only licensed vendors are authorized to Collect and Transport septage for its disposal at designated locations. A list of the authorized vendors with tankers details and designated locations for the collection, transportation and disposal of the septage has also been enclosed herewith. (Annexure-I)

Despite the notified designated Locations by the DJB for the disposal of septage, instances have also been reported that in many unauthorized colonies, located within the territorial jurisdiction of the South Revenue District, owners of the residential units have engaged many non-licensed vendors for the collection and transportation. These unauthorized vendors are apparently involved in the disposal of septage at the non-designated locations including in the storm water drains, contrary to the provision of the aforementioned Septage Management Regulations. This is a serious violation and source of in river Yamuna.

The time has come that all stake holder departments like Storm water Drain owning Agencies, DJB, PWD, Local Municipal Corporation, Traffic/Local Police etc. take cohesive and inclusive steps in coordination with each other to launch comprehensive enforcement drive not only to impound the vehicles/ tankers illegally engaged in the collection and transportation of waste of septic tanks but also for the imposition of Environmental compensation on the defaulters, as per direction of Hon'ble NGT in OA No. 06/2012, so that true compliance of the Septage Management Regulations 2018 and Hon'ble NGT Order may be ensured.

In the enforcement drive, the role of the Local Police is very vital due to its visibility in the field and having comprehensive intelligence network which can be used to nab/ apprehend the real culprit and book them under the provision of Environmental Protection Act, 1986 for further action including

imposition of environmental compensation and impounding of illegal tankers involved in the alleged illegal collection, transportation & disposal of the septage at the non-designated locations.

Yamuna monitoring committee has also expressed its serious concern on the non-enforcing of Septage Regulations which require detection of illegal tankers and taking action against the vehicle owners in terms of the Hon'ble NGT order Dated- 11.09.2019 in OA No. 06/2012. For failure to enforce the provisions of the septage management regulations against unregistered septage collectors, there is sufficient cause to take action as has already been directed by NGT in its order dated 11.09.19. Para 15 (A) (iv)(g) of the NGT said order is produced below for ready reference:-

**"For delay of the work, the Chief Secretary, Govt. of NCT Delhi must identify the officers responsible and assign specific accountability. Wherever there are violations, adverse entries in the ACRs must be made in respect of such identified officers for delay in setting up of STPs, sewerage network and its connectivity by the concerned head of the department".**

Your attention is also drawn to the provision contained under Section 5 & Section 15 of the Environment Protection Act, 1986 read in conjunction with Hon'ble NGT direction, as quoted in the previous para, which gives ample powers to the local Police to collect information of the illegal collection, transportation and disposal of septage at various non-designated locations by the un-authorized vendors and report the same to Area SDM for further necessary action in terms of the provisions contained under Section 15 & 19 of the Environment Protection Act, 1986 and as per direction of Hon'ble NGT.

Considering the gravity of situation associated with the subject matter and the fact that the order of Hon'ble NGT are constantly monitored by the Yamuna monitoring committee, tangible and visible results on the field are to be ensured by the local Police. All such instances are to be brought to the notice of Area SDM through the mandated procedure for further necessary action.

It is hereby desired that all the Area SHOs may accordingly be sensitized to take up enforcement drive seriously and on priority so that the provision of Septage Management Regulations and direction of Hon'ble NGT read with recommendations of the Yamuna monitoring committee dated- 23.01.2021 are complied with, which inter-alia provides detection and impounding of illegal tankers and action against vehicle owners including imposition of environmental compensation.

Non-compliance of the order would be viewed seriously.


Sir,





Further, DJB has already been requested to SDM (Saket) and SHO vide this office letter No. DJB/EE(S)-III/2020/2659 to 2665 dated 06.11.2020 to issue necessary directions to concerned for taking action under provision of environmental act. to avoid unscientific dumping of sewage by tractors/vehicles of the septic tank cleaners at Sangam Vihar, Deoli Constituency, AC-47, New Delhi-80. (Copy placed as Annexure-B)

In this regard, EE(South)-III,DJB along with concerned Zonal Engineer Sh. Prem Singh was visited the location on 18.03.2021 & no disposal of the septic tank waste found/noticed on the ground at mentioned location i.e K-II, Harijan Basti, Jile Singh Farm, Sangam Vihar, New Delhi-80. Same was telephonically discussed with petitioner & he also confirmed that presently no disposal of septage waste is being done at site.
