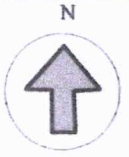

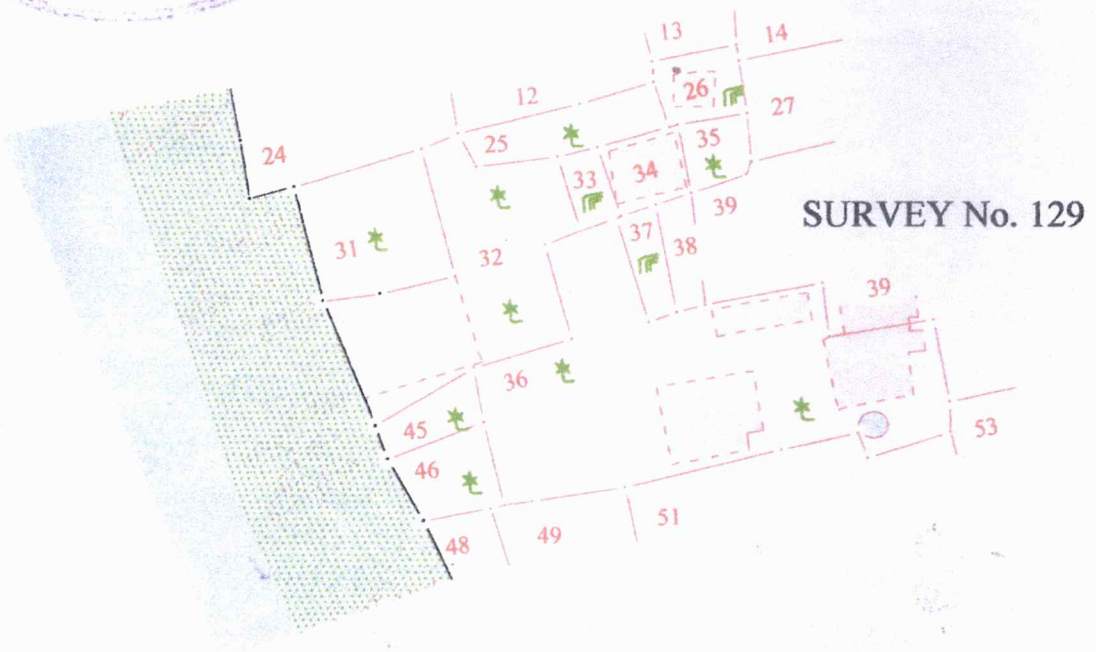


CBAR 121-13755
