

I, Kartikeya Langote, aged about 52, Occupation – Service, the Sub-Regional Officer of the Maharashtra Pollution Control Board at Pune-I having my office address at 2nd Floor, Jog Centre, Wakdewadi, Pune – 411003, do hereby state on solemn affirmation as under : –

- (1) I am filing this additional affidavit in reply in compliance of the order dated 04/03/2023 passed by this Hon'ble National Green Tribunal.
- (2) I say and submit that in compliance order dated 10/10/2023 the Respondent MPC Board has e filed Additional Affidavit in Reply on 28/02/2024 on issuance of the Public Notice in the leading Newspapers 'Times of India' & 'Indian Express' dated 26/02/2024 in English and in 'Maharashtra Times',

'Loksatta', 'Lokmat' & 'Sakal' in Vernacular language on 28/2/2024 in the State of Maharashtra.

- (3) I say and submit in compliance of order dated 04/03/2024, the Executive Engineer Building Permission Department, Zone No. 6 Pune Municipal Corporation has submitted list of 181 Nos. Marriage Halls in the jurisdiction of PMC on 12/03/2024. A copy of the Letter received from Pune Municipal Corporation dated 11/03/2024 is annexed as **Annexure I**.
- (4) I say and submit accordingly Respondent MPCB has issued Proposed Directions u/s 33A of the Water (Prevention and Control of Pollution) Act, 1974 and u/s 31 A of Air (Prevention and Control of Pollution) Act, 1981 dated 28/03/2024 to 181 Nos. Marriage Halls as per list provided by PMC, for carrying out activities without obtaining consent from the Respondent-Board and not providing adequate pollution control devices. A sample copy of the Proposed Directions issued to the Marriage Halls dated 28/03/2024 are annexed as **Annexure II**.
- (5) I say and submit that thereafter, on the basis of office record, the Respondent MPCB has issued Proposed Directions to 91 Nos. dated 25/04/2024. A sample copy of Proposed Directions issued to the Marriage Halls dated 25/04/2024 is annexed as an **Annexure III**.
- (6) I say and submit that Respondent MPCB On the basis of list provided by Respondent No.-1-PMC and based on the office record, Respondent Board has taken action against total 272 Nos of Marriage Halls. The further process of survey and visit is in process.

- (7) I say submit that During Visit the officials of MPCB has guide and made awareness to them about the Consent Regime and informed them to make application for the same. Some of Marriage Halls enquired about procedure for applying of the Consent by visiting Office of MPCB. Furthermore, Respondent MPCB has decided to conduct meeting with the Associations of Marriage Halls within Pune Municipal Corporation Limits/Jurisdiction for giving awareness to obtain Consent from MPC Board.
- (8) Hence this Affidavit.



AND WHEREAS, the Central Pollution Control Board has issued guidelines/mechanism for Control of Pollution and Enforcement of Environment Norms at Individual Establishments and the Area/ Cluster of Restaurants/ Hotels/ Motels/Banquets etc in Hon'ble NGT O.A.No. 400/2017 titled as Westend Green Farms Society Vs Union of India.
