Affidavit in terms of Order dated 03-09-2025 passed by this Hon'ble Tribunal.

I, Dr. Rakesh Minhas, presently posted as Deputy Commissioner, Jammu do hereby solemnly affirm/declare that the information given below is true and no part of this is false and nothing has been concealed.

1. That the Hon'ble Tribunal vide order dated 03-09-2025 directed the deponent to file affidavit disclosing the encroachers on the flood plain of River Tawi and place on record the revenue record showing the status of Khasra no. 302 and 303 of village Jammu Khas Tehsil and district Jammu.

2. That the above-captioned matter is pending before this Hon'ble Tribunal, and the case is now posted for hearing on 04.11.2025.

3. That the matter was taken up with the Chief Engineer Irrigation and Flood Control Canal Road, Jammu to furnish the list of encroachers falling within the flood plain vide letter no. DCJ/Legal/2025-26/435-37 dated 22.10.2025. Joint verification was conducted by Revenue department and Irrigation and flood Control department and report was furnished to this office vide letter no. TJ/OQ/2025-26/1134 dated 30-10-2025. **(Copy of the letter is annexed as Annexure-I)**

4. That the revenue record was sought from Tehsildar, Jammu who vide letter no. TJ/OQ/2025-26/1117 dated 29.10.2025 submitted the report from Naib Tehsildar Jammu Khas alongwith Khasra Girdawari pertaining to 302 & 303 of village Jammu Khas. **Copy of report along with Khasra Girdawari is annexed as Annexure-II).**

5. That the Jammu Smart City Limited Tawi River Front Project is executed under the aegis of Jammu smart city limited has been completed upto the extent of 98%. The major objective of the project are:

i. Providing a robust flood protection mechanism to the areas in the vicinity of the project.

ii. Diversion of polluting nallahs falling into the river in the reach of the project (3 no. of nallahs of right bank and 2 no. nallahs of the left bank.

The recent floods on August 26, 2025, provided a significant test for the Tawi River Front Project. Despite the severe impact of the floods on surrounding areas, the project infrastructure performed admirably, protecting the city areas within its reach. The project's ability to withstand the floodwaters and safeguard areas like warehouse, Belicharana, Gandhi Nagar, Talab Tillo, Bhagwati Nagar area etc, is a testament to its robust design and effective implementation. The success of the Tawi River Front Project in mitigating flood risks and reducing river pollution has significant implications for the city. By protecting the city from floods, the project has ensured the safety of lives and property, while also preventing damage to infrastructure. 6. That another achievement of the Tawi River Front Project is the interceptor drain system. This system has been designed to tap and divert 3 major nallahs on the right bank & 2 no. nallahs of left bank in the project reach the previously flowed directly into the Tawi River, carrying with them large amounts of pollutants including solid and liquid waste. By diverting these nallahs into interceptor drains, the project has significantly reduced the pollution load carrier by the river. The reduction in river pollution will have long term benefits for the improvement of environment and public health.
