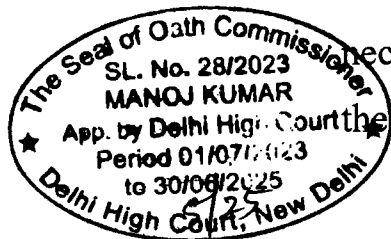

**COUNTER AFFIDAVIT ON BEHALF OF RESPONDENT  
NO. 2/ DELHI JAL BOARD.**

I, Ravindra Kumar Lakhera, S/o R. K. Lakhera, aged about 56 years, currently posted as CE (WEST) having office at Varunalaya Complex Phase-II, Karol Bagh, New Delhi-110005, do hereby solemnly affirm and declare as under: -

1. That I am well conversant with the facts and circumstances of the present case in so far as the same pertains to the Answering Respondent and as such am competent to depose with respect hereto.
2. At the outset, it is submitted that the Answering Respondent disputes and denies as false and vexatious, all the contentions, allegations, claims and averments which are contrary to anything stated or submitted in this reply. Nothing in the application may be deemed to have been accepted or admitted by the Answering Respondent for want of specific denial or traverse. The Answering Respondent further craves leave of this Hon'ble Tribunal to file such other/addition affidavit(s) as may be

necessitated in order to adjudicate the matter in issue in the present case.

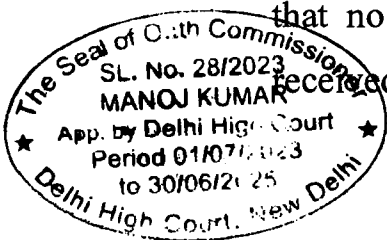


**PRELIMINARY SUBMISSIONS:**

3. That the Applicant in the said Complaint is stated to be the wife of deceased Lt. Sh. Mangat Ram who had died in a fire/ explosion/ blast which occurred in the toilet area of the residential house of the Applicant, B-43, Nand Ram Park, near Sharma Dairy, Uttam Nagar, Delhi on 04.04.2024. The case of the Applicant is that an explosion took place on account of a sewer gas leak from the sewer pipeline into the toilet through reverse pressure and the gas accumulated in large quantities and suddenly caught fire when the deceased had switched on the motor plug. Further, the plea of the Applicant is that the blast was of very high magnitude and the street outside the house under which the sewer line was passing through also burst and caved in.
4. That on the aforesaid basis, the Applicant is seeking to initiate action against the concerned authorities and for grant of appropriate compensation on the basis of the Polluter Pay Principle.
5. It is respectfully submitted that the entire basis of the petition is flawed and the Answering Respondent is not liable to make any payment of compensation on account of any fault on its part.
6. That a Sewer Line had been laid by the Answering Respondent, EE(P) SR-II Division of Delhi Jal Board ["DJB"] with outer diameter 280 mm to 630 mm in the area of Uttam Nagar under the command Waste Water Treatment Plant (WWTP) (STP), Dwarka in 2019 which is being maintained by Answering Respondent i.e., CE (West).



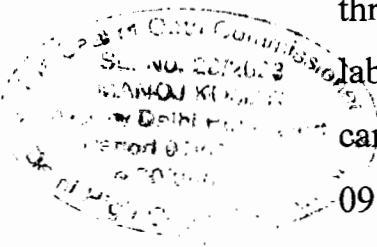
7. That the officials of the Answering Respondent gained knowledge on 04.04.2024 that there has been an incident in the area. Forthwith, the concerned area JE who received the information through local residents promptly visited the site and conducted a thorough inspection of the entire sewer line passing through/catering to the resident's house. Upon inspection, he found that the sewer line was functioning optimally, with no signs of gas accumulation. A copy of the JE's Site Report dated 04.04.2024 is annexed herewith and marked as **Annexure R-1**.
8. It is submitted that the accident had not taken place on account of any fault/ liability of the Answering Respondent and there were no signs of any gas accumulation and no role of DJB's sewer line in the alleged accident. The Polluter Pays principle has no application whatsoever in this case. The explosion may have been caused due to some other reasons such as gas geyser/ emulsion rod, storage of hazardous material/flammable chemical etc.
9. The Answering Respondent has a robust mechanism of responding to any complaint received of blockages or overflow, etc. in the sewer system. A Centralised Complaint Call Centre number i.e. 1916 has been set up on which complaints are received, and are duly forwarded to the area JE for redressal of the complaints amongst other portals like PGMS, etc.,. For the particular area in question, Nand Ram Park, complaints that have been received at the contemporaneous period from January to April 2024 are annexed as **Annexure R-2**. A perusal thereof would show that no complaints in respect to the particular lane were received. As such, there were no complaints of any release



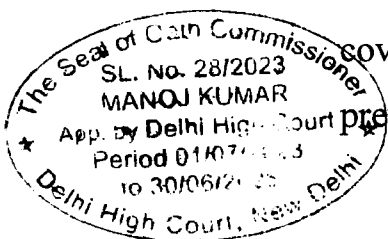
of gases, gas leak, blockage or overflow received from the sewer line in this area. The complaints that were received from the area were duly addressed by the concerned JE.

10. That the Answering Respondent has a established system to carry out routine operation and maintenance of the sewerage system in the said area i.e. in Uttam Nagar Assembly Constituency. The deployed manpower consists of about 17 departmental sewer beldar and 30 hired workers. The sewer maintenance is being done by deploying 10 sewer cleaning machines which consist of desilters, jetting-cum-suction machines of various capacities and also by super sucker machines as per requirement. In addition to above, old and damaged sewer lines/manholes are replaced/repared on contractual basis. Elaborate instructional orders are issued by the Head Office for effective and efficient maintenance of the sewerage system. For instance, Instruction Order No. DJB/Member(Dr)/2021/1369-1385 dated 29.10.2021 titled 'Guidelines for Maintenance of Sewage System' has been issued for regular maintenance of sewer lines of DJB and the sewage system. A copy of Instruction Order No. DJB/Member(Dr)/2021/1369-1385 dated 29.10.2021 is annexed as **Annexure R-3**.

11. As per the Guidelines, an annual action plan for 2024-25 for desilting of the sewerage system was prepared and executed through deployment of sewer cleaning machines and labours. Further, the desilting of peripheral sewer line was carried out on contractual basis vide W.O No. 185 dated 09.03.2024. A copy of the W.O No. 185 dated 09.03.2024 is annexed as **Annexure R-4**.



12. Furthermore, sewage level was monitored through Level Indicators at the sump pumping station located at Bindapur SPS (Jeewan Park), which duly recorded the hourly level record of sewage into the sump to avoid any overflow and take necessary action to stop in case there is any overflow of sewage in the command area.
13. It is submitted that all the above steps are taken in order to run the sewerage system effectively and efficiently without any sewer blockages and sewer overflows.
14. It is submitted that the sewer line of diameter 280 mm OD in the lane in question is interconnected to Peripheral sewer line at Matiyala road and further connected to the SPS located at Binapur, and ultimately outfalls in Dwarka STP. This Peripheral sewer line was functioning optimally at the time and there has been no damage reported of this sewerage system. A map showing the sewage network of the entire area of Uttam Nagar is annexed as **Annexure R-5**. Google Earth Image/Map showing the Peripheral sewer line is annexed as **Annexure R-6**.
15. As a matter of fact, photographs filed by the Applicant herself at Page 25 & 27 of the Original Application show that the residents of the area had illegally punctured the road/ lane to make a hole therein so that accumulated rain water and other accumulated water on the road falls into the DJB sewage network. Such holes are usually made by residents due to the reason that storm water drains in the colony have been unauthorisedly constructed over and blocked on both sides by residents carrying out extra coverage in the form of unauthorised construction. Thus to prevent accumulation of water on the road, holes are

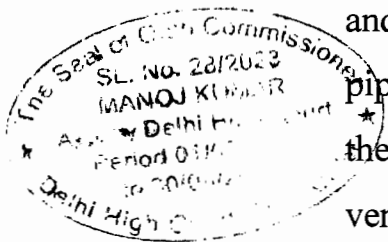


punctured. Be that as it may, the presence of a hole right next to the manhole of DJB shows that had there been any accumulation of gases, there would have been a nauseous smell due to release of gases at this point. However, this was not the case. Ergo, there arises no question of gases travelling through reverse pressure inside the house of the Applicant.

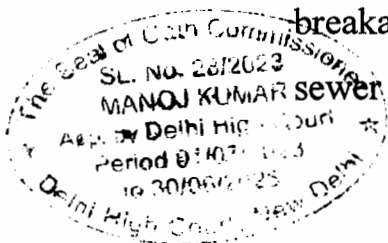
16. That it is further submitted that all toilet seats are to use “**P and S Trap system**” in order to prevent sewer gases from entering the toilet seat. The purpose of this convoluted pipe which is either in S shape or P shape is that water is stored in the pipe/trap so that gases cannot enter the toilet seat through the sewage network under the toilet seat. A diagram of the toilet seat and explanation thereof is annexed as **Annexure R-7**.

17. It is further submitted that there are 8 sewer connections in the manhole, photographs of which have been filed by the Applicant, and from which the Applicant claims that hazardous gases have travelled to her bathroom. It is a matter of record that no other home/ bathroom has made any complaint of nauseous gases releasing from this network/manhole.

18. Additionally, a vent pipe is required to be installed in all homes to release sewer gases, if any, into the atmosphere, and prevent them from entering into any home. This vent pipe is connected to all bathrooms in a home. Therefore, had there been any accumulation of gases the purpose of the vent pipe is to ensure release in the atmosphere. A diagram of an internal sewage network showing vent pipe is annexed as **Annexure R-8**.



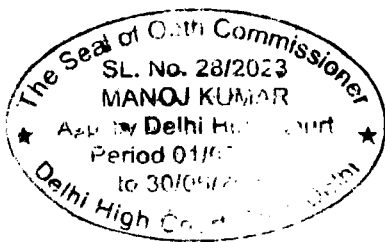
19. That a vent pipe is installed at the Applicant's house so that if there are any sewer gases, the same may be released into the atmosphere via the vent pipe. A photograph of vent shaft installed at Applicant's house is annexed as **Annexure R-9**.
20. It is submitted that sewer gases are produced through anaerobic reaction, which take some time for production after sewerage water is received. If a sewer line is running and there is no blockage present or long standing accumulation of sewage water and waste material then the possibility of gas production is minimal. Sewer gases are produced in significant quantities only in stale, accumulated sewerage water that has been lying such for considerable lengths of time.
21. It is also submitted that no complaints of sewer related issue was received from the deceased person's house.
22. It is reiterated that the DJB regularly maintains the sewage system in running conditions by deploying Manpower & Sewage Cleaning Machines like DICCI, desilter, jetting-cum-suction machines, super sucker machines etc.
23. It is further submitted that post the incident, on inquiry, no blast was found to have occurred outside the house and no DJB sewer line was found damaged. Had there been a blast on account of release of hazardous gases from DJB's sewage network as alleged by the Applicant, it would have led to a blast of large magnitude, that would have caused immense damage, however none was reported. As a matter of fact, the pictures annexed with the Complaint/OA at Annexure A-4 show that there seems to have been deliberate breakage of CC on the road, however there is no damage to sewer line/ manhole or and no indication of a blast.



24. It is further submitted that to the best of the knowledge of the Deponent, no such incident of hazardous gases entering a toilet of a home and causing an explosion as alleged by the Applicant has been reported before.

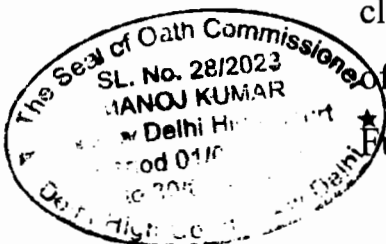
**PARA-WISE REPLY:**

1. That the contents of Paragraph No. 1 are denied in toto as being wrong, false and incorrect and the rest of the contents are denied for want of knowledge. It is submitted that Nand Ram Park is an Unauthorized colony with Regn No. 303 in the List of recognized unauthorized colonies. Reference is made to the contents of the Preliminary Submissions made hereinabove, which are not repeated herein for the sake of brevity.
2. That the contents of Paragraph No.2 are denied, except in so far as are a matter of record.
3. That the contents of Paragraph No. 3 are vehemently denied as being wrong, false and incorrect. Reference is made to the contents of the Preliminary Submissions made hereinabove, which are not repeated herein for the sake of brevity. It is reiterated that had there been a blast on account of release of hazardous gases from DJB's sewage network as alleged by the Applicant, it would have let to a blast of large magnitude which was never reported. As a matter of fact, the pictures annexed with the Application at Annexure A-4 show that there



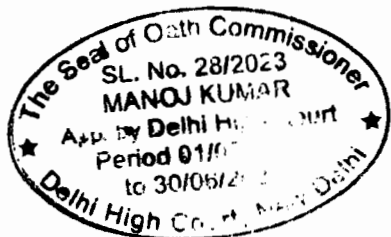
has been deliberate breakage of CC on the road, however there is no damage to sewer line/ manhole.

4. That the contents of Paragraph No. 4 are denied for want of knowledge.
5. That the contents of Paragraph No. 5 are wrong and denied to the extent that no action was taken on behalf of the Answering Respondent. It is reiterated that as soon as the concerned area JE of the Answering Respondent was informed of the said incident, he visited the site and affirmed that there was no issue with the DJB sewer lines. Rest of the contents are denied for want of knowledge.
6. That the contents of Paragraph No. 6 are denied being false and wrong. It is submitted that the Answering Respondent undertakes periodic inspections and maintenance. Reference is made to the contents of the Preliminary Submissions made hereinabove, which are not repeated herein for the sake of brevity.
7. That in response to the contents of Paragraph No. 7 it is submitted that Answering Respondent has issued **Instruction Order No. (Dr)/2021/1369-1385 dated 29.10.2021** titled 'Guidelines for Maintenance of Sewage System' on the steps to follow for regular maintenance of sewer lines of DJB and the sewage system. As per the Guidelines, an annual action plan for desilting of the sewer through deployment of sewer cleaning machine was duly carried out last in the month of April-2024 and vide W.O. No. 185 dated 09.03.2024. Furthermore, in terms thereof, sewage level monitors in



the sump were maintained at the pumping station located at Bindapur SPS (Jeewan Park), which duly recorded the hourly level record of sewage into the sump. In addition, desilting of sump and sewer line was done through super sucker machine on W.O. No. 18 dated 29.06.2022 by E&M Wing of DJB. Regular inspection of manholes for conditional assessment of sewer lines was also done in the area. It is submitted that all the above steps are taken in order to prevent sewer blockages in the internal sewer system. It is further submitted that the area JE undertakes periodic inspections as well as receives complaints and in case there is any complaint regarding any overflow, blockage etc., the Answering Respondent takes action accordingly.

- 8-11. That the contents of Paragraph No. 8-11 are in an entirely different factual situation and cannot be applied *ipso facto* in all situations. Reference is made to the contents of the Preliminary Submissions made hereinabove entailing the facts in the present case.
12. That the contents of Paragraph No. 12 are wrong and vehemently denied. Reference is made to the contents of the Preliminary Submissions made hereinabove, which are not repeated herein for the sake of brevity.
13. That with respect to the contents of Paragraph No. 13, it is submitted that while Hydrogen Sulphide is a hazardous gas, there is nothing to suggest that there was formation of or leak of the said gas in the present case, or that any act or omission on the part of the Answering Respondent led to such explosion/gas leak. Reference is



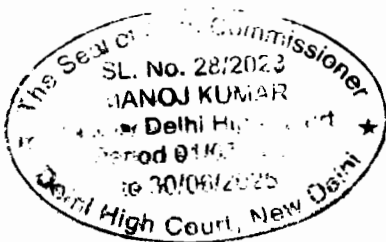
made to the contents of the Preliminary Submissions made hereinabove, which are not repeated herein for the sake of brevity.

14. That the contents of Paragraph No. 14 are wrong and denied to the extent that the Answering Respondent had not taken due care and caution by regularly cleaning and desilting the sewer line. It is reiterated that the Answering Respondent regularly maintains the sewer lines and as and when any issue is reported by the residents, the same is immediately taken care of by the Answering Respondent. Reference is made to the contents of the Preliminary Submissions made hereinabove, which are not repeated herein for the sake of brevity.
15. That the contents of Paragraph No. 15 need no reply.

**REPLY TO GROUNDS:**

A-D That the contents of Ground A-D are wrong, baseless, misleading and are hence denied. The judgements cited have no application to the present case. In reply, the contents of Preliminary submissions and the contents of para wise reply may be read as part and parcel of this para.

E-G That the contents of Ground E-G are a matter of record and hence need no reply.



Reference is made to the Preliminary submissions hereinabove which are not being repeated for the sake of brevity.

PRAYER

In view of the submissions made herein above, it is most humbly prayed that this Hon'ble Court may be pleased to dismiss the present OA with costs.

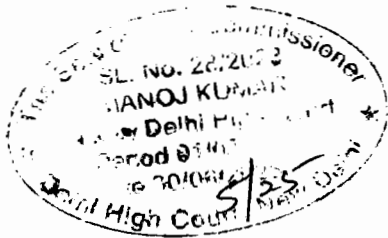

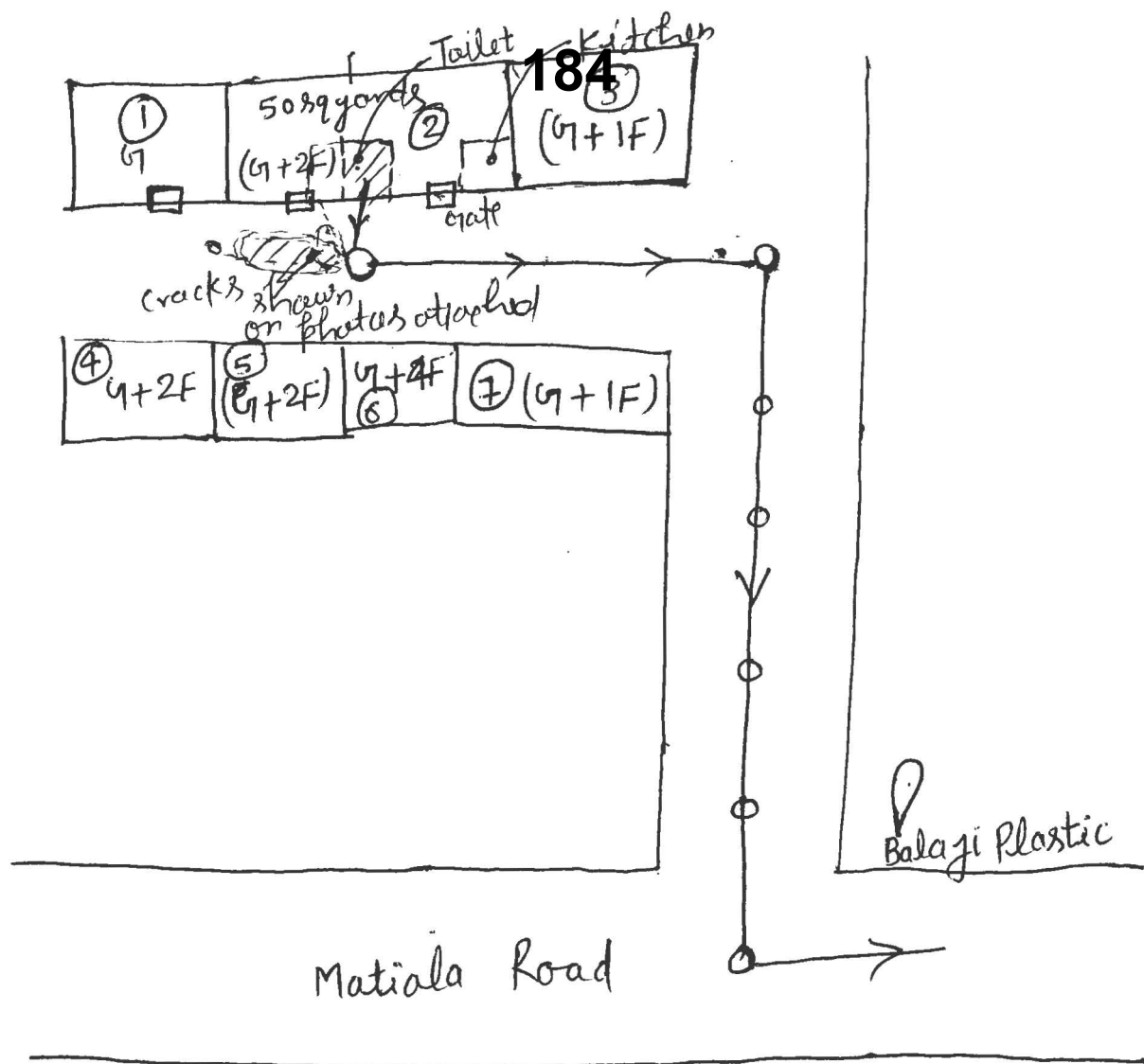



INSTRUCTIONAL ORDER**Guidelines for Maintenance of sewerage system:**

- In order to maintain Sewerage System in proper manner, it is advisable to maintain free fall conditions of Sewage into the sump of Sewage Pumping Stations through round the clock pumping i.e. 24x7. This is ideal situation of Sewerage System wherein possibility of siltation/ blockages is minimum. Free fall condition of sewer line must be ensured at least once in a day. If freefall condition in the sump of pump house is not achieved, the entire Sewerage System will work as a Septic Tank and siltation in sewer system will take place.
- Concerned EEs(Maintenance) should prepare annual action plan for periodical desilting of entire Sewerage System including trunk/ peripheral/ sewer through mechanical means by deployment of *Recycler, Super Sucker and Sewer Cleaning machine*. Desilting of entire sewer system must be carried out once in a year. Concerned ACEs(Maintenance) must ensure compliance of these instructions. After proper desilting CCTV survey report must be kept on record.
- All pumping stations must have sewage level monitor in the sump, which should be clearly visible from all around the premises of SPS. Hourly level record of sewage into the sump has to be maintained. Concerned EE (E&M) has to ensure its compliance and concerned field staff of maintenance should conduct surprise inspections.
- Periodical desilting of sump of SPS preferably through super sucker must be carried out as per the requirement. This may be on monthly

Rehabilitation of sewer lines be carried out through trenchless method to enhance the capacity and their life by 50 years without digging and with least disturbance of public/traffic.

Concerned ACE (Maintenance)/CE(SDW)NW/ACE(P)-3 have to ensure compliance of above instructions within their jurisdictions. CE(Cor.)- II has to coordinate and report.

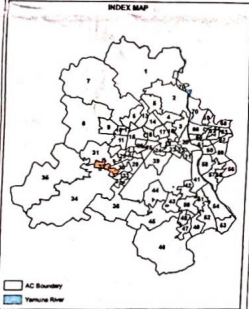

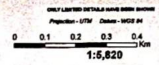
SEWER NETWORK MAP

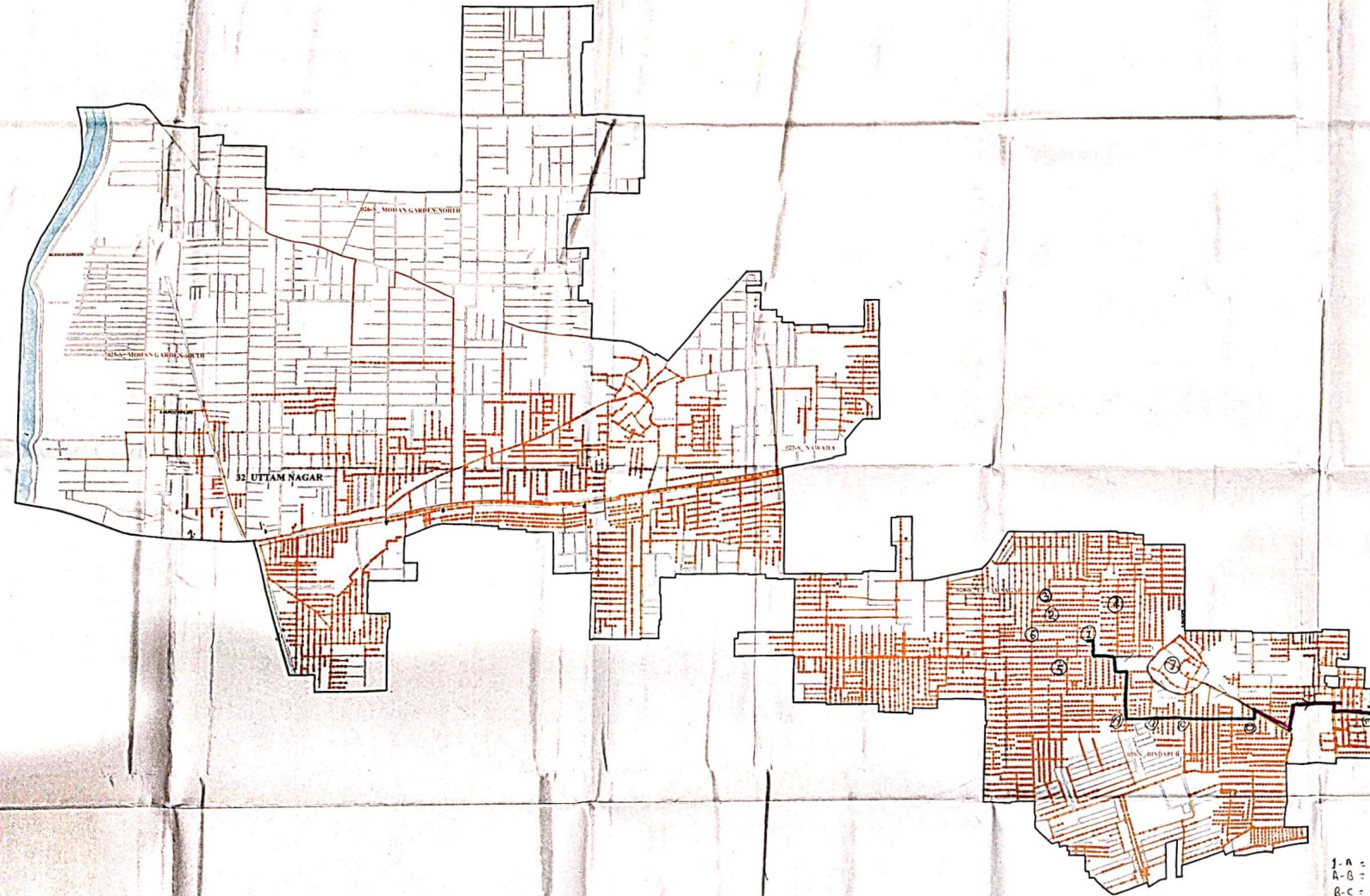

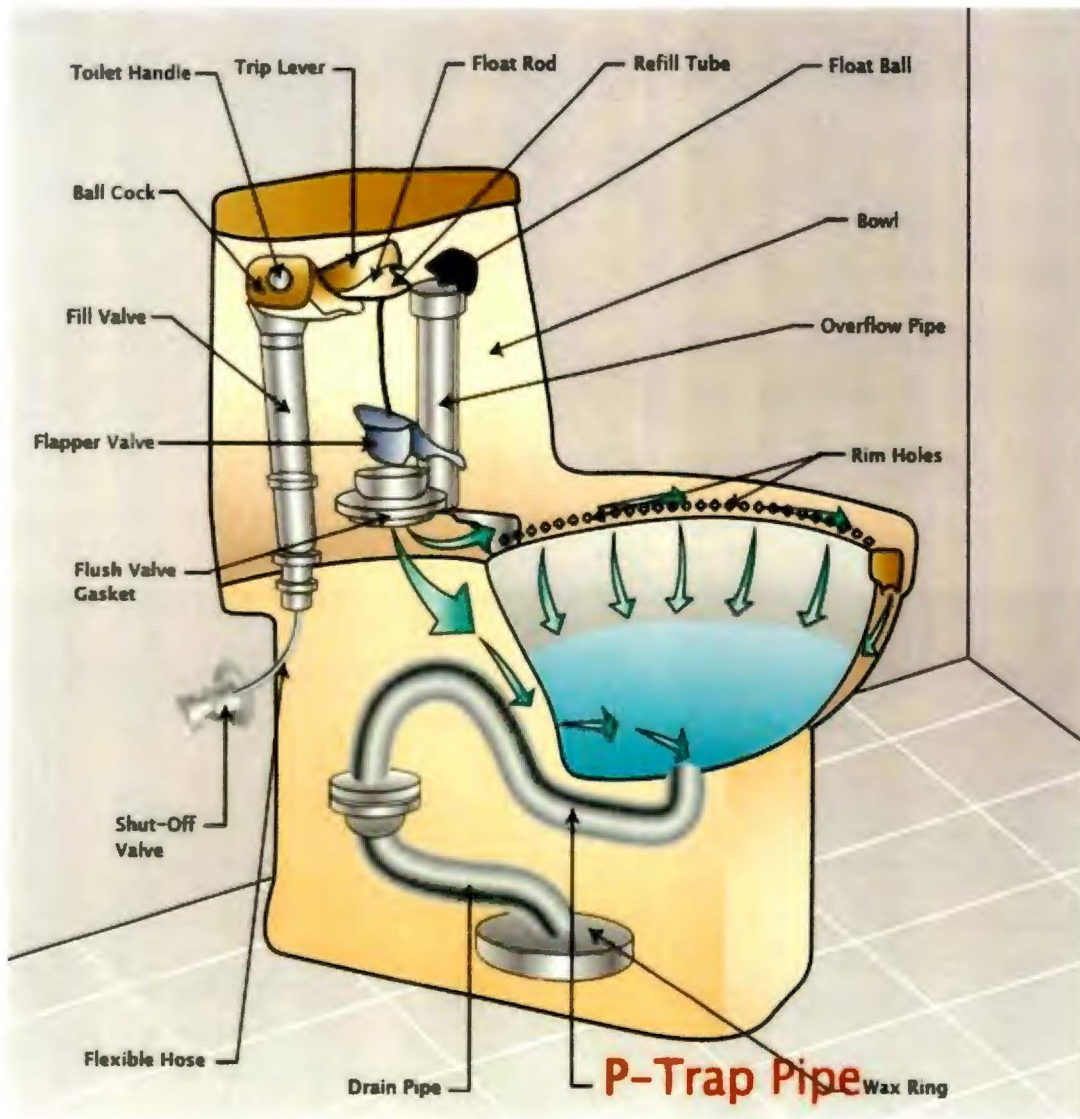

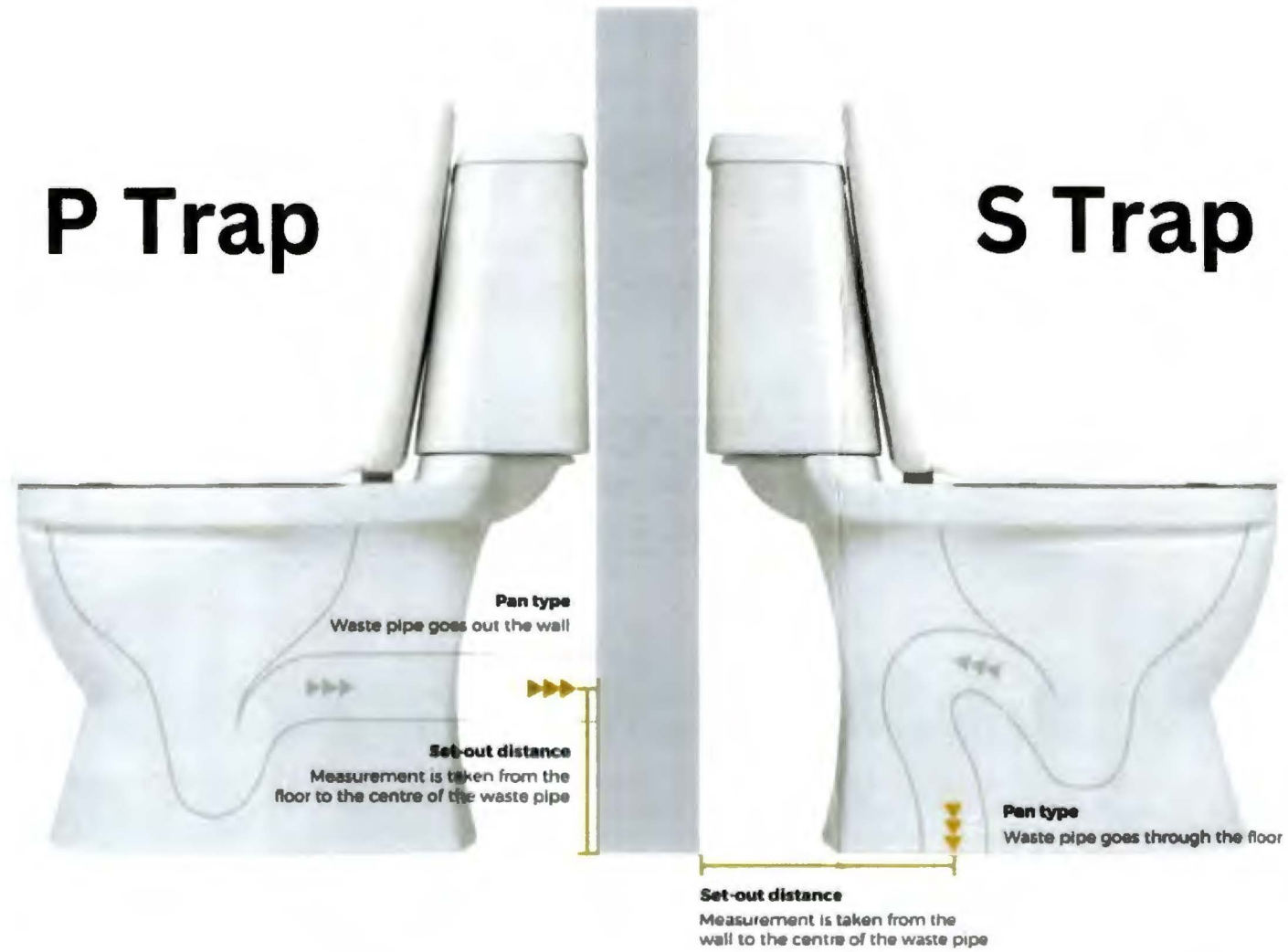
Toilet configurations such as S-traps and P-traps stop foul gasses and water from flowing back into the bowl and your bathroom. They also serve as a filter for debris and other objects that might stop wastewater from flowing through your sewage pipes.

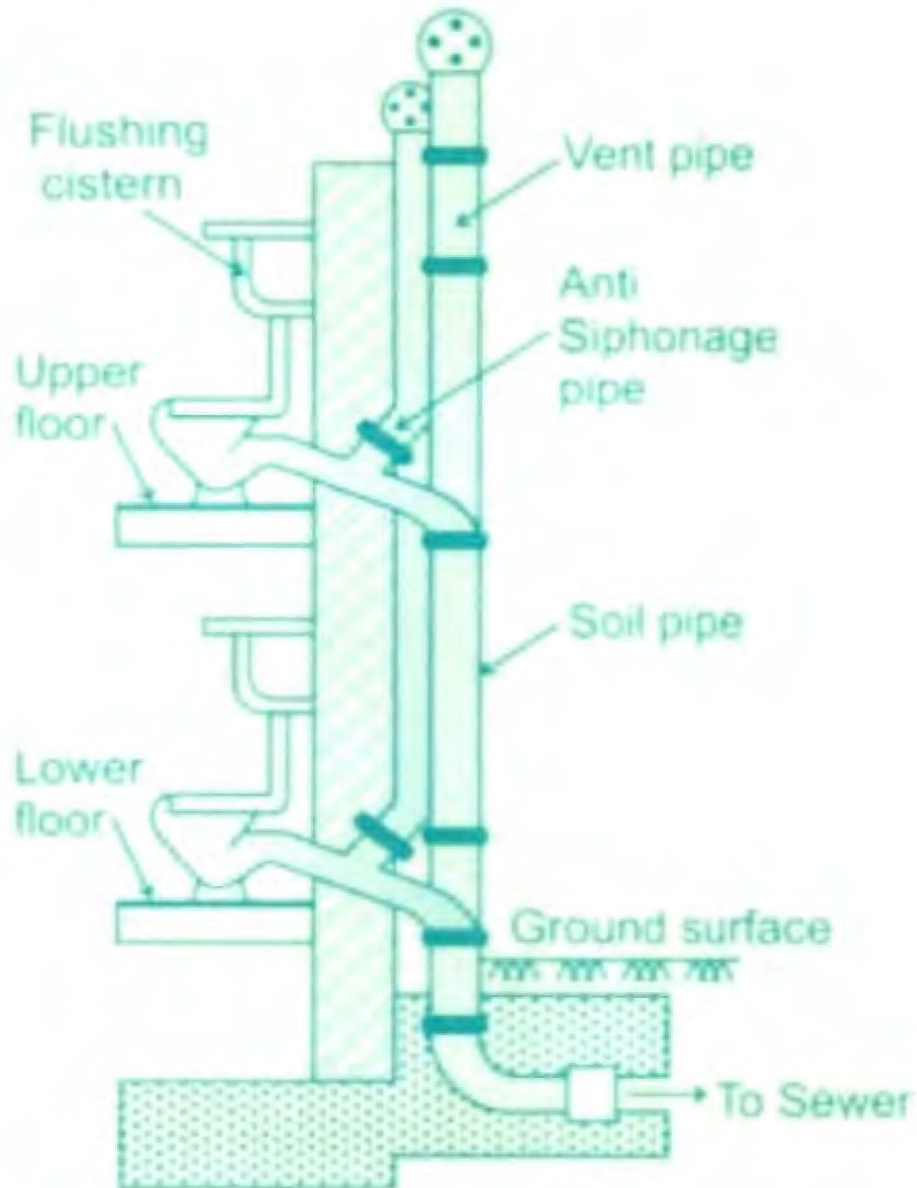


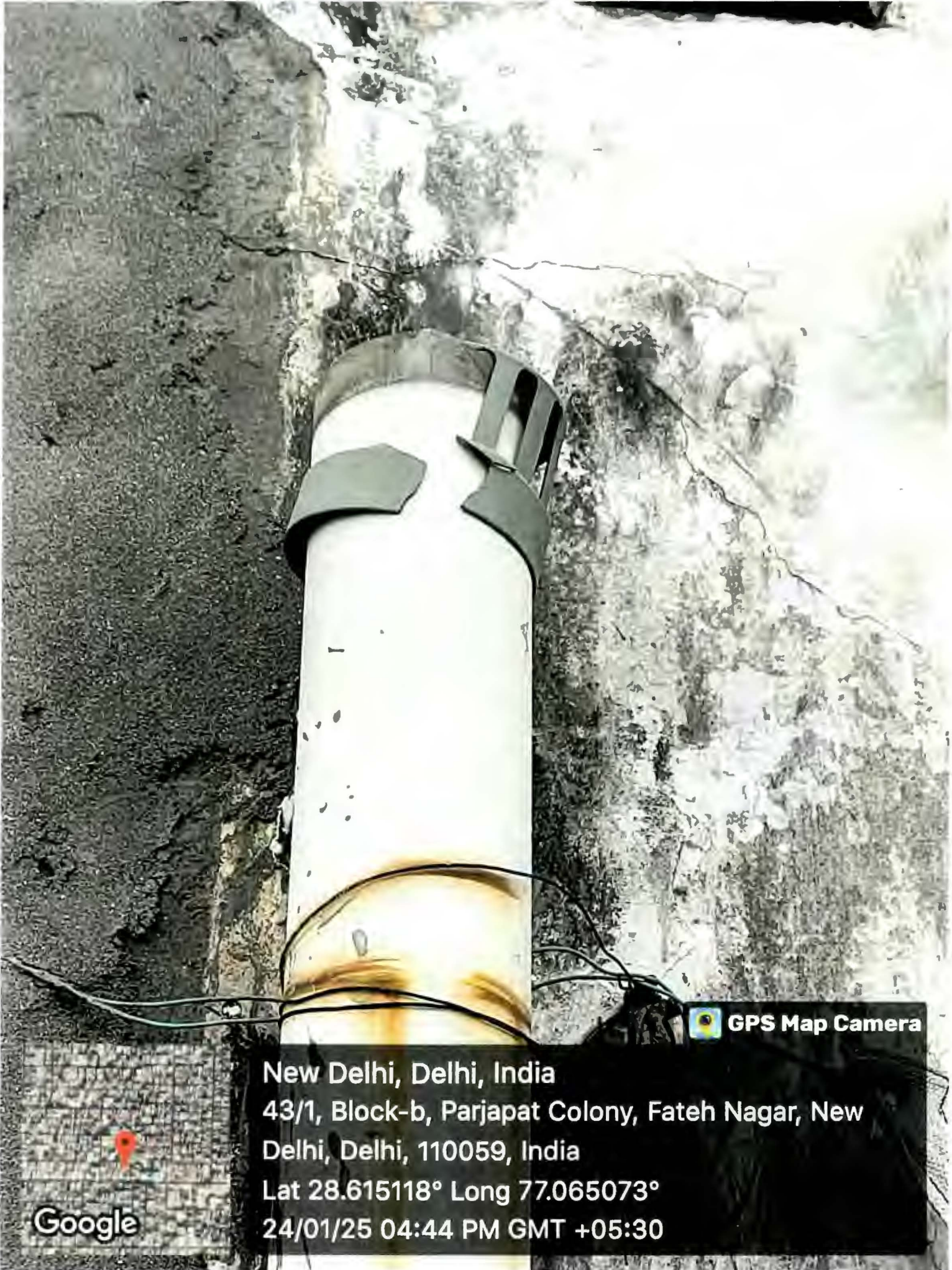
The p-trap pipe is a p-shaped (or arch shaped) piece that attaches to the lines under the toilet. The main purpose of this piece is to prevent sewer gas from rising out of the toilet system and into the home. Inhaling these sewer fumes frequently can cause headaches, nausea, fatigue, and other serious complications, and can even be fatal if inhaled too frequently. These pipes are commonly made of PVC or stainless steel.


In addition to keeping gasses out, these parts also serve other functions as well. This part also traps up dirt and debris. If you notice the toilet is draining out slowly, the p-trap may be clogged. In order to trap and non-waste materials, the p-trap has a small metal filter that captures the waste to avoid it clogging up plumbing. Once it has filled and no longer allows things to pass, the drain must be cleared out (usually with a simple toilet [plunger](#)). For more complicated clogs, the p-trap may have to be removed and replaced. Interestingly enough, the p-trap's filter has also been known to save valuable items from going into sewer lines, like the jewelry, cellphone, or other valuable items you may have accidentally dropped into your toilet.



Vent pipe releases the obnoxious gases from the drainage system, and it is fitted into the soil pipe to protect water seal against siphonage and backflow. It should be of minimum 50 mm in diameter.
