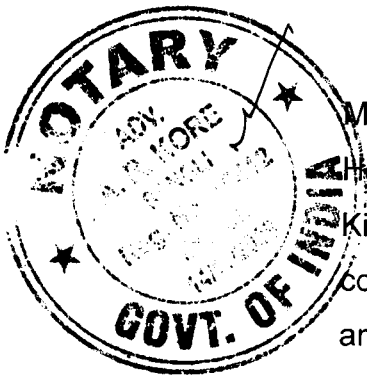

At the time of the Fish Kill industry was not in operation due to the off season. The online continuous effluent monitoring system is connected to the ETP outlet only and does not cover any accidental discharge, including lagoon breakout or other discharge from industry's premises. As such, we cannot rely on it.

At the time of the Fish Kill industry was not in operation due to the off season. The online continuous effluent monitoring system is connected to the ETP outlet only and does not cover any accidental discharge, including lagoon breakout or other discharge from industry's premises. As such, we cannot rely on it. It is evident from the Fish killing incidence for the year 2022 and 2023 the Sugar Unit and Distillery units which are situated at the bank of Krishna river within the radius of 5 -10 Km unauthorizedly discharging effluent outside the factory premises and which flowing through nearby nalla which is ultimately mixed to the Krishna River is responsible for Fish Kill.
