Compliance Status of all Brick Kilns in the Union Territory of Jammu & Kashmir submitted in compliance to Hon'ble National Green Tribunal Order Dated 02-02-2024 in O.A No. 594 / 2022 titled Syed Riyaz V/s Union Territory of J&K and Ors.

Background: -

The Hon'ble National Green Tribunal (NGT) was pleased to pass following directions vide its dated 02-02-2024 in the O.A No. 594/2022 operative part of which is as under: -

“132 brick kilns are operating without consent in contravention of the direction of the Tribunal dated 04.01.2024 wherein concerned officers of J&K PCC were directed to ensure that no brick kiln is set up and operated without obtaining Consent to Establish (CTE) / Consent to Operate (CTO) from J&KPCC and without due compliance of environmental norms.

In the report dated 20.01.2024 nothing has been disclosed as regards the action which has been taken against 132 brick kilns operating without consent. Hence, we deem it proper to issue notice to Principal Secretary, Department of Environment, J&K requiring him to file response disclosing action taken for proper functioning of J&K PCC and

also action taken against the brick kilns which have been set up and are operating without CTE/CTO and without following environmental norms.

Let response be filed by Principal Secretary, Department of Environment, J&K at least one week before the next date of hearing by email at judicial-ngt@gov.in preferably in the form of searchable PDF/ OCR Support PDF and not in the form of Image PDF."

In Compliance to the Hon'ble NGT directions as referred above, the Action Taken against the brick kilns, which have been set up and are operating without CTE/CTO and without following environmental norms is submitted as under: -

1. The updated status of brick kilns in the UT of Jammu and Kashmir is summarised here as under :-

2. That, out of 570 brick kilns in the Union Territory of Jammu and Kashmir, 205 Brick kilns are consented and are in operation with valid consent of the J&K Pollution Control Committee and in remaining 365 brick kilns, there are different categories viz. 122 brick

kilns those who have not obtained Consent and have ordered to be closed by the J&K PCC and in remaining 243 brick kilns there are 238 brick kilns those who have obtained consent earlier but have not renewed their consent under provision of Water/Air Acts have also been closed by the J&K PCC till they get their consents renewed and in 05 cases, consent have been refused for not following norms. It is to mentioned here that all these 243 brick kilns are also ordered to be closed till they renew their consent following environmental norms. The updated status of brick kilns is appended as **Annexure (A)**.

3. That regarding implementation status of closure order, out of 365, closure orders issued in respect of the brick kilns which were operating without consent, 326 closure orders as per the reports of respective Regional Directors and Divisional Officers stands implemented. Remaining 39 brick kilns out of the brick kilns in respect of which closure orders have been issued in first week of April 2024 are in the process of implementation through the respective District Magistrates. However, it is learnt that no brick kiln is currently functional.
4. That the Consent Status of all Brick Kilns of J&K has been uploaded on the website of J&K Pollution Control Committee i.e. <https://jkpcc.nic.net.in> (*Scroll on main page and under information >General information>Public notice>Consent Status of Brick Kilns in UT of J&K*). The status is regularly updated as & when consent is issued/renewed.
5. That, Directions under Section 31 (A) of Air (Prevention and Control of Pollution) Act, 1981 have been issued from time to time to all the District Magistrates (DMs) to ensure that no Brick Kiln is setup and

operated without obtaining mandatory Consent to Establish and Consent to Operate from JK PCC and without due compliance with environmental norms. The latest directions issued to all the District Magistrate as on 01-04-2024 for ensuring that no brick kilns is allowed to operate without having valid consent from J&K Pollution Control Committee. Copies of directions issued to District Magistrates (DMs) are appended as **Annexure 'B'**.

6. That in order to have a proper check and control on the defaulting brick kilns, Divisional Officers J&K PCC have been instructed through respective Regional Director vide letter No. JKPC/NGT/130/719 dated 30-03-2024 to ensure that no Brick kiln in respect of which closure order has been issued is allowed to operate, and in case if any violation is noticed, the Divisional Officer concerned shall immediately report the same to the District Magistrate, Superintendent of Police of the District, Member Secretary. Further, the Divisional Officer shall also ensure filing of the complaint against the occupier of the Brick kiln in the court without any delay. The copy of the instructions issued is appended as **Annexure (C)**
7. That, a Public notice has also been issued in local dailies of J&K for the attention of Brick Kiln owners of J&K to comply strictly with the environmental norms and adhere to the notification GSR 143 (E) Dated 22nd February 2022 issued by MoEF&CC read with notification GSR 895(E) Dated 15th December 2023 which reads as under. Copy of Public notice is appended as **Annexure 'D'**.
 - i) *That, in 10 kms radius of Non-Attainment Cities of Jammu/Srinagar, Brick kilns without Zig-Zag Technology shall not be permitted to operate beyond February 2024.*

- ii) *That, in rest of the area (other than Non-attainment Cities) the Brick Kilns shall be directed to convert to Zig-Zag Technology by or before February 2025.*

Hence the Compliance Report may kindly be taken on record and placed before the Hon'ble NGT for consideration please.

**Sub:- Hon'ble National Green Tribunal Directions in O.A No. 594/2022 titled
Syed Riyaz V/s Union Territory of Jammu and Kashmir.**

J&K Pollution Control Committee has issued directions from time to time for closure of Brick Kilns that were operating without valid consent. Circular instructions have already been issued vide No. JKPCC/PS/MS/23/2256-80 dated 04-12-2023 that District/Divisional Officer shall proceed under the relevant Sections of the Air/Water Act and file complaints in the competent court against the occupiers who fail to comply with the directions issued by J&K Pollution Control Committee.

In view of the above, the following instructions are hereby reiterated:

1. Divisional Officers concerned shall ensure that no Brick Kiln in respect of which closure order has been issued is allowed to operate in violation of the environmental laws in their respective jurisdictions.
2. In case any violation is noticed the Divisional Officer shall immediately report the same to District Magistrate, Superintendent of Police of the District, and Member Secretary J&K PCC. Further, the Divisional Officer shall ensure filing of complaint against the occupier in the court without any delay.
3. In case the Divisional Officers fails to report any instance of violation of J&K PCC directions by any Brick Kiln owner in his jurisdiction, the officers and officials concerned shall be liable to be proceeded against for dereliction of duties.

PUBLIC NOTICE

Kind Attention all Brick Kiln Owners, J&K

The Ministry of Environment, Forests and Climate Change, Government of India vide Notification GSR 143 (E) Dt. 22nd February 2022 read with Notification GSR 895 (E) dated 15th December 2023, has prescribed the following environmental standards for operation of brick kilns under the Environment (Protection) Rules, 1986:

Particulate matter in stack emission	250 mg/Nm ³
Minimum stack height (other than Vertical Shaft Brick Kiln)	
- Kiln capacity less than 30,000 bricks per day	24 m
- Kiln capacity 30,000 bricks per day or more	27m
Minimum stack height (Vertical Shaft Brick Kiln)	
- Kiln capacity less than 30,000 bricks per day	14m (at least 7.5 m from loading platform)
- Kiln capacity 30,000 bricks per day or more	16 m (at least 8.5 m from loading platform)

New brick kilns shall be allowed only with zig-zag technology or vertical shaft or use of piped Natural Gas as fuel in brick making.

Existing brick kilns located within 10 km of non-attainment city boundary (Jammu and Srinagar Municipal Corporation area) must convert to Zig-zag technology/ Vertical shaft technology/ piped natural gas by or before 23 February 2024.

In the rest of the UT of J&K, existing brick kilns must convert to Zig-zag technology/ Vertical shaft technology/ piped natural gas by or before 23 February 2025.

For further details regarding environmental standards pertaining to Brick Kilns, please visit the website of J&K PCC <https://jkpcc.nic.net.in> under Standards> Industry Specific > Brick Kiln.

Further, the Hon'ble National Green Tribunal in OA No 594/2022 titled "Syed Riyaz V/s UT of J&K and Others" in its order dated 04.01.2024 has, *inter alia*, issued the following directions:

"7. All the concerned District Magistrates and the Superintendents of Police in the UT of Jammu and Kashmir are directed to ensure that no brick kiln is set up and operated without obtaining CTE/CTO from JK PCC and without due compliance with environmental norms."

Accordingly, all Brick Kiln owners are advised to adhere to the environmental standards for operation of brick kilns under the Environment (Protection) Rules, 1986, and the directions of Hon'ble National Green Tribunal in the matter.

Violation of prescribed norms is punishable under the Air (Prevention and Control of Pollution) Act, 1981 and the Environmental (Protection) Act 1986.
