


Sub:- Compliance Report against order dated 30/08/2022 of Hon'ble Green Tribunal, New Delhi in the matter of "Rajesh Kumar V/s State of Punjab" Original Application No. 186/2022.

The Hon'ble National Green Tribunal Principal Bench vide order dated 30.08.2022 directed the Punjab Pollution Control Board to disposed off all applications for renewal of authorization under Bio Medical Waste Rules, 2016 of 17 no. HCFs, which did not have valid authorization.

All the 17 HCFs which did not have valid authorization have now been granted authorization under Bio Medical Waste Rules, 2016 and the status of authorization of these HCFs is as below:-
