- i. Ministry of Road Transport and Highways has circulated a draft note for Cabinet on creation of eco-system for scrapping of older vehicles for transition to environment friendly vehicles for inter-Ministerial consultation on 30.10.2019. The comments/inputs received from various Ministries/Departments has been examined and final note for Cabinet is being formulated.
- ii. Draft Guidelines for setting up, authorization and operation of Vehicle Scrapping Centres has been uploaded on MoRTH website vide letter dated 14.10.2019 for public comments. Draft guidelines have been suitably modified in reference to public comments/inputs. Formal notification is to be issued under the Motor Vehicles Act, 1988 after approval of the Cabinet.
