

Most Respectfully Showeth:

1. That during the last date of hearing on 04.09.2025, the Counsel for the Respondent no. 4, submitted that the municipal solid waste lying dumped by the side of Govt. Hospital wall, Gate of Govt Inter College, near DAV College, Pond at Village Kukda has been cleared now and no such waste is lying there.
2. That the Hon'ble Tribunal permitted the Applicant to verify the same and file material in this regard.
3. That in furtherance of the same it is submitted that the Applicant has taken recent photographs from the said locations which shows that at Gate of Govt Inter College and Pond at Village Kukda, the solid waste is still lying there and these points are used as collection points where the waste gets dumped regularly but lifted occasionally.

The photographs showing the solid waste at Gate of Govt Inter College and Pond at Village Kukda are annexed as **ANNEXURE A/1(colly)**.

4. It is further submitted that the wall of the Govt Hospital is still being used as collection point for solid waste. The recent photographs showing the Govt Hospital Wall being used as waste collection points are annexed as **ANNEXURE A/2**.
5. It is submitted that the Respondent no.4 is not taking action on the ground and is trying to mislead the Hon'ble Tribunal by making false submissions.
6. In these circumstances it is prayed before the Hon'ble Tribunal that the above submissions and the material be considered and appropriate directions be issued for removal of the solid waste from the above areas And the Govt Hospital and the Govt Inter College be permanently stopped from being used as dumping ground and the responsibility be fixed upon and action be taken against the erring officials in case of failure to ensure that such sensitive places be not used as dumping ground.




