On the above cited subject, it is submitted that vide order memo no. ZP-261 Vol-II/AD(GK)/2024/11202 dated 01.04.2024 (copy attached) request of applicants for composition of construction of temple (religious building) built in Group Housing Colony namely Piyush Height, Sector 89, Faridabad was refused by HQ. Now, vide letter under reference, directions have been received to this office for re-survey of the said site of temple. The site of said temple has been got visited by this office and the report is as under:-

1. The temple site measuring 125.00 Sqmt. has been constructed in area situated near Tower J in above said colony. However, the area of temple falling under green & open space is difficult to ascertain at site as the shape of green area earmarked near Primary school site is not as per approved layout plan. The tentative location of temple has been shown on the copy of approved layout plan attached herewith.
2. The Primary school site shown in approved layout plan has now been utilized as green area at site after demolition of school building in compliance of the orders dated 18.05.2022 passed by Ministry of Environment, Forest & Climate Change, Govt. of India (copy attached).
