**Interim report of the review committee on review of Private Forest provisionally identified by North and South Goa Forest Division Committees (V.T. Thomas & F.X. Araujo Committee)**

**Introduction**

Hon'ble NGT directed the state Government to constitute a committee and evolve internal mechanism to demarcate private forest areas in each of the land as private forest by Sawant and Karapurkar Committee vide order dated 07/01/2016 in Application No. 18(THC) /2013 (WZ). In pursuance to the aforesaid order, the Government of Goa , vide notification dated 23.04.2018 constituted a committee under DCF (Working Plan) to review identified Forest areas by earlier all committees, simultaneously disbanding the two Forest Division Committees (North and South Goa) also known as Thomas & Araujo committees constituted under Application No. 16(THC)/2013 (later O.A. No. 478/2018). The review committee chaired by DCF (Working Plan) submitted its report on 29.06.2019 reviewing all the areas identified by earlier Sawant & Karapurkar Committee only as per timeline fixed by Hon'ble NGT in O.A. No. 479/18. However, due to paucity of time, the committee did not submit any review report of the areas identified by two Forest Division Committees (North and South Goa) Thomas & Araujo committees.


**Constitution of new review Committee**

A committee (hereinafter referred as Review Committee"), to review Provisionally identified Private Forest areas by North and South Goa Forest Division Committees (also known as Thomas & Araujo Committee) was constituted vide Government of Goa Notification No. (WP)/Pvt. 20/26 dated 21/01/2020 (with Conservator of Forests as Chairman) and Vide Notification No. DCF (WP)/Pvt. Forest/16(THC)/ 2013(WZ)/19-20/119 dated 18/06/2020 (The Chief Conservator of Forests was made the Chairperson). The Composition of the Review Committee is as follows

1. The Chief Conservator of Forests – Chairman
2. Director (survey and Land Records), – Member
3. Director (Agriculture), – Member
4. Additional Collectors (North), – Member
5. Additional Collectors (South), – Member
6. Asst. Conservator of Forests (HQ) (North), – Member
7. Asst. Conservator of Forests (HQ) (South), – Member
8. DCF (Working Plan) – Member Secretary

**Criteria followed by the State of Goa .**

The criteria adopted for identification of Private Forest are as follows:

(i) 75% of the tree composition of such lands should be of Forest species;

(ii) The area should be either contiguous to the Government Forest lands or if in isolation, the minimum area should be 5 ha; and

(iii) Canopy density should not be less than 0.4.

**Methodology adopted and progress made in review**

The two Forest Division Committees (North and South Goa) Thomas & Araujo committees provisionally identified the areas qualifying as private forest based on their field visits only.

Therefore, the Committee proposed the following methodology for reviewing the identified Private forest Areas by two Forest Division Committees (North and South Goa) based on the criteria followed by State of Goa using Forest Cover Maps ( Canopy density > 40% & Area > 5 ha ) from Forest Survey of India followed by field enumeration cum survey & public hearing and same was approved by the Government on 9.3.2020.

**1. Inviting objections/ representations from landowners / affected parties etc .**

The committee invited objections/representation from affected Private Forest Owners on 15.2.2020 by publishing advertisements in local dailies with due date of submission within one month's notice initially. However, due to prevailing COVID conditions, the timeline was extended from time to time to give sufficient time for convenience of affected persons for filing their representations / objections . It has been decided with approval of the Government that considering existing COVID - 19 pandemic conditions, objections received after the due date will also be considered by the Review Committee. Total objections received as on date are 8062 nos..

Data entry, sorting, scrutiny and tabulation of large number of objections received started in March, 2020 and continued till July, 2020. Additional manpower was deployed for scrutiny and tabulation of data during the period considering the huge volume


of information. All the objections have been sorted & tabulated and details of objections are uploaded on the departmental website for public information and also sent to Sub-committees formed in the matter/ North and South Goa Divisions for inviting objectors during field visit for enumeration and survey.

## 2. Digitization of Private Forest Data:-

All the Survey numbers (more than 3195 nos.) included by the two Forest Division Committees (North and South Goa) – Thomas & Araujo Committee were digitized using the Regional Plan of Town & Country Planning Department, Government of Goa and records of Directorate of Survey & Land Records Department. Considering a large number of Survey numbers to be digitised, the work started soon after formation of the review committee in January, 2020, additional manpower trained in digitisation work were deployed for work. Digitisation work was mainly affected due to lockdown and COVID – 19 pandemic conditions. However, with all efforts, 100% digitisation of all survey numbers was completed in September, 2020.

## 3. Superimposing on Forest Cover Maps / Classified image

As a part of approved methodology the review committee in coordination with National Remote Sensing Centre and Forest Survey of India (FSI), a high quality LISS IV Satellite image was specially analysed for preparation of Forest Cover Map as per the Private Forest criteria (*Canopy density & Area criteria*) by Forest Survey of India. Forest Survey of India was consulted on formation of the review committee and approval of methodology. However, due to COVID – 19 related lockdowns FSI could start their work on time effectively and started only in May, 2020. Satellite image of 2014-15 was used as it coincides as the mid term period of working of North and South Goa Divisions (Thomas and Araujo) committees. COVID – 19 lockdown and



restrictions have severely delayed the preparation of special forest cover maps by FSI. The Forest Cover Map ( FCM ) of 2014-15 from FSI could only be received on 15.10.2020.

The Forest Cover Map ( FCM) of 2014-15 prepared by FSI constitutes polygons with more than 40% canopy and area more than 5 Ha and less than 5 Ha, with later analysed for proximity to Government Forest. Digitised Survey numbers of North and South Goa Divisions (Thomas and Araujo )committees have been superimposed on FCM maps/polygons of FSI for analysis.

#### 4. Image interpretations

Pursuant to receipt of FCM from FSI on 15h October, 2020, the interpretation work to analyze all the Survey numbers identified by the two North and South Goa Divisions (Thomas and Araujo )committees started and total work was totally completed by January, 2021, with following results.

- 183 maps are prepared of Survey Numbers qualifying area and canopy criteria (Patch Areas with more than 5 hectare & Canopy density more than 40% ) admeasuring 9138 Ha (91.38sq.km) approximately and sent for ground verification & enumeration by sub-committees under supervision of concerned DCF. (*Sending of maps started simultaneously from end of October, 2020*)
- 27 maps are prepared of survey numbers qualifying area and canopy criteria (Canopy density > 40% & being adjoining Government Forests) measuring 45 Ha (0.45 Sq. Kms) and similarly sent for ground verification & enumeration by sub-committees under supervision of concerned DCF.
- Additional 82 no. of maps primarily with details of Survey Numbers. not meeting the criteria of canopy density and area as per LISS IV FCM of 2014-15, have also been prepared and details were sent to Divisions for seeking

history details regarding felling permission, offences, court cases if any, in those Survey Numbers etc for further analysis including google timeline analysis as per approved methodology.


- After receipt of this information from Divisions, analysis on Google Time Series has been undertaken and corroboration with satellite based Forest Cover Map of FSI for the relevant period was done wherever required.

### 5. Ground Verification

Since out of the three criteria of Private Forests in Goa, the first criteria i.e 75% of the tree composition should be forestry species composition, which cannot be ascertained by using Forest Cover Map / Classified image but though ground verification only. The enumeration of 9183 Ha (91.83 Sq. Km) approximate area is being carried out by 16 Nos. Sub-committee consisting of Range Forest Officers of Forest Department, Inspector of Survey and Land Records, Directorate of Land and Survey Department and Village Talathi of Revenue Department, which are working under direct supervision of concerned territorial DCF.





A. The ground verification and enumeration has commenced from November, 2020 after the end of monsoon and still it is in progress. The sub-committees are inviting objectors, plotting sample plots (5% *sampling intensity*), marking and enumerating trees, preparing reports, preparing maps after survey for area qualifying. Concerned territorial Deputy Conservators of Forest are directly supervising and also providing support of equipment, manpower etc. As on date the teams has completed enumeration of an area of **2417 Ha** and it is anticipated to complete another **1500 Ha** of area before the onset of monsoon. In nearly four and half months of Monsoon period survey and enumeration will not be possible due to continuous heavy rains in the region; Public hearings and disposal of objections will be undertaken during the monsoon period .

B. The owner of the property is being given opportunity to remain present during enumeration and all trees present therein were enumerated. The Division Office/sub-committee have been provided with details of objections filed by the owner to ensure that the objectors are informed to remain present during field survey/ enumeration work.

However, considering the huge tract of land involved, enumeration with 5% sampling intensity method has started (*Similar method adopted by earlier review Committee in its report and the report was accepted by Hon'ble NGT in O.A. No. 479/2018*). However, after conducting a public hearing if objectors are not satisfied with sampling results, they are being provided an opportunity for 100 percent enumeration of the area qualifying as private forests. .

C. The sub-committees through concerned Territorial DCF have to submit the final field survey plan of areas qualifying the species criteria to the Review Committee. They also have to submit the



field enumeration results of areas not qualifying along with details of offence/tree felling permissions etc for taking final decision of such non qualifying survey numbers.

- D. The ground verification is a complex, extensive, time consuming activity, considering the extent of vast area to be verified with varying topography, approachability to the site for undertaking verification, enumeration and survey with actual traverse, due to deployment of 16 teams and more than 50 additional man power to execute the work, the progress is significant. Non availability of sufficient Field Surveyors for actual determination of survey boundaries and also surveying the extent of area qualifying as private forest and plan preparation is hampering the overall progress of review, despite field enumeration being done on war footing. During field verification, a team visits the survey number twice for reconnaissance and for enumeration, surveying & plan preparation and normally it takes 3-4 days to cover an area of 5 ha. Considering the all above constraints, the review has shown significant progress.

#### 6. Disposal of Objections

Based upon the forest cover Map/ Classified image interpretation as well as ground verification report & survey, the Review Committee is hearing the affected persons to dispose of objections received. Considering a very large no. of representations/ objections (more than 8000) it has been decided to hear only with respect to objectors whose area qualifies all the criteria for the area to be identified as Private Forest. At public hearing the objectors, are also given a provision for 100 percent enumeration whose area qualifies all the criteria for the area to be identified as Private Forest and where sampling has been adopted.

7. So far ten meetings of this review committee has taken place on 29.01.2020, 03.02.2020, 10.02.2020, 27.02.2020, 13.07.2020, 18.09.2020 , 06.01.2021, 03.03.2021, 18.03.2021 and 5.4.2021 to monitor, review, & expedite the progress of work. The committee also conducts meetings with sub-committee members (*Range Forest Officers and Member Secretaries and Inspectors of Survey and Land Records*) for monitoring progress and sorting out field issues if any, on a regular basis .

### 8. Time Period

Hon'ble NGT has directed to complete the exercise within three months of its order dated 7.1.2021. In view of the NGT order, considering the huge extent of area for enumeration through FCM analysis (more than 91 Sq Km) and also COVID conditions affecting the work now and hence, the committee has started 5% sampling method of enumeration instead of 100% enumeration. Further, additional manpower have been deployed along with field survey equipments (Two no. additional Total Station Method in addition to existing 7 Nos ) for enumeration, , survey etc. so far field enumeration and survey of more than **2417 Ha** area has been accomplished and enumeration of **another 1500 Ha** is expected before the onset of monsoon, since Goa experiences heavy rain showers during which any field activity of Private forests ground verification cum survey will be restricted and ceased .

Considering all above, around one year (*which includes four and half monsoon months, thus effectively seven and half months of field work*) may be required to complete the work at above rate. This is also the time period provided to the Committee i.e at least 1 year from the date of receipt of high resolution Forest Cover Map (FCM) from Forest Survey of India (FSI) (i.e. 15<sup>th</sup> October, 2020) and excluding the monsoon period, which is expected to

be over by Feb, 2022. Following are the major reasons for requirement of additional time-

- i) Vast area to be surveyed and enumerated (more than 91 Sq.Km)
- ii) Existing manpower with the Department is being utilised for the task who has other functions of forest protection, plantation, nursery maintenance, fire control, attending other assigned works. We have to deploy the manpower without affecting important core functions of protection , afforestation etc.
- iii) There are only eight Surveyors for survey work which is affecting the speed. Though Directorate of Survey and Land Reforms has floated a tender for hiring of Surveyors on outsourcing basis, this process is not yet completed. There are 16 sub committees for field enumeration and only 4 Survey teams (consisting of two surveyors each), thereby Survey of the area qualifying as Private Forests is slow thereby the progress of the review is also affected
- iv) Most of the terrain to be surveyed and enumerated is hilly and undulating, which restricts the pace of work and which needs to be identified physically on ground with the help of Field Surveyors only.
- v) Concerned objector has to be informed in advance and also invited for enumeration. Many times for conveyance of objectors enumeration has to be rescheduled.
- vi) In many places there is public protest/ political opposition to the enumeration exercise also.



- vii) All affected persons are given the opportunity to be heard. Public hearing/ sitting of such a large number of objectors is going to take time.
- viii) Since, every objector is to be given opportunity for 100% enumeration, this is also going to take time.


In view of the directions of Hon'ble NGT and expected time required to finalize the exercise, the committee has decided to submit an interim report based on its decisions taken in the meeting dated 6.1.2021, 03.03.2021, 18.3.2021 and 5.4.2021 which are reproduced below.

**A. Survey Numbers identified as Private Forest by Sawant and Karapurkar committees and found repeated in Thomas & Araujo Committee :**

It has been already decided that Sy No. identified as Private Forest by Sawant and Karapurkar committees and found repeated in Thomas & Araujo Committee are not to be reviewed as another Review committee headed by DCF ( WP) has already reviewed it and report accepted by Hon'ble NGT in its order dated 18.08.2020. There are total 130 such survey numbers across 39 villages were analysed and out of which 88 have already been completely reviewed and remaining 42 S. Nos along with its 56 parts needs to be reviewed as they were not in the scope of earlier reviewed committee and were not reviewed earlier . **(Annexure I).**

**B. Survey Numbers identified as Private Forest by earlier demarcation team of Forest Department:**

A total of 39 Survey numbers were demarcated as Private Forests by earlier demarcation team of Forest Department


during 2003-2008 and the same has been subsequently identified by North and South Goa Divisions (Thomas and Araujo ). Since these survey numbers have already been reviewed by earlier Review Committee under the DCF (WP) and also accepted by Hon'ble NGT as a Forest in 46.11 sq. km. area. After detail discussion it was decided by the Committee that in 39 adjoining survey numbers except Sy. No. 25 and 101 of Keri (Sattari), where full survey number is repeated and are not to be reviewed, the undemarcated area of remaining 37 survey numbers will be reviewed by this Review Committee. **(Annexure II)**

**C. Survey Numbers recorded as Government Forests :**

Further, there are total 26 survey numbers of recorded Forest which have been identified as Private Forest by Thomas & Araujo Committee in its report. It was decided to exclude survey numbers pertaining to Reserve Forest and to review Proposed Reserve Forest and Unclassified Forest under private ownership (*If any*) in the instant case for further analysis. **(Annexure III)**

**D. Survey numbers not qualifying Area & Canopy Density Criteria :**

The Committee also undertook the Review of 747 survey numbers not meeting area & Canopy density criteria as per LISS IV Forest Cover Map 2014-15 (Forest Survey India) and based on the analysis of LISS IV Forest Cover Map 2014-15 (Forest Survey India , Google Timeline changes corroborated by LISS III Forest Cover Map 2012-13, North & South Goa Divisional history for offence cases, illegal felling, Tree Felling

permissions , FCA & Court orders (if any) etc. and balance area are under review. After detailed discussion and deliberations the committee decided these survey numbers are not qualifying the criteria to be identified as Private Forests.




**E. Report based on Enumeration results of Survey numbers fulfilling area and canopy criteria.**

An extensive ground verification, enumeration & survey exercise of qualifying Area and canopy criteria has been initiated since November 2020, to evaluate the Tree composition criteria. Based on the field analysis report following status of review work is as below (As on 10.04.2021)



9. Accordingly, an interim report is submitted to the Government with the status as indicated in the Annexures .
- A. With this interim report out of around 3200 total survey numbers provisionally identified as Private forest by North & South Goa Division Committees around 860 survey numbers are fully disposed off and around another 100 are partly disposed off.
- B. The ground verification, enumeration & survey of qualified survey numbers, about **2417** hectares have been completed as on 10.04.2021 and before the start of Monsoon another 1500 hectares is anticipated, balance area (around 5000 Ha) is to be verified, surveyed & demarcated on ground for which additional time is essential as indicated in para 8 above.
