**Report of M/s Indian Potash Limited (Titawi Sugar Complex), Titawi, Muzaffarnagar in reference to the directions issued in NGT O.A. No. 369/2022 Sachin Tomer Vs State of U.P.**

Hon'ble NGT order dated 24.05.2022 issued the following directions in O.A. No. 369/2022 Sachin Tomer Vs State of U.P.

*"2. The allegations made in the letter petition require due verification and immediate remedial action. Accordingly, we constitute a Joint Committee of CPCB, State PCB and District Magistrate, Muzaffarnagar and direct the Joint Committee to meet within four weeks and undertake site visits, look into the grievances of the applicant and take requisite action by following due process of law. The State PCB will be the Nodal agency for coordination and compliance. Factual and action taken report may be furnished within two months by e-mail at [judicial-ngt@gov.in](mailto:judicial-ngt@gov.in) preferably in the form of searchable PDF/OCR Support PDF and not in the form of Image PDF."*

The industry Indian Potash Limited (Titawi Sugar Complex), Titawi, Muzaffarnagar had shut down its operation and ended the crushing season on dated 22.05.2022. The industry has submitted the letter dated 23.05.2022 which is annexed as **Annexure-1**.

As the industry is not operational presently, the efficacy of installed pollution control systems cannot be verified. In view of this, the committee recommends that the inspection of industry may be carried out once the crushing season 2022-23 starts.

The report is submitted for perusal and further necessary action.
