

**JOINT COMMITTEE REPORT AS PER THE ORDER OF THE HON'BLE NGT
COURT August 05, 2025 IN SUMOTO DY No. 270413801409 Of 2025**

Background:-

Hon'ble NGT Order Dated 5/8/2025 in Dy. No. 270413801409 pertaining to unauthorized dumping of garbage in the office premises at New Administrative Building, "B" Wing adjacent to Parmar Tower, Camp, Pune.

At the time of hearing dtd. 5/8/2025- Hon'ble NGT has directed that:-
"Committee comprising the Executive Engineer, Public Works Department (PWD), the Regional Officer, Maharashtra Pollution Control Board (MPCB), in person along with a representative each of the Commissioner, Pune Municipal Corporation and District Collector, Pune to visit the site in question and recommend time bound action plan along with the names of the persons responsible for implementation of the same and enforcement of proper collection of the solid waste from the site in question". The Regional Officer, MPCB shall be the Coordinating Agency of the said Committee. A report of the said Committee shall be submitted by the Regional Officer, MPCB, being the Coordinating Agency of the Committee, before us within two weeks.

Accordingly in compliance with the Hon'ble NGT order dtd. 5/8/2025- Regional Officer, MPC Board Pune has conducted meeting for initial discussion and to decide line of action on 14th August 2025 at Chamber of Regional Office, MPC Board, Pune. During meeting Regional Officer, Pune has directed to PMC authority to submit Progress report as per Hon'ble NGT order. PMC authority has submitted report.

In compliance with the Hon'ble NGT order dtd. 5/8/2025 the joint Inspection has been carried out by Officials of Public Works Department (PWD), Pune Municipal Corporation and District Collector, Pune and Maharashtra Pollution Control Board on 20/8/2025 at 11:00 AM to New Administrative Building, "B" Wing adjacent to Parmar Tower, Camp, Pune.

At the time of joint committee visit the following points observed:-

- 1) Firstly, joint committee members visited at Hon'ble NGT office Pune and meet with Shri. Shriprasad Oza, District Judge Hon'ble NGT court, Pune. Hon'ble Judge point out that regular dumping of garbage in the Hon'ble NGT office premises at New Administrative Building, "B" Wing adjacent to Parmar Tower, Camp, Pune.
- 2) Public Works Department (PWD) Officials stated that – We have appointed agency namely M/s. Sagar Services, Pune for collection of solid waste generated in the premises of new administrative building, Hon'ble NGT, Pune.
Also, at time of visit Mr. Sagar Gaikwad from agency available at site. After due deliberate discussion joint committee instructed agency to provide separate bins for dry & wet waste collection & after collection of waste same shall be regularly dispose to PMC authority for further treatment.
- 3) During joint committee visit no garbage/ solid waste found dumped in premises at New Administrative Building, "B" Wing adjacent to Parmar Tower, Camp, Pune.

Recommendations: -

PWD authority should provide separate bins for dry & wet waste collection at New Administrative Building, "B" Wing adjacent to Parmar Tower, Camp, Pune & after collection of waste same shall be regularly hand over to PMC authority for further treatment/ disposal.

PMC authority shall regularly ^{dispose} the dry & wet waste generated in the premises of New Administrative Building adjacent to Parmar Tower, Camp, Pune.
