**STATUS REPORT OF ACTION TAKEN BY WAY OF
AFFIDAVIT ON BEHALF OF RESPONDENT, NORTH, DMC.**

I, Himanshu Gupta, Deputy Commissioner, Karol Bagh Zone do hereby solemnly affirm and declare as under:-

1. That at present I am working as Deputy Commissioner, Karol Bagh Zone and being conversant with the facts and circumstances of the case competent to swear this affidavit.
2. That in compliance of direction issued by this Hon'ble Tribunal vide order dt. 27.11.2020, it stated that at the site in question the garbage are being cleaned by North DMC two times on daily basis.

3. That in order to ensure the regular removal of garbage from the colonies and the dhalaos/collection sites to the SLF sites, the Karol Bagh Zone has hired the services of M/s Metro Waste Handling Pvt. Ltd. It is submitted that the said company is responsible and accountable that the said sites are regularly cleaned and no garbage is left at the dhalaos etc. The said company is also responsible for door-door to collection, at source segregation. It is submitted that the DEMS department monitors the work of the said agency and whenever any negligence or lapse is noticed on its part, necessary action is taken in terms of the contract. However, DEMS department, Karol Bagh Zone also process the garbage from waste to compost, in this regard, a compost plant is located Near Sir Ganga Ram Hospital, Old Rajinder Nagar. There are also various pits which manufacture compost from Mpl. Waste, the list of which is enclosed herewith *as Annexure-A.*

4. That in order to ensure proper sanitization from time to time and timely uplifting of the garbage from dhalaos, the DEMS department, Karol Bagh Zone has written various letter to M/s Metro Waste Handling Pvt. Ltd to adhere to the terms of the contract, that, some of which are enclosed herewith as Annexure *B.*


- 5. That the garbage/sludge is being removed, transported and disposed of from the site in question in scientific manner and in accordance with the MSW Rule, 2016.


As per direction issued by the Respected DC/KBZ that:




