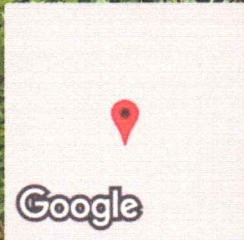
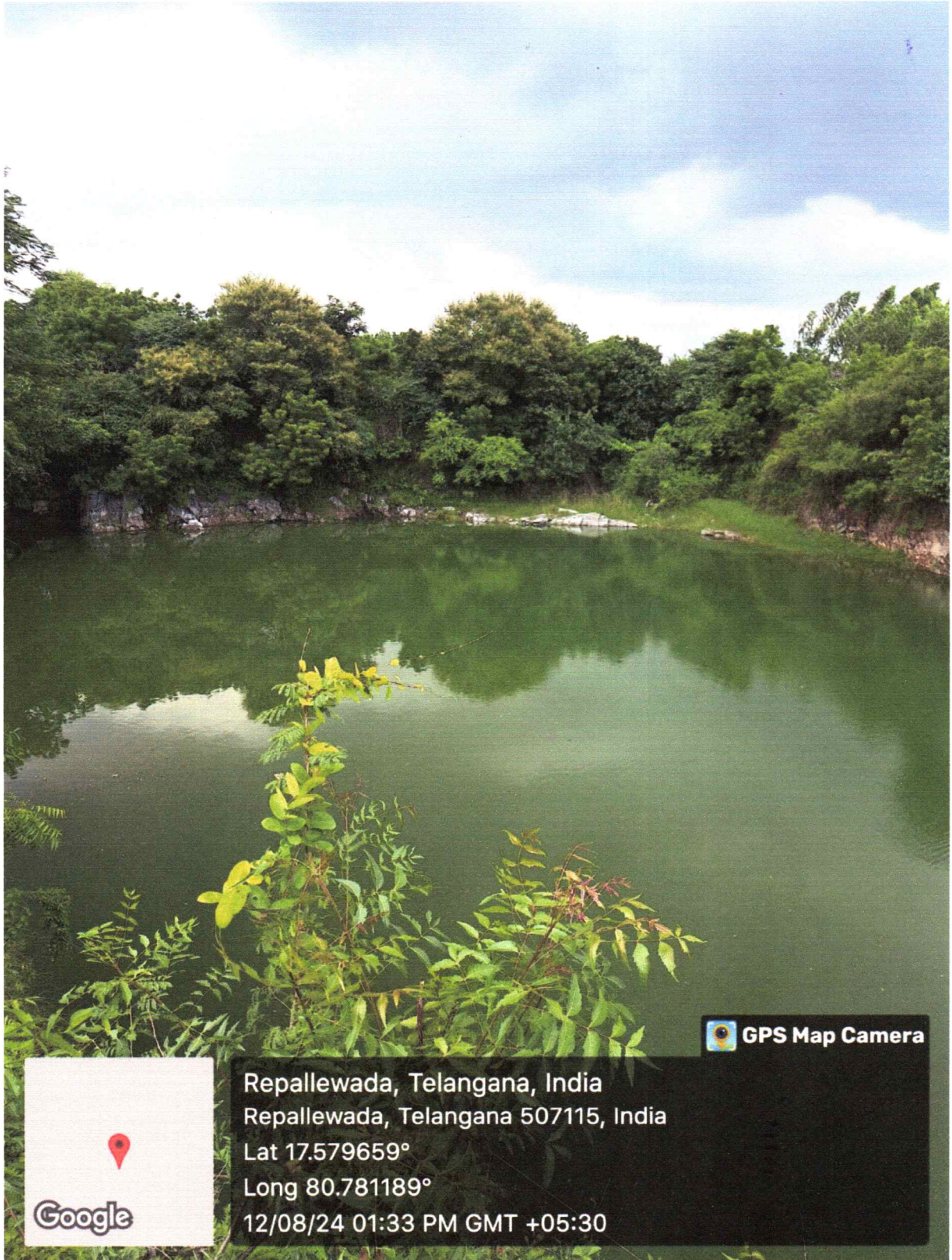
operations are filled with water and due to Heavy rains the mining operations are stopped and related images are annexed below.
