**STATUS REPORT FILED ON BEHALF OF 3<sup>rd</sup> RESPONDENT**

I, KUTHALINGAM S/o. SWAMY VIVEKANANTHAN Aged 43 Yrs serving as Deputy Commissioner of Police, Theyagaraya Nagar District, T-Nagar, Chennai do hereby humbly submit as follows:

1. The Applicant has filed the present Original application at this Hon'ble tribunal on 27.05.2024 for Reliefs against the 1<sup>st</sup> Respondent to Halt the construction at Door No. 115, Sir Thyagaraya Road T-Nagar, Chennai till the other respondent certify the same, and for payment of Compensation of Rupees Ten Lakhs for the loss of sleep, disturbance and long term repercussions on his health caused by the noise and air pollution by the 1<sup>st</sup> Respondent M/s. APA Hotels Pvt Ltd during the prohibited time of 10PM to 6AM.
2. As on 10.05.2024, it was informed by our Counsel regarding the above said Application and to monitor the activities in and around the construction area. Parallely, a complaint Dt. 11.05.2024 was also received by the Deputy Commissioner of Police, Theyagaraya Nagar District and forwarded for necessary action to the Office of Assistant Commissioner of Police, Teynampet Range Dt. 13.05.2024 vide **C.No.40/DC-TNR/I-Petition/2024**. Accordingly, a TN Police Patta book was installed near to the construction site.

3. It is stated that, the authorized person for M/s. APA Hotels Pvt Ltd., has attended before the Inspector of Police on 25.05.2024 for enquiry against the online complaint tendered by the Residents and submitted in writing that they have not violated any approvals contemplated either in the Planning permission issued by the CMDA or TNPCB or Commissioner of Police and also this Hon'ble tribunals orders Dt.22.05.2024 that the movement of heavy vehicles and blaring lights that disturbs the residents were avoided and carried on only during the permitted hours (day time).
4. It is stated that from the date of installing the TN Police Patta book, our personnel has been monitoring the activities for any mishap or commotion created by either parties and in particularly M/s. APA Hotels Pvt Ltd., for any violation.
5. It is stated that our personnel are on constant vigil thrice in a day on active duty and monitoring for any law and order situation and for any possible violation so that there is no public disorder in the concerned area.

Hence this Hon'ble Tribunal may be pleased to accept this status report and pass such further order which deem fit and proper for the case and thus render justice.
