On October 8, 2023, at 9.30 am, the fire caught the attention of the locals in the West Hill plant where waste is collected as part of the Kozhikode Corporation's cleaning. The fire burned on the eastern (backside) side of the plant. Then the fire started to spread. The 11 KV line passes near the building along the back side of the the plant and a transformer is operating nearby. As an army rally was going on near the said place, soldiers and some locals were the first to reach and engage in rescue operations. Then Beach Fire Force arrived based on the information given at Vellayil Police Station and Beach Fire Force. But the fire was not brought under control. So more fire forces arrived from Vellimadukunnu, Narikuni, Koyilandi, Meenchantha, Mukkam, Perambra and other places in

called Kerala Envio Infrastructure Limited operating in Ambalamed, Kochi for the scientific treatment. At present all the waste from the site of the West Hill plant has been removed and recovered. Currently the police have registered a case and are investigating, but the reason for fire is not clear yet.
