

REPLY ON BEHALF OF RESPONDENT NO.1
AND 2 THROUGH REGIONAL OFFICER,
HARYANA STATE POLLUTION CONTROL
BOARD, GURUGRAM REGION (S).

MOST RESPECTFULLY SHOWETH:

1. The above mentioned original application is pending before this Hon'ble Tribunal and now is fixed for hearing on 21.05.2025.
2. That present reply is being filed through Krishan Kumar, Regional Officer, Haryana State Pollution Control Board, Gurugram (South) who is authorised to file the same on behalf of answering respondents.
3. That before proceeding further, it is appropriate to mention here that in compliance of the directions of Hon'ble Tribunal in the present case as well as in other cases, State Government of Haryana is determined to take appropriate step to prevent pollution by following environmental laws and also determined to restore the environmental degradation, having already been caused by the violators, in the State of Haryana by appropriate use of Environment Compensation as per



directions passed by this Hon'ble Tribunal to achieve the objects of environmental laws in true spirit.

4. That a perusal of OA No. 1379 of 2024 filed before this Hon'ble Tribunal categorically reflects that there is a need to submit before this Hon'ble Tribunal with regard to the aspects of the imposition of environment compensation, recovery of environment compensation, utilization of environment compensation. For the better understanding submissions are made under separate headings as following:-

Imposition of Environment Compensation

5. That it is appropriate to mention brief background related to emergence of methodology of imposing environment compensation. This Hon'ble Tribunal in OA No. 593/2017 (WP (CIVIL) No. 375/2012, Paryavaran Suraksha Samiti & Anr. Vs. Union of India & Ors. issued direction to Central Pollution Control Board (CPCB) in the term, "*the CPCB may take penal action for failure, if any, against those accountable for setting up and maintaining STPs, CETPs and ETPs. CPCB may also assess and recover compensation for damage to the environment and said fund may be kept in a separate account and utilized in terms of an action plan for protection of the environment. Such action plan may be prepared by the CPCB within three months*"

On the directions dated 03.08.2018 of this Hon'ble Tribunal in above mentioned OA, CPCB had prepared Methodology for Assessing



Environmental Compensation and the same was accepted by this Hon'ble Tribunal vide orders dated 28.08.2019.

It is also necessary to mention here that the Central Pollution Control Board vide letter dated 10.04.2019 circulated record notes of discussion and decision taken in 63rd Conference of Chairman and Member Secretary of PCBs/Committees held on 18.03.2019, wherein it was decided that SPCBs/PCCs may frame their guidelines on Environmental Compensation based on CPCB's report.

Accordingly, HSPCB decided to adopt the modalities/methodology for assessing, imposing and utilization of environmental compensation from the polluting units in the State of Haryana.

After receiving various representations, those were examined by the Technical Advisory Committee.

It is necessary to mention here that keeping in view of the abovementioned background the policy for imposition of environmental compensation was prepared and issued by HSPCB vide order dated 22.12.2021. Further, it is not out of place to mention here that in compliance of directions of this Hon'ble Tribunal amount of environment compensation deposited with HSPCB has been kept under separate head.

Utilization of Environment Compensation

7. That it is worthwhile to mention here that the Government of Haryana has constituted a High Powered Committee (HPC) consisting of



Additional Chief Secretary to Government Haryana, Industries & Commerce Department, Additional Chief Secretary to Government Haryana, Environment, Forest and Wild Life Department, Additional Chief Secretary to Govt. Haryana, Public Health Engineering Department, Commissioner & Secretary to Government Haryana, Urban Local Bodies Department and Director General, Environment and Climate Change, for process of planning and execution of environment compensation funds and compensation deposited with the State PCBs/PCCs And also other regulators such as SEIAAs, Water Resource Authorities etc. The details of amount sanctioned by HPC to the Deputy Commissioner concerned are given below:-

It is also appropriate to mention here that proposals submitted by the Deputy Commissioners of Ambala, Jind and Rewari shall be considered in meeting of HPC scheduled for 20.05.2025.

Recovery of Environment Compensation

8. It is necessary to bring into notice of this Hon'ble Tribunal that HSPCB has framed a policy for taking action in case failure to deposit Environmental Compensation. As per policy, details of action to be taken are given as under:-
- a. EC imposed will need to be deposited by the Project Proponent at concerned Regional Offices within a period of 30 days from issue of directions. In case of failure to deposit EC amount within 30 days, concerned RO will follow up with defaulting unit and issue show cause notice intimating the further course of action proposed to taken.
 - b. The cases of new/renewal of CTO, suspension of closure order of the defaulting unit shall not be entertained until and unless the EC is deposited.
 - c. In case PP fails to deposit EC after expiry of six months, the concerned RO shall request to concern Deputy Commissioner to recover the EC amount in accordance with the provisions of the Haryana Land Revenue Act or any other Act for the time being in force for recovery as arrears of land revenue.



9. That further, keeping in view of the subject matter involved in the present OA, it is also appropriate to mention here that in many cases, environment compensation has already been recovered from the violators and the process of recovery is still going on. The current details upto 31.03.2025 of imposition and recovery of Environment Compensation is given as under:-

10. That in addition to the above, it is necessary to mention here that in some of the cases Environment Compensation was/is imposed on the violators operating the units without obtaining mandatory consent to establish (CTE) and/or consent to operate (CTO) and after issuance of closure order, owner/occupier of the such units run away by leaving the rented premises or the premises occupied by them illegally on the Government/other land and in such cases the orders of environment compensation issued by HSPCB not delivered to the concerned and resultantly the process for recovery of environment compensation cannot be initiated against such violators. It is also necessary to mention here that such kind of tiny units as mentioned above are usually operating in small spaces or in an open space occupied by



them illegally. It is also necessary to mention here that apart from the above, hardship is being faced to recover environment compensation, wherein owner/occupier of the unit runs away. It is also necessary to bring into the notice of this Hon'ble Tribunal that there is no policy/scheme to settle/write of the environment compensation of the units mentioned above and thus it remains stand in the amount to be recovered.

11. That list of individual units which failed to deposit the Environment Compensation is attached herewith as **ANNEXURE-R/1**. If this Hon'ble Tribunal thinks fit, units which fail to deposit the Environment Compensation may be impleaded in the present proceedings as respondents.
12. That it is also worthwhile to mention here that the policy for imposition of environmental compensation has been framed in pursuance of the order of this Hon'ble Tribunal in OA No. 593/2017 (WP (CIVIL) No. 375/2012), Paryavaran Suraksha Samiti &Anr. Vs. Union of India & Ors. as mentioned in the preceding para no. 5. It is also necessary to bring into kind notice of this Hon'ble Tribunal that due to absence of any statutory backup for imposition and recovery of Environmental Compensation, it is humbly prayed to this Hon'ble Tribunal to implead the defaulter units and to initiate the action against them for recovery of the Environmental Compensation.

In view of the submissions made above, it is humbly prayed that present reply may kindly be taken on record for kind consideration of this Hon'ble Tribunal.
