"Since the borewells already identified to be illegal are still remaining to be sealed, the CEO, DJB and all the Deputy Commissioner (Revenue)/District Magistrate in NCT of Delhi are directed to file further compliance report by 15.05.2025."

3. That the District Magistrate (South) has taken all necessary and appropriate steps to ensure compliance with the directions issued by this Hon'ble Tribunal in the present matter.
