उल्लेखित ग्रामों दोस्तपुर मंगरौली खादर, चकमगरौला, असदुल्लापुर, छपरौली खादर, नगली बहरामपुर उपरोक्त ग्राम गैर आबाद डूब क्षेत्र के अर्न्तगत आते हैं एवं आबाद ग्राम नगली नगला की भूमि बांध के दोनो तरफ है जिसमें बांध से डूब क्षेत्र की तरफ फार्म हाउस बने हुए हैं। उक्त डूब क्षेत्र के ग्रामों में याचिकाकर्ताओ की भूमि/फार्म हाउस बने हैं। सिचाई विभाग का बाध/पुस्ता बने होने के कारण सिवरेज खतरनाक रसायनिक अवशिष्ट बदवूदार कीचड, गाद और पोलीवेग के साथ यमुना का प्रदूषित पानी उपरोक्त ग्रामों/आवासीय घरों में प्रवेश नहीं कर पाया था। तहसील/जिला स्तरीय अधिकारियों द्वारा बाढ से प्रभावित ग्रामों का दौरा व निरीक्षण किया गया था। एन0डी0आर0एफ0/एस0डी0आर0एफ0 द्वारा वाढ प्रभावित क्षेत्रों में यथा सम्भव सहायता उपलब्ध करायी गयी थी व बाढ में फसे व्यक्तियों एवं पशुओं को बाढ से सकुशल बाहर निकाला गया था।
