**ACTION TAKEN REPORT ON BEHALF OF DISTRICT MAGISTRATE  
MORADABAD, IN COMPLIANCE WITH THE ORDER DATED  
20.01.2025 ALONG WITH THE SUPPORTING AFFIDAVIT.**

MOST RESPECTFULLY SHOWETH:

1. That the order dated 20.01.2025 passed in OA No. 889/2022 Jeetu Yadav vs. Uttar Pradesh Pollution Control Board and others pending in Hon'ble National Green Tribunal, New Delhi is as follows: -

*“....3. Learned Additional Advocate General (AAG) appearing for State of UP has submitted that out of these 24 brick kilns, 22 have approached the High Court against the action of levy and recovery of EC and order of status-quo has been passed by High Court in those writ petitions. She has further submitted that in respect of one brick kiln, owner has died and second brick kiln has no property for recovery of EC.*

- . 4. *So far as District of Moradabad is concerned, action taken report filed on behalf of District Magistrate, Moradabad is on page 1845 which discloses the status of 71 brick kilns against whom action of imposition and recovery of EC was initiated and details of writ petitions filed by them wherein interim orders have been passed.*
7. *Learned AAG submits that the State has filed the application for vacating of stay in all the writ petitions wherein interim relief has been granted by High Court and those applications for vacating the stay are pending. She has further submitted that now a fresh inspection of brick kilns that are operating in all four districts will be done, and compliance status by those brick kilns will be ascertained, and action will be taken against those which are operating in violation of the norms. She has prayed for four weeks' time to file a composite report in respect of all the four districts disclosing the details of the brick kilns that are operating in those districts and their compliance status and action taken against them. Said report will be supported by affidavit of District Magistrates of all the four districts.*
8. *I.A. No.649/2024 has been filed by the applicant-M/s. New Star Bricks for impleadment & I.A. No. 650/2024 has been filed by the applicant for stay. Counsel for the applicant is directed to supply copies of the IAs to Counsel for the State if not already supplied...”*
2. In compliance with the order dated 20.01.2025, passed in OA No. 889/2022, Jeetu Yadav vs. UP Municipal Board and Others—which is currently pending before the Hon’ble National Green Tribunal, New Delhi—the relevant authorities have taken all necessary actions in response to the earlier closure order imposed on 71 brick kilns operating in the Moradabad district. During a comprehensive and coordinated joint on-site inspection aimed at evaluating

the current status of the measures implemented, detailed instructions were issued to ensure that a complete report is prepared. This report is intended to document the recovery of the environmental compensation amount and to confirm that the closure order against the 71 brick kilns is being strictly enforced. These efforts reflect a rigorous commitment to upholding environmental regulations and protecting public health by ensuring that all prescribed measures are effectively implemented and monitored.

3. That the report of investigation conducted by the concerned Sub-District Magistrates of District-Moradabad in compliance with the order dated 20.01.2025 passed in OA No. 889/2022 Jeetu Yadav vs. UP Pollution Control Board and others pending in Hon'ble National Green Tribunal, New Delhi, is as follows: -

4. It is also submitted that by office letter number 443/CA DM-2024/50 dated 26.09.2024, a letter was sent to the Additional Commissioner State Tax,

Moradabad Zone, Moradabad for cancellation of registration of brick kilns declared illegal, in continuation of which information has been provided by letter number P-04-2431/Brick Kiln/2024-25/Additional Commissioner Grade-1, R.K. Moradabad dated 10 October 2024 cancelling the GST registration of brick kilns.(Annexure-5)

5. That it is humbly submitted that full compliance of the order dated 20.01.2025 passed in ON No. 889/2022 Jeetu Yadav vs. UP PRBSE and others, pending in Hon'ble National Green Tribunal, New Delhi, is being ensured.
6. It is further pertinent to note that the notice that in compliance with the order of Hon'ble National Green Tribunal, strict instructions have been issued to all the Sub-District Magistrates and Police Officers of the district as well as the Regional Officer, UP Pollution Control Board, Moradabad, not to allow the operation of the 71 brick kilns in question under any circumstances and to keep providing their inspection comments from time to time.
7. Hence, it is clear from the above that all 71 brick kilns in the Moradabad district have long been closed and are not in operation at present. Furthermore, neither is the process of baking raw bricks in these kilns being carried out, nor is fuel—such as coal or wood—being stored. Consequently, brick kiln production has been completely halted.
8. That the answering respondent reaffirms its unwavering commitment to the directives of the Hon'ble National Green Tribunal. Every measure undertaken is meticulously aligned with the Tribunal's orders to safeguard public health and preserve the environment. Through rigorous inspections, prompt remedial actions, and continuous monitoring, the respondent is

1. That I am posted as stated above and well conversant with the facts of the present case and as such competent to swear this affidavit before this Tribunal.
