

ACTION TAKEN REPORT ON BEHALF OF DELHI POLLUTION CONTROL COMMITTEE WITH RESPECT TO ORDER DATED 30.09.2020

1. That Hon'ble Tribunal took up the matter on 30.09.2020 and directed DPCC to take further action against illegal E-Waste processing units and file compliance status before the next date of hearing.
2. That, earlier DPCC in co-ordination with East Delhi Municipal Corporation, Revenue Department and Delhi Police filed report action taken on 19.12.2019 and 25.09.2020 against the illegal E-Waste units being operated in non-conforming areas of Delhi. The reports are available on the record of this Hon'ble Tribunal.
3. That Hon'ble Supreme Court had passed a judgment on 07.05.2004 in WP(C) No. 4677 of 1985 titled as "M.C. Mehta Vs. Union of India & Others" for closure of all the illegal units from the residential / non-conforming areas in NCT of Delhi. As per the said judgment, all illegal/unauthorized industrial units that have come up in residential / non-conforming areas in Delhi on or after 1st August 1990 shall close down. Illegal e-waste handling activities are also non-conforming to the land use as per the Delhi Master Plan -2021 and so are liable for closure.

Hon'ble Supreme Court of India has also constituted a Monitoring Committee under the Chairmanship of the Chief Secretary of Delhi. The Monitoring Committee would be responsible for stoppage of illegal industrial activity. This Monitoring Committee is filing regular progress



reports before the Hon'ble Supreme Court of India through the Commissioner of Industries.

4. That, as per the decision taken by the Chief Secretary, Govt. of NCT of Delhi in the meeting held on 05.06.2015, it has already been decided that action on all the industries operating in residential/non-conforming areas of NCT of Delhi and violating the Master Plan of Delhi will be taken by the land owning agencies.
5. That, as per the Master Plan of Delhi-2021, an industry is permitted only in designated areas i.e. Industrial Areas / Estates & Redevelopment Areas. An industry operating outside these areas are patently illegal irrespective of the fact whether that is polluting or not.
6. That Hon'ble Supreme Court of India, vide its order dated 04.11.2019, in the above mentioned petition, clearly cast the responsibility of taking action against the illegal units in residential/non-conforming areas on the concerned Zonal Deputy Commissioners of the Municipal Bodies. Copy of the order dated 04.11.2019 passed by Hon'ble Supreme Court of India is annexed herewith as **Annexure-1**.
7. That, illegal storage, dismantling, refurbishing & recycling of E-Waste are not permissible in residential/ non-conforming areas of NCT of Delhi and action for closure of such entities is the responsibility of the concerned municipal authority. The teams consisting of East MCD, Executive Magistrate of Revenue department, DPCC and Delhi Police were constituted for taking action for effective closure and disconnection of power supply of such units/occupiers which are indulged in illegal activities of E-Waste handling & processing.
8. That, a copy of the order passed by this Hon'ble Tribunal dated 30.09.2020 was forwarded to DSIIDC for taking necessary action and submit the action taken report to identify industrial areas where such unit can be allowed to operate in an environment friendly manner. DSIIDC has submitted a letter



on 16.10.2020 and informed that e-waste units can be set up in any of the approved industrial areas provided they take suitable measures for the prevention and control of environmental pollution as per the norms and provisions of various environmental laws.

EDMC has been directed to take necessary action against illegal e-waste handling units in residential/ non conforming areas, of East DMC, till all the illegal units are closed down.

Deputy Magistrates (Revenue) of three revenue districts have also been directed to take necessary action on the issue as closure of illegal units in terms of orders passed by this Hon'ble tribunal dated 18.10.2019.

DCPs of all the three districts ie East, North East and Shahdara have also been requested to provide adequate police force for carrying out drive of effective closure.

9. That, an order dated 07.10.2020 was issued by DPCC urging the Commissioner of EDMC and Deputy Magistrates of (East), (North East) & (Shahdara) of Revenue department to continue the drive till all the illegal e-waste handling units are closed down. Police authorities were also asked to provide adequate force for carrying out the drive carried for closure of all the illegal units. Copy of the order dated 07 October 2020 is enclosed as **Annexure-2.**

10. That, following is the gist of the actions taken in the month of September and October 2020 by the DPCC in coordination with EDMC, Revenue department, Delhi Police and BSES Yamuna Power Ltd:

- 251 number of premises were surveyed till 15.10.2020
- Out of 251, 142 premises were found to be carrying out illegal e-waste handling activities. List of the 142 premises is enclosed as **Annexure-3.**
- 99 number of premises have been vacated by the violators and stopped illegal e-waste processing activities/ found locked. List of the violators who have vacated the premises is enclosed as **Annexure-4.**

- 43 number of premises have been effectively closed by the joint teams of EDMC, Revenue Department, Delhi Police and BSES Yamuna Power Ltd. List of the premises which have been closed effectively is enclosed as **Annexure-5**.

11. That, looking at the above explained position, this Hon'ble Tribunal is requested to direct the East DMC to carry out the survey and close down all such illegal e-waste activities. DPCC will extend all technical help to EDMC in achieving the goal of closure of all illegal activities.

This status report may kindly be taken on record by this Hon'ble Tribunal.

O R D E R

(1) REPORT NO. 149 AND 161 SUBMITTED BY MONITORING COMMITTEE

As prayed for, three weeks' time is granted to the Monitoring Committee to file response.

Report No.161 is, accordingly, disposed of.

(2) IA NOS. 51374, 54195 AND 54198/2019 (APPLNS. FOR INTERVENTION, DIRECTIONS AND STAY ON BEHALF OF RAVINDER PARKASH PUNJ)

We have considered the objections and the report. We find the report to be absolutely correct and it must be scrupulous followed by the owner.

In case of any violation, let it be reported to this Court to take stringent actions against the owner, whether he can use the building in violation of order. In case of any violation of the order of Monitoring Committee is committed the same to be viewed seriously.

Application for directions is dismissed and the other applications are disposed of.

(3) IN RE: RELOCATION OF INDUSTRIES IN DELHI PROGRESS REPORT BY THE MONITORING COMMITTEE APPOINTED BY THIS HON'BLE COURT

The compliance report filed on behalf of the Government of NCT of Delhi is considered. It has been pointed out that out of 92 industrial units of step 2 which were found to be running illegally, 30 units have been sealed and 11 units are operating in the industrial clusters. SDMC has also informed that remaining 49 premises are vacant/shops/under construction. And there is some contradiction with respect to the previous status report furnished by the SDMC on the status of 49 units. The Government of NCT of Delhi has directed the SDMC to recheck and verify and provide the actual state of affairs regarding these 49 units/premises. After closing down the units, the use of the premises is being ensured in

accordance with the provisions of the MPD-2021 by the respective municipal bodies. Direction has been issued to the Zonal Deputy Commissioners to keep strict vigil on such premises so that they should not be re-used for any illegal purpose.

The state of affairs projected in paragraph 5 and 6 cannot be said to be proper. Let a clear affidavit be filed with respect to the closing of the industrial units which are objectionable and we saddle the responsibility of compliance of the order upon the respective Zonal Deputy Commissioners of the Municipal Corporations. They shall be personally liable, in case any any industrial unit is found to be running, not only in the law of torts but also for violating the order passed by this Court and they shall be liable to be proceeded with under the Contempt of Court Act. In case any unit is found to be running in violation of the Court's order in future.

Let respective Zonal Deputy Commissioners of the Municipal Corporations file the affidavits as to the state of affairs within the area which falls in their respective zones of the Municipal Corporation concerned. Let a better affidavit be filed by SDMC also. Let the Zonal Deputy Commissioners and SDMC also take the steps and furnish a report directly to this Court in addition to the Government of NCT of Delhi of doing the needful within fifteen days from today.



OFFICE ORDER

Hon'ble National Green Tribunal vide its order dated 18.10.2019 in OA No. 1001/2019 in the matter of News Item in the Indian express dated 18.10.2019 titled "5000 illegal e-waste units being run in Capital; Study authored by Esha Roy" had directed to submit factual and action report. The hot spots for these activities mentioned in the order are located in Eastern and North Eastern parts of Delhi including Seelampur (Shahadra), Mustafabad (North East Delhi). Two teams, consisting of officials of Revenue department, EDMC, Delhi Police and DPCC, have been constituted vide order dated 25.8.2020 for carrying out survey, inventorisation and effective closure of the illegal e-waste processing units, including levy of EDC.

Hon'ble NGT heard the matter on 30.9.2020 and has again directed the agencies to take action and submit Action Taken Report as on 15.10.2020 before the next date of hearing (20.10.2020). Copy of the order of Hon'ble NGT dated 30.9.2020 is enclosed. So as to file compliance report/affidavit, all the illegal units engaged in e-waste processing activity shall be closed down effectively including disconnection of power supply and levy of EDC as per the criteria given in earlier office order.

DMs of Shahdara, North East and East districts along with EDMC shall take immediate action for effective closure of the illegal e-waste processing/handling units in their respective jurisdiction and submit ATR as on 15.10.2020 not later than 16.10.2020 along with the list(s) so that, DPCC can file the compliance report in Hon'ble NGT. DMs and DCPs of the respective districts shall ensure requisite police force for carrying out the drive with immediate effect. Further, the drive shall be continued till all the illegal e-waste units are effectively closed and Hon'ble NGT appraised.
