STATUS REPORT

I, G Sudhakar, aged 56 years, presently working as District Magistrate (Central), 14 Daryaganj, New Delhi do hereby solemnly affirm as under:

1. A list of the 30 violating Hotels/Guest Houses in Paharganj was supplied on 06.11.2024 by the Delhi Jal Board (Annexure I).
  2. The list of the 78 violating Hotels was supplied by the Delhi Jal Board on 12.11.2024 (Annexure II).
  3. Another letter was submitted by the Delhi Jal Board on 26.11.2024 (Annexure III).
  4. List of 14 Hotels/Guest Houses (5 already sealed) was submitted on 29.11.2024 by the Delhi Jal Board (Annexure IV).
  5. As soon as lists were received, letters were issued to Delhi Police for providing sufficient staff for the safety of the team, Delhi Jal Board for deputing members to seal the illegal borewells, DPCC for identification of the illegal borewells and BSES for disconnecting the electric supply to the borewells (Annexure V, VI, VII).
  6. Perusal of the lists revealed that there were 108 (78 + 30) Hotels/Guest Houses which were to be checked for sealing of borewells for violations. The current status in respect of these 108 Hotels/Guest Houses has been annexed (Annexure VIII & IX).
- **Challenges faced in the sealing exercise:**
    - a) In the meeting held on 03.04.2024 to discuss the issue, regarding the supply of the status of extraction of ground water illegally, was discussed. In the minutes issued 03.04.2024, it was decided that a joint team of DPCC and DJB will carry out a survey and submit the report, supported by geo tagged photographs of each violating hotel by 08.04.2024, in the office of the District

Magistrate (Central), which has not been submitted by either the DPCC or the Delhi Jal Board, despite several reminders (Annexure X).

- b) A request was also sent to the DPCC and the DJB on 14.08.2024 reiterating that the report sought in the meeting held on 03.04.2024, this was also not submitted, even then (Annexure XI).
- c) The SDM (Karol Bagh) in the Minutes of Meeting dated 30.08.2024 also mentioned that the DPCC and DJB will identify and seal the illegal borewells. However, the officials deputed by the said agencies do not have idea of the exact details of the borewells (Annexure XII).
- d) That many of hotels mentioned in the lists supplied by the DJB had the names of the hotels who had either fulfilled all the conditions as ordered by the Hon'ble National Green Tribunal in its order dated 03.09.2024 or had already been sealed by some other agency or did not have any borewells, as is also confirmed by the inspecting team. A clarification in this regard has also been sought from the DJB on 04.12.2024, their reply is awaited (AnnexureXIII).
7. As on date, no action is pending on the part of the undersigned.

It is hereby requested to the Hon'ble Tribunal, to issue directions to the DPCC and DJB to enclose geo tagged photographs, with any request letter regarding sealing of the borewells of the violating Hotel/Guest Houses or other entities, in future, so that the sealing exercises can be completed within the shortest possible time.

Sub: -Request for sealing of borewells of the Hotels/Guest Houses not complied with the order of Hon'ble NGT dated 03.09.2024 and 22.10.2024.

The Hon'ble NGT has ruled in its order dated September 03, 2024 "Having regard to the plea that such a sealing drive is impeding the operation of hotels/guest houses and also considering the statement of the Counsel for the Applicant that they are ready to deposit the environmental damage charges under the protest and comply with the requirement of law, by way of an interim measure, we direct that if any hotel/guest house in question deposits the environmental damage charges under protest, applies for permission, gives an undertaking to comply with all norms and to pay regular water charges, the concerned Authority will defer the action of sealing of the borewells against that hotel/guest house till the next date of hearing" and further extended the date upto 31.10.2024 as per order dated 22.10.2024.

After receipt of applications by the owners of Hotels/Guest houses, the scrutiny is under process to identify the hotels which have not complied with the order of Hon'ble NGT. 30 nos. hotels (Non VDS) have been identified in the first instance who have not complied with the direction of Hon'ble NGT (List attached).

You are requested to seal the borewell of these hotels on urgent basis before the next date of hearing on 14.11.2024.

A team from Delhi Jal Board has already nominated for the sealing drive vide order No. DJB/EE(D)-53/2024-25/495 dated 08.10.2024 (copy attached).

  - II. Direction for closure under sec33(A) of the water (prevention and control of Pollution) Act, 1974 and u/s 31(A) of the Air (Prevention & control of pollution) Act, 1981 as amended to date were issued on 29.03.2022 to 330 Hotels.
  - III. Direction for closure were not issued to remaining 206 Hotels as they had submitted the reply.
  - IV. He is not sure about the present status of the Hotels extracting ground water illegally. It was decided that as such, a joint team of DPCC and DJB will carry out a survey of these 330 hotels and submit the report supported by Geo tag photographs of each hotel, by 08.04.2024 in the O/o DM (Central).

Regarding the Nakul Kapoor Vs DPCC & Ors, OA NO. 297/2023, NGT Matter It was discussed that a showcause notice dated 11.12.2023 for imposition of EDC in respect of 03 illegal borewells at 2B Goela Lane, Underhill road, Civil Lines, Delhi-110054 has been issued by the DPCC. Rs. 90000/- Penalty has been imposed as a lumpsum amount as is done in the case of borewell being illegally use for domestic purposes. Sh. Harshit JE DPCC was instructed to confirm the status of payment of the EDC amount by the violator by 08.04.2024

Sub: Request for immediate sealing of illegal borewells of Paharganj area

In reference to your letter No.DJB/SE(M)-5/2024 25/2419 dated 12.8.2024 regarding above captioned subject, it is intimated that as per the order dtd. 04.12.2023 of the Hon'ble NGT in the matter, out of 612 illegal borewells identified in the Central District, 412 have been sealed and 199 borewells remain to be sealed.

The said order was forwarded by the C.E (GW), DJB vide letter dated 30.01.2024 to the undersigned. Copy of the same is enclosed for reference. It is the responsibility of the field staff of DJB to ensure that the 412 borewells which have already been sealed remain not operational without the approval for re-opening of the same by the Competent Authority.

However, as per the letter dated 12.9.2024 of the Supdt. Engineer, DJB about 400 borewells out of 512 borewells are operational as on date in Paharganj area itself, which is a commercial area in Central District. This data is contradictory to the data/details mentioned in the aforementioned order of Hon'ble NGT. Moreover, the fact that DJB furnished illegible copy of status report dated 22.7.2024 to Hon'ble NGT which was seriously viewed in the order dated 23.07.2024 creates confusion and suspicion that the borewells earlier sealed are being operated presently without any permission.

The subject was earlier reviewed by the undersigned in the meeting dated 3.4.2024, wherein it was directed that a joint team of DPCC and DJB shall carry out a survey of the 330 hotels in which directions for closure under section 33(A) of water (Prevention and Control of Pollution) ACT, 1971 and under section 31(A) of the Air (Prevention and Control of Pollution) ACT, 1981 were issued and closed

for resurvey and submission of report supported by Geo-Tag photographs of each hotel borewell within a week was not furnished till date. The report should be furnished by Joint Team of DPCC and DJB immediately along with the exact and factual data as to how many borewells were sealed earlier and how many are to be sealed hotel / guest house wise in Pahar Ganj area by 20.08.2024, failing which the issue will be brought to the notice of Hon'ble NGT in the next date of hearing.

Further, Supdt. Engineer, DJB is advise to furnish clear information with details as to how many illegal borewells are in operation and sealed respectively as on date in Central District by 20.8.2024.

Sub: Clarification in reference to the mismatch in the number of illegal borewells to be sealed in Hotel/Guest Houses in Paharganj.

Sir,

Kindly refer to the order issued by Hon'ble NGT in Execution Application no. 11/2023 in the matter of Varun vs Govt of NCT of Delhi & Ors dated 22.11.2024.

In para no. 7, it has been observed in the order, that the learned counsel for the DJB has stated that they have forwarded the matter for sealing of 108 illegal borewells. Out of which 33 only have been sealed.


Whereas, in para no. 8 of the order Hon'ble National Green Tribunal has observed that the Ld Counsel appearing on behalf of Lodging House Owners Association, has disputed this figure and has submitted that 398 Hotel/Guest Houses have complied with the order deposing Environmental Damages Charges and given the undertaking. He has submitted that out of this 398, 44 hotels are those, who have complied with two conditions but could not comply with the third condition, of making application for permission. In respect of the remaining 44, he had made a prayer that 05 day's further time be granted to them, for filing application as they have complied with other two conditions. The Hon'ble National Green Tribunal, accepted the prayer, and granted a further 05 days time, from the date of the order, to stasify the third conditions of making an applications for permission. If, the third condition was satisfied within the extended period of 05 days, these 44 Hotel/Guest Houses will be entitled to benefit of interim order dated 03.09.2024. The Ld. Counsel of Lodging House Owners Association had also submitted that there were 04 other Hotel/Guest Houses who was members of association who had been sealed.

In para no. 12 of the order, the Hon'ble Tribunal had given 10 days times from the date of order to seal the remaining borewells out of the list of 78 Hotel/Guest Houses provided by DJB to be sealed. It is submitted that the DJB has shared two list 06.11.2024 & 12.11.2024, having a total of 108 violating Hotel/Guest Houses.

Kindly clarify on the following points:

1. If the figure of 108, as given in the two lists dated 06.11.2024 and 12.11.2024 by the Delhi Jal Board, is added to the number of the borewells, as given by the counsel of the Lodging House Owners Association - 398 is added, then the total comes to the 506 and this exceeds the number given by the DPCC (442 borewells).
2. The Hon'ble National Green Tribunal has observed that only 44 hotel owners, are to be given 05 days, extended time, to be entitled to the benefits of interim order dated 03.09.2024.
3. That the 02 lists supplied by the Delhi Jal Board contains details of 108 Hotel/Guest Houses having illegal borewells. However, the field inspections, have revealed violations in 36 Hotel/Guest Houses and borewells of these Hotel/Guest House have been sealed. 04 Hotels have been sealed by other agencies and it was informed by the team, that in 05 cases the borewell could not be found. The Ld. Counsel had also submitted that there were 04 other Hotel/Guest Houses who have fulfilled all the three condition but still have been sealed. This total comes to 49 which does not match with the number of 108 as given by you.

As such, you are requested to explain this mismatch so that the Hon'ble Tribunal can be apprised of the same.
