ACTION TAKEN REPORT ON BEHALF OF DELHI POLLUTION CONTROL COMMITTEE WITH RESPECT TO ORDER DATED 04.10.2023.

IT IS MOST RESPECTFULLY SHOWETH:

1. That, this matter was taken up by this Hon`ble Tribunal on 23.05.2023 and was pleased to direct the "Monitoring Committee" appointed by Hon`ble Supreme Court may look into the matter in coordination with other concerned authorities, including the CPCB and DPCC. The report may mention consent status, compliance status with reference to disposal of effluents into drain and its quality, location of these units in non-conforming area against operation of dyeing factories operating without the consent/NOC/permission in Bindapur, Matiala, Ranhola, Khyala, Meethapur, Badarpur, Mukundpur and Kirar, Delhi.
2. That geo-tagged location/premises mentioned in the said OA are 71 nos. including 18 no. of respondent addresses. Out of 71 locations/premises, 50 locations/premises had already been inspected till 03.10.2023 and the details of these 50 locations are as follows :

Locations/premises found outside NCT of Delhi	: 01 nos
Locations/premises found locked	: 11 nos.
Locations/ premises found as residential/no dyeing activity	: 27 nos
Locations/premises(Dyeing activity) sealed/electricity disconnected :	11 nos

3. That in compliance with the order dated 23.05.2023 passed by this Hon`ble Tribunal, DPCC filed the status report through email on 03.10.2023 which is available on the records of this Hon`ble Tribunal.
4. That, this Hon`ble Tribunal considered the report on 04.10.2023 and directed to file fresh complete action taken report i.e. in respect of 21 leftover premises and inspection of 11 nos. of locked premises (Total : 21+11=32 nos.)
5. That out of these 32 remaining premises/locations, 16 co-ordinates/premises in Meethapur, Molarband, Lal Kuan Badarpur and Khyala area have been inspected and the details are as follows :

8. It is therefore requested that the present action taken report may kindly be taken on record.


