

**STATUS REPORT IN R/O OF O.A.NO.319/2023 IN THE MATTER OF**  
**“RAJESH KUMAR VS. GOVT. OF NCT OF DELHI**

In the above matter, it is submitted that a complaint was received in this office for the first time in the month of February-2023 regarding illegal scrap/kabari shop running in the premises situated at Block-I-11, Sector-16, Rohini, New Delhi. Accordingly, site was visited by field staff on 23-02-2023 and sale of iron scrap was found running from the said premises. Accordingly, a court challan vide No.116547 dated 23-02-2023 was issued.

Further, joint inspection was carried out with DPCC on 10-07-2023. The occupier had been vacating the premises on the said inspection date. Joint inspection report dated 10-07-2023 is enclosed. Another inspection of said site was carried out on 19-07-2023 and no illegal scrap/kabari shop was found running from the said premises. Geo Tag photographs dated 19-07-2023 is enclosed herewith for ready reference.

A recent joint inspection dated 14-09-2023 was carried out alongwith DDA & DPCC. During joint inspection, again no illegal scrap/kabari shop was found running from the said premises. During routine visit of the site dated 29-09-2023, no illegal scrap/kabari shop was found running from the said premises. - 2) During inspection, scrap (iron, etc.)/material found being loaded in a truck and as informed/told by Sh. Jayant Kumar, owner/representative of unit that they are shutting down the unit & vacating the premises.
- 3) Some shuttering work material like fatti, balli etc. found in the premises.
- 4) During inspection, MCD representative was asked for taking necessary action and submit the action taken report.




