Sub: Action taken report/Compliance on order dated 10/01/2020 passed by the Hon'ble National Green Tribunal, Principal Bench, New Delhi in O.A. No. 533/2019 titled Anubhav Kumar V/s Union of India & Ors.

Sir,

This is in reference to the above mentioned subject; regarding Action taken Report/compliance of the directions passed vide order dated 10/01/2020 by the Hon'ble National Green Tribunal, Principal Bench, New Delhi.

CRWC had submitted its Action Plan/Action taken report dated 10.02.2020 to all the committee members appointed by Hon'ble NGT and compliance report to the same is submitted below:

- 1) Northern Railway shall immediately construct warehouse for handling of cement bags so as to minimize fugitive emissions until then no cement handling shall be permitted.**

This does not pertain to CRWC.

However, it is informed that CRWC's warehouses at line no. 2 & 3 are already covered warehouses which minimize the fugitive emissions. It is also submitted that CRWC is not permitting any loading of stocks in the uncovered trucks. The loading is being allowed only in the trucks properly covered with tarpaulin.

- 2) Mechanical handling of cement bags using conveyor belts shall be introduced by NR and CRWC in order to reduce fugitive emission.**

(i) For mechanical handling of cement bags, CRWC has already made operational at its warehouse two tier-mounted conveyor belt machines with arms. These machines are being used for mechanical handling/unloading of cement bags

(ii) In addition to above, CRWC also got designed suitable conveyor belt system with folding arms with the help of the manufacturers of the machines to make mechanical loading/ unloading operations more effective. One such Conveyor belt with folding arms purchased from M/s Vivian Conveyors, Pune, stands installed at the warehouse and has been into operation since 06.02.2020.

(iii) CRWC is facing stiff resistance from labourers, as installation of conveyor machines is affecting their livelihood. The installation of conveyor belt machine has replaced and reduced the number of labourers working at the good shed. Installation of more machines will create more unrest between the management and the labourers. Management is in process for convincing the labourers to use these machines.

(iv) CRWC has invited tenders for purchase and installation of 10 more conveyor belt machines in the warehouse in april'2020. The delivery period has been given 45 days. Due to COVID-19 Lockdown, the ordering and delivery of machines is expected to get delayed.

3) The enclosures in the form of flexible belt curtain may be provided for the unloading sides.

(i) CRWC after considering various options available for flexible belt curtains has placed order for supply/purchase and fixing of flexible PVC belt curtain on 07.02.2020. The curtains are under installation. The installation work going on has been stalled due to lockdown in country and it shall be completed in approx. one month after the lockdown is completely withdrawn.

4) Warehouse cleaning shall be done with only mechanical means by NR and CRWC and it shall be done on regular basis. Cement collected shall be properly stored and records be maintained.

(i) For cleaning the warehouse, four number sweeping machines have already been procured by service provider, M/s G. S. & Company, as cleaning of the warehouse being within their scope of work.

(ii) The cleaning is now being done with the help of these sweeping machines on regular basis.

(iii) The cement sweeping is being collected on regular basis and is being stored at designated place in respective compartments. The record for cement sweeping collected is being maintained in a separate register. The sweeping collected is handed over to cement companies/Service Provider.

(iv) The following relevant documents are enclosed at Annex - 3 for ready reference:-

- Copy of the invoice for the four machines purchased by M/s G. S. & Company for sweeping of floors.
- The photographs of the machines put in use for sweeping of floors.
- Copy of the record being maintained for cement sweeping.

5) Peripheral roads for vehicle movement should be paved and these should be properly maintained.

(i) The peripheral road for vehicle movement were already paved by CRWC and is being properly maintained. CRWC has purchased one mini truck loaded sweeping machine from M/s Pyara Singh & Co, Ludhiana for cleaning the peripheral road . The peripheral road/circulating area is now being cleaned with the help of mini truck loaded road sweeping machine purchased by CRWC.

Effects of Cement dust on human body

- Irritated eyes, nose, throat and the upper respiratory system.
- Skin irritation, thickening/cracking of skin to severe skin damage.
- Silica exposure can lead to lung damages including silicosis and lung cancer.
- Alzheimer
- Coughing, asthma and other health-related issues.

Protection methods

- Wear a P-, N- or R-95 respirator to minimize inhalation of cement dust during loading and unloading of cement bags.
- Rinse eyes with water if they come into contact with cement dust.
- Use soap and water to wash off dust to avoid skin damage.
- Eat and drink only in dust-free areas, to avoid ingesting cement dust.
- Wear the appropriate personal protective equipment, such as gloves, boots, goggles or HEPA-filter respirators.

First camp is planned on 3rd March 2020.

3. We will educate the labour about correct handling of cement bags, impact and safety precautions to be taken by them. This will be done on monthly basis, first is planned on 3rd March 2020.
