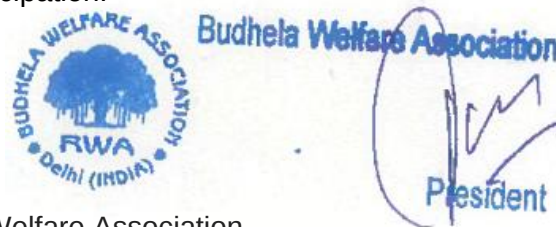
Pursuant to the order dated July 23, 2020, passed by your Lordship in the subject matter, the RWA of Budhela is filing their reply to the same.

HUMBLE PETITION OF THE APPLICANT ABOVENAMED.

**RESPONSE TO THE ACTION TAKEN REPORT
FILED BY THE DPCC DATED JULY 21, 2020.**

- (1) That, we would like to reiterate that there are three marriage function Sites (Nos. FS/WZ/124/1, FS/WZ/124/2 and FS/WZ/124/3, located at Dussehra Ground, F-block, Budhela, Vikas Puri, New Delhi-110018, Ward No.20 (S). Each function sites conducts 10 x 3 marriage functions at the Dussehra Ground. This Dussehra Ground comes under the province of Horticulture Department of SDMC, OFFICE OF THE HORTICULTURE DEPARTMENT, WEST ZONE, DR. SAHIB SINGH VERMA NIGAM BHAWAN, NEAR SHIVAJI COLLEGE, SHIVAJI PALACE, RAJA GARDEN, NEW DELHI.
- (2) Furthermore, we would also like to reiterate that this Dussehra Ground is surrounded by the residential area (which is just 10 to 13 meters across the road) and it is quite surprising that for generating revenue, SDMC Horticulture Department continuous to allow such an extensive commercial activities of three marriage functions at this Dussehra Ground, due to which the Life of the residents who stay closer to this Ground has become HELL.
- (3) That as per paragraph 3 (i) of the Hon'ble NGT order it has been clearly mentioned "***That No Park of DDA/MCD shall be used for holding any social, cultural, commercial and marriage or other functions***". However, the Department of Horticulture of SDMC does not at all taking any steps to de-list this Ground. Instead, SDMC Horticulture Department has started doing fresh function booking details at this ground for the upcoming entire winter session 2020-2021.
- (4) That subsequent to the NGT order dated December 20, 2019, the horticulture department of the SDMC continued to carry out its functions at this Dussehra Ground site. Details of the booking for the months of Feb & March 4, 2020 are attached as **ANNEXURE 1**, herewith for reference and records. It is clear

evident that SDMC Horticulture is well aware of the Hon'ble NGT Order dated 20-12-2019. However, officials of the SDMC Horticulture Department blatantly continued to disobey the Order of the Hon'ble NGT and continued to conduct the marriage functions at Dussehra Ground site.

- (5) That SDMC and the Tent organizers have deliberately violated the guidelines of the Hon'ble NGT Order and continue to violate and damage the environment of the entire Dussehra Ground to generate and gain revenue.
- (6) That the local residents are facing numerous noise pollution issues and subsequent to the Hon'ble NGT order have registered noise pollution complaints at the NGMS Online Portal vide complaint nos.4307, 4322, 4323, 4445, 4560, 4684, 4711, 4712 and 4748. Also, pollution complaints were registered in the online CPCB complaint portal vide complaint number 1318696 dated December 1, 2019.
- (7) That whenever there are marriage functions at this ground, entire night fire crackers keeps on bursting. As there is no fixed time of arrival of Barat's therefore, running of Dols \ DJ music \ Crackers bursting \ noise of vehicular activities \ public hooting keeps coming up through the night from all the three marriage function sites, due to which local residents Right to Sleep, which is democratic right gets badly affected.
- (8) That in compliance with paragraph 2 (1) of the NGT Order, it explicitly mention that how Tent Palace Owners should manage the disposal of the solid waste and left over waste. However, in all the three function sites Tent Palace organizers have absolutely failed to comply with the rules and \ or guidelines of the Hon'ble NGT Order in all the three function sites.
- (9) That the Tent organizers along with the officials of SDMC Horticulture Department aligned together and instead of disposing off the solid waste\garbage i.e., left at the function sites, SDMC with the help of JCB machine had dug up the entire ground to place all the solid waste material \ left out plastic material beneath in the premises of the Dussehra Ground. This is evident and accepted by the SDMC department vide letter dated June 1, 2020. Copy of letter dated June 1, 2020, from SDMC is attached herewith as **ANNEXURE 2** for review and records.
- (10) That once the marriage season had finished i.e., from March 4, 2020 the premises of the Dussehra Ground had been dug up and all the Solid Waste \ Plastic Waste and leftovers waste had been placed beneath the ground. This is evident from the pictures attached herewith as **ANNEXURE 3**. The conduct

of the SDMC officials falls within under the scope of contempt of Hon'ble NGT orders.

- (11) That, the garbage i.e., left out of the functions, is being dumped in the Dussehra Ground, due to which, as and whenever it rains the water gets stagnant in the entire Dussehra Ground which increases the breeding of mosquitoes and other water borne diseases. Pictures of the park covered with the water stagnating is attached herewith as **ANNEXURE 4** for reference and records.
- (12) That, due to the illegal and unregulated use of the commercial activities at the Dussehra Ground, the environment of the local residential area is badly getting damaged. It is quite regrettable that despite of the clear-cut specific provisions of the Environment Laws, all the organizers of the Tent Palace appears to violate all pollution norms.
- (13) That we would like to record the fact that SDMC Horticulture department, had almost destroyed most of the trees out of the 136 trees planted in the Dussehra Ground during the period January 1, 2017 to March 31, 2018 in order to provide more space to facilitate the three marriage functions at the Dussehra Ground effectively. Copy of the letter of the SDMC dated July 1, 2019 is attached herewith as **ANNEXURE 5**. It is evident to note that as on date there are hardly any trees left out in the premises of the Dussehra Ground.
- (14) That as on date, SDMC Horticulture Department has left Dussehra Ground Vikas Puri in a very miserable condition and the same can be evident from the copy of Times of India newspaper cutting dated August 15, 2020 is attached herewith as **ANNEXURE 6**.
- (15) That immense pollution is caused \ released by the three tents while preparing and/or cooking the food in the Dussehra Ground. The Entire residential area is covered with dense smoke and residents find it difficult to breath during night hours, and the bursting of crackers during wee hours further deteriorate the air quality level of the residential area. SDMC Horticulture Department vide letter dated December 10, 2019, agreed the fact that there were no specific guidelines supporting the prohibition of cooking of food in the open ground areas and that the level of the Air quality would not be contaminated by the cooking of food in the open ground areas. Copy of SDMC Horticulture Department letter dated December 10, 2019 is attached herewith as **ANNEXURE 7** and pictures of release of the smoke coming out from the Tents installed at the Dussehra Ground are attached herewith as **ANNEXURE 8** and the same may be taken on records.

- (16) That subsequent to the Hon'ble NGT Order and DPCC directions, as on date, the SDMC Horticulture Department has not de-listed all the 3 function sites from its online booking portal. These sites are still available for the bookings.
- (17) That, in addition, the SDMC Horticulture Department is not at all in compliance with the Hon'ble NGT Orders and has initiated the process of taking fresh function bookings at the 3 Function Site Nos. FS/WZ/124/1, FS/WZ/124/2 & FS/WZ/124/3) located at Dussehra Ground F-Block Budhela Vikas Puri, New Delhi – 110018 [Ward No.20(S)]. SDMC Horticulture Department is willingly disobeying the directions \ orders of the Hon'ble NGT and DPCC. Proof of the fresh booking details for the month of November 2020 are attached herewith as **ANNEXURE 9**. It is clearly evident that the nature of misconduct and the corruption of the SDMC officials in connivance with the tent mafia and hence their conduct falls within the scope of the Contempt of Court. As per the facts highlighted above, we hereby request that the case of contempt of disobedience to the orders of the Hon'ble NGT and DPCC be registered against the officials of the SDMC Horticulture Department.
- (18) That Tent organizers does not apply for any mandatory compliances such as approval from **(i)** Delhi Fire safety services, **(ii)** Event performance Licenses for holding functions at the Dussehra Ground premises, **(iii)** Approval from Delhi Traffic Police, **(iv)** Electric department services for inspection of site, **(v)** also No Objection Certificate is required to be taken from Auto Engineer after inspecting site once the Tent Pandals are installed, **(vi)** Approval from local Police Station etc.
- (19) It may be pertinent to note that in the event that marriage functions are permitted at this Dussehra Ground, the local residents will continue to suffer abundance of harm and mental anguish due to the effect of the 3 marriage functions organized at Dussehra Ground site. The Health of the local residents has been deteriorating due to the numerous pollution activities that is generated by the functions during the entire winter seasons. Since the enforcement of law is very weak hence the violators get easily escaped and can't be penalized. Years after years have been passed local RWAs are consistently complaining and it is quite surprising that despite of the Environmental laws\guidelines why commercial activities are allowed in the Grounds.
- (20) That vide letter dated February 20, 2019, SDMC Horticulture Department admitted the fact that there are many locations available in the Vikas Puri area where local public can conduct functions \ parties. There is adequate place

being allocated by DDA to conduct functions \ parties in the Vikas Puri locations. Copy of letter dated February 20, 2019 is attached herewith as **ANNEXURE 10.**

- (21) That as per the Article 21 of the Constitution of India, the Applicant right to breathe is being violated. Article 21 (right to life) of the Indian Constitution has broadened the ambit of right of life to bring in a citizen's right to sleep peacefully. *"Sleep is essential for a human being to maintain the delicate balance of health necessary for its very existence and survival. Sleep is, therefore, a fundamental and basic requirement without which the existence of life itself would be in danger,"* terming it as a basic human right. Due to the functions permitted by the SDMC Horticulture Department the Applicant is approaching this Court to seek justice for the security of their Right to breathe and Right to Sleep peacefully during night hours.
- (22) That Article 31 states Child's Right to Play and recreational activities appropriate to the age of the child, providing sufficient recreational facilities like swings for example to ensure healthy development of the children. Since the Dussehra ground is gridlocked by the Tent palaces for conducting functions at this Dussehra Ground, hence there is no place left out for the children to play. Also, there is no near-by ground where Senior citizens and local residents can walk-in freely. Pictures of representation by the local children's to remove commercial activities from the Dussehra Ground is attached herewith as **ANNEXURE 11.**

PRAYERS:

- (A) Initiation of Contempt proceedings with immediate effect should be registered against the officials of SDMC Horticulture department. In addition, an immediate show cause notice should be issued to the SDMC Horticulture Department seeking an explanation for damaging \ polluting the Dussehra Ground i.e., located at Dussehra Ground Budhela \ F-Block Vikas Puri, New Delhi, Ward No.20 (S).
- (B) Initiation of the Contempt proceedings should be registered against the officials of SDMC Horticulture department for initiating the process of taking new bookings for the 2020-2021 winter session by disobeying the Orders of the Hon'ble NGT and DPCC.
- (C) Hefty fine should be impose on the SDMC and Tent owners for digging and dumping of the solid waste, plastic waste and party leftover waste in the Dussehra Ground premises.

- (D) The revenues collected and generated by the SDMC Horticulture department during the months of Jan, Feb & March, 2020 from all the three function sites should be confiscated with immediate effect.
- (E) Lastly, in order to protect our health and environment, we need massive afforestation and local residents hereby strongly demand that the Dussehra Ground environment should be preserved and with immediate effect appropriate orders should be passed on to de-list the Dussehra Ground and no functions should be permitted at the Dussehra Ground with immediate effect.
- (F) Any other such relief as this Hon'ble NGT Court may deem fit and proper in the interest of justice may be granted.

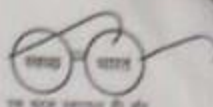

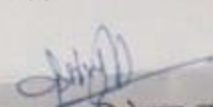

Vikaspuri stink: Open area used for weddings leaves bad aftertaste

New Delhi: A 4.5-acre green area located in the middle of west Delhi's Vikaspuri and Budhela Village has become an eyesore for residents.

The open site, 80% of which is used by South Delhi Municipal Corporation for holding weddings and other functions, has turned into a home for stray cattle and pigs. Residents claim that after the functions get over, the department disposes of the waste in pits at the park and the area stinks during the monsoon season.

Annoyed residents have written to the SDMC commissioner, horticulture department, and the deputy commissioner several times, clarifying that as per the National Green Tribunal order, no park of Delhi Development Authority or the corporations shall be used for holding social events or marriage functions.

"The place was handed over to MCD in early 1987 for development as a park. The ci-

vic body, however, never took any effort in plantation, maintenance and rather used it for conducting events. This year too, till March functions were taking place and the leftovers were being disposed of in the pits. We wrote to senior officials, after which they arranged for some superficial job and then disappeared. Ideally environment compensation should be imposed on all involved parties, including the tent organiser," said Paras Ty-

agi, a resident who lives next to the site.

Fed up by the unwilling attitude of the civic agency, the residents filed an RTI, seeking to know about the actual land use of the site. "In the RTI, it was clearly mentioned that 1.88 hectare is green land as per the master plan. We shared a copy of this SDMC and asked officials to develop the whole area into a park rather than using it for commercial purposes and

making money. But there is no reply and even our councillor is not cooperating," Tyagi claimed.

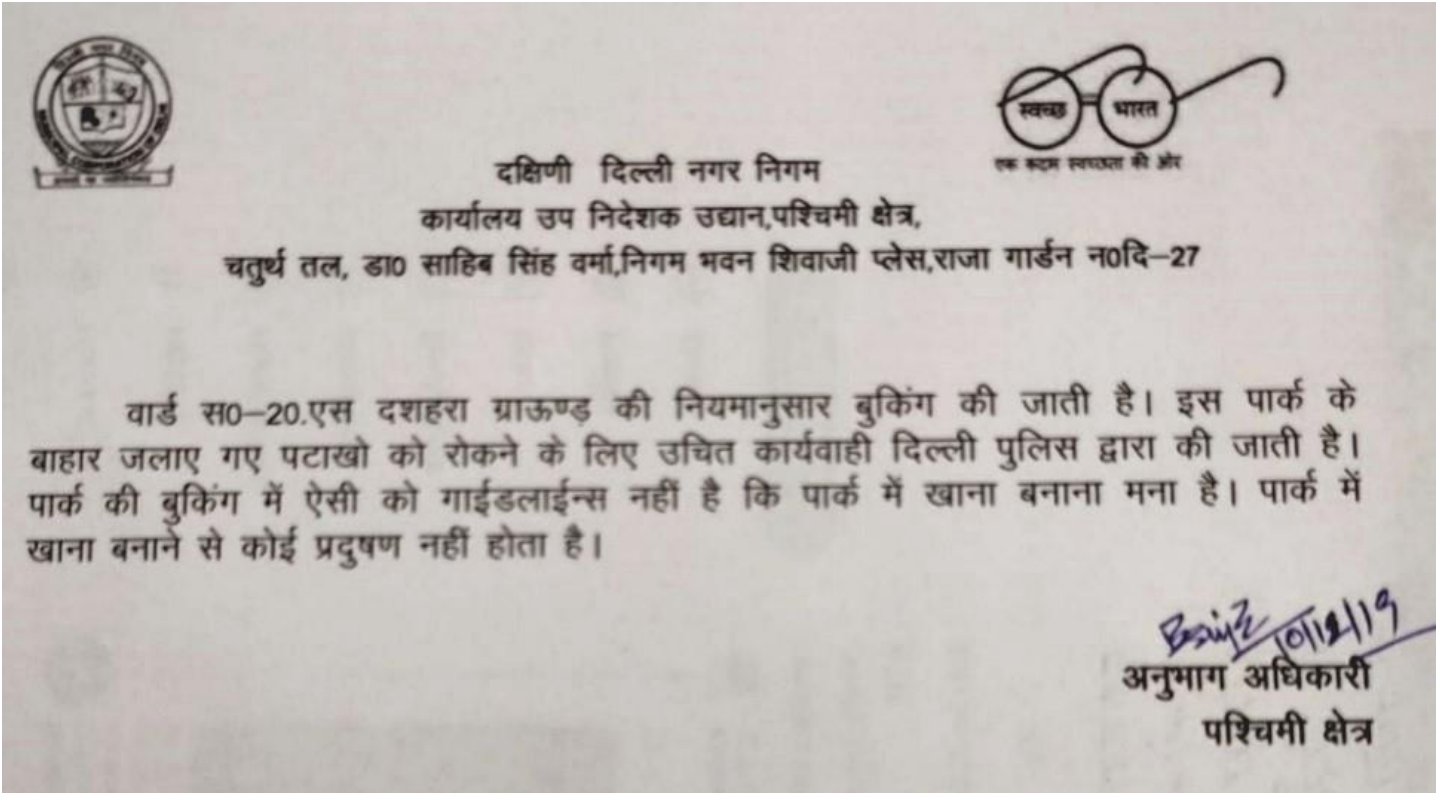
A senior SDMC official, however, claimed that every time they received a complaint, the staff immediately arranges for cleanliness action. "We never found any garbage dumped inside the complex. As far as stray and outsiders are concerned, it is an open land and we can't stop anyone. We cannot do plantations as people living in the area are frequently booking it for functions. In comparison, the adjoining half acre land, earmarked as park, has grass, plants and is maintained by malis," the official said.

He added that the site was among the 60 earmarked spots used by municipalities for arranging social functions on the demand of locals. "If they don't want it, then as per norms a reference letter from the councillor is required. We will take action accordingly," the civic official said.

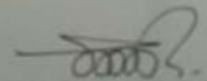
