

do hereby solemnly state on oath and submit that: -

2. The captioned Appeal is for quashing and set aside the  
Environment Clearance dated 16.09.2024 granted by Respondent  
Ministry (Hereinafter referred as "R-1") to Respondent Project-  
Proponent's (Hereinafter referred as "R - 5") for 3 limestone mines.  
The Appellants have challenged the Environment Clearance



granted for three limestone mining projects lead by R - 5 at following villages of Mahuva Taluka, Bhavnagar District: -

- a) Vangar & Madhiya,
- b) Padhiarka & Doliya and
- c) Gujarda, Dudheri & Dudhala

3. It is respectfully submitted that the project is categorized as Category-A of item 1 (a) Mining of minerals under the Environment Impact Assessment Notification, 2006, hence required appraisal at Central Level by Expert Appraisal Committee. The answering Department, respectfully submits that it has only limited, procedural and facilitative role in EC clearance.
4. The Answering Respondent humbly submits that Environmental Clearance is granted in accordance with the procedure prescribed under the Environment Impact Assessment Notification, 2006 and its subsequent amendments, by the competent authority i.e., the MoEF & CC, Government of India. The technical appraisal is undertaken by the Expert Appraisal Committee (hereinafter referred as "EAC") which is independent statutory body; thereafter the Environment Clearance is granted by MoEF & CC.
5. The role of answering Respondent is merely to review, recommend the changes if required and authenticate the Conservation Plan submitted by the Respondent Project Proponent. It is humbly submitted that such conservation plan is submitted by the Project



Proponent upon the Term of Reference issued by the MoEF & CC. The answering Respondent hereby wish to produce the internal communication of the answering Respondent's office while authenticating the Wildlife Conservation Plan.

- 5.1. The answering Respondent humbly submits that the Respondent Project Proponent has submitted a consolidated Wildlife Conservation Plan for the aforementioned limestone mines in accordance with the Term of Reference ( Hereinafter referred as "ToR") granted by MoEF & CC for 3 sites. The Wildlife Conservation Plan was submitted vide a letter dated 08.06.2020 to Principal Chief Conservator of Forest. The copy of such letter dated 08.06.2020 is annexed and marked as **ANNEXURE - R1**.
- 5.2. Thereafter the Chief Conservator of Forest vide a letter dated 09.06.2021 has asked the Deputy Conservator of Forest to express opinion on the Wildlife Conservation Plan. Deputy Conservator of Forest replied vide a letter dated 18.09.2021 to the Chief Conservator of Forest recommending to authenticate the conservation plan and forwarded it further. Copy of said letter dated 09.06.2021 and 18.09.2021 is annexed and marked as **ANNEXURE - R2(Colly)**.
- 5.3. The Chief Conservator of Forest after duly scrutinizing the submitted Wildlife Conservation Plan has made certain recommendations vide a letter dated 22.10.2021. The recommendation includes to reduce the period of financial

layout of conservation plan from 5 years to 3 years, to update the latest details of flora and fauna, and to mention distance from the Velavadhar Sanctuary to the project area in the map. Further, it was recommended to make appropriate budgetary allocation according to the project area and to include the conservation and breeding of Schedule I, II, III & IV species in the conservation plan. Copy of such letter dated 22.10.2021 by Chief Conservator of Forest to Deputy Conservator of Forest is annexed and marked as **ANNEXURE - R3**.

5.4. After considering the recommendations made by the Chief Conservator of Forest, the Respondent No. 5 vide a letter dated 02.11.2021 has submitted the Revised Wildlife Conservation Plan along with budgetary allocation. Thereby submitted the revised Wildlife Conservation Plan to Deputy Conservator of Forest vide letter dated 02.11.2021 which is annexed and marked as **ANNEXURE - R4**.

5.5. The Chief Conservator of Forest vide a letter dated 30.11.2021 addressing to the Principal Chief Conservator of Forest stating that the recommendations made by the Chief Conservator of Forest has been duly complied by updating the latest record of flora and fauna, and specifying the distance between project area and the nearby Sanctuaries and national parks; budgetary allocation for the conservation and breeding of Schedule I, II, III & IV species.



Copy of letter dated 30.11.2021 by Chief Conservator of Forest to Principal Chief Conservator of Forest is annexed and marked as **ANNEXURE R5**.

- 5.6. After reviewing and scrutinizing the revised Wildlife Conservation Plan, the Principal Chief Conservator of Forest authenticated the Wildlife Conservation Plan of Rs. 19.9 Lakhs and communicated the same to Project Proponent. Copy of such letter dated 20.12.2021 communicating authentication of Wildlife Conservation Plan by the Principal Chief Conservator of Forest to Respondent Project Proponent is annexed and marked as **ANNEXURE - R6**.
- 5.7. The answering Respondent has merely authenticated the Conservation Plan which was submitted by the project proponent as per the requisite of ToR issued by the MoEF & CC.
6. It is submitted that the Answering Respondent is neither the regulatory authority nor the appraisal body for Environment Clearance. Further Answering Respondent has no role in granting Environment Clearance in the present case. Hence, the core issues raised in the petition do not fall within the statutory domain of the answering Respondent.
7. In view of the above, the answering Respondent humbly prays that the allegations and reliefs pertaining to the validity, legality, or appraisal of the EC may not be fastened upon answering

Respondent, as it is not the competent authority directly involved in granting the EC. There are no specific prayer or contention against the answering Respondent.






